The case of Lessee of Samuel Smith, Plaintiff in error vs. Robert Trabue's Heirs, by James Trabue, their next friend of 1835 is filed as appellate case number 1713 of the United States Supreme Court records in the National Archives, Washington, D. C. The children are stated to be represented by their father James Trabue, and probably were heirs to the estate of Robert Trabue, apparently their grandfather of Woodford County, Kentucky. Selected paragraphs were copied to include all the names received in the papers from the National Archives. The printed volumes of Cases Adjudged in the Supreme Court of the United States indicate locations and surnames involved in disputes but do not indicate the wealth of genealogical data to be found in the original papers.

As there were many lawsuits over land in Kentucky, these should not be overlooked as a source containing wills, deeds, letters and depositions in the county circuit court; U. S. District Circuit Courts in Kentucky and appellate cases from Kentucky to the U. S. Supreme Court.

Pleas before the Honorable John McCan (?) and John Boyle, Judges of the Seventh Circuit Court of the United States of America, in and for the District of Kentucky, held at the Capitol in the Town of Frankfort at the May term of said Court in the year of our Lord, 1831.

Be it remembered, that heretofore, to wit, on the day of May in the year of 1830, came the Plaintiffs aforesaid by their attorney, and filed the following Petition against the said defendant, Samuel Smith, to

wit --

To the Honorable Judges of the Circuit Court of the United States, 7th Circuit, Kentucky District. Your petitioners James Trabue, Daniel Trabue, Edward Trabue, Juliann Trabue, William Trabue, Robert Trabue, Lavine Trabue, and Charles Trabue, infants of Robert Trabue, under the age of twenty one, by James Trabue, their next friend, respectfully represent, that John Doe on the demise of Samuel Smith instituted (page 6) his action of Ejectment in this Honorable court against Richard Fenn with a notice to Hiram Bryant, William Bryant and others. Your Petitioners respectfully represent that said Bryants were tenants to your petitioners' ancestor Robert Trabue, who appeared and had his tenants entered defendants and a Judgment was rendered against them at the May term 1818. Your petitioners will further state no writ of Habere facias possessionem never issued on the said Judgment aforesaid, that at the November term 1818 a Judgment was rendered against the other tennants and on that Judgment a writ of Habere facias possessionem issued, and the Marshal of the District of Kentucky under said last Judgment and writ, turned out of possession John Evans, who was a tenant of your petitioners resident on the same place occupied by said Bryants when the said suit was brought as aforesaid and Judgment rendered and possessed himself. Your petitioners therefore pray your Honors to award a rule against said Samuel Smith, to show cause why a writ of restitution shall not issue to restore your Petitioners to their possession of said premises.

On motion of the plaintiffs herein by their attorney, a rule is awarded them against the defendant, to show cause on or before the 6th day of the next term, why a writ of restitution should not (page 7) be awarded them to restore the possession of the tenements taken out of the possession of James McGuire, William Acres and John Evans, by the Marshal, upon a writ Of Habere facias possessionem in the name of Doe on dem. Smith vs. Brinegar, &c.

On the back of a copy of the foregoing Rule the Marshal made the following return, towit:

Trabue &c) The defendant moves the Court to quash the Marshal's return herein executed, because the Marshal's return is untrue in point of fact, he having never served the process or rule upon the defendant as he has returned, the defendant being at the time of the issuing of the rule and ever since a citizen of Maryland, residing in the City of Baltimore in said State, and never was in all his life, the more especially since the issuing, within the State of Kentucky.

(Page 9) The Pltfs. in the motion introduced a witness Henry Eastin, who proved that they, the plffs. were the children of James Trabue, dec'd. and then read the following records (Page 10) and Habere facias possessionem (here copy the papers read in evidence) and then called on Hiram Bryant, who deposed that at a time not named by the Witness, but which appeared to be before the service of the declaration in Ejectment, James Trabue, the father of the plaintiffs, called at his father's William Bryant's who then lived upon the land, and as he understood from his father, had settled there under Nathl. Hart - - -

That the said Trabue told his father if he would rent of him he would make it easy, and that his doing so would induce others to rent of him. Said Witness said that his father agreed to do so, and recollects that Trabue said his father paid Trabue as rent a shot gun worth about ten dollars. That after Smith, the defendant in the motion, obtained judgment his father went off and left him the witness on the land, and that he the witness agreed to let Samuel Plummer have the place but that when Plummer came to take possession a man by the name of Rose, who alleged that he had rented or bought of Trabue, took up a Swingle Tree and threatened to knock his brains out unless he left the premises, that Plummer left the land, that when his the witness's father left the premises, he left him in the house he occupied, without anything said as to whose tenant he was, that afterwards he moved off to Missouri and within a few years returned. That he understood that James Trabue sold the tenement occupied by Evans to his brother Jeremiah Bryant and that J. Bryant has rented to said Evans who was occupying the place when the Marshal & Plummer turned Evans out of possession. That Samuel Smith (page 11) lived in the State of Maryland

was known to the Court and not Controverted by the Pliffs. Counsel.

This day came Charles C. Kunnhes (???) and made oath before me, Bennet Clarke a justice of the peace for said Court, that on the 16th day of this instant 1815 he delivered a true copy to the above named gentlemen Jacob Brinegar, William Bryant, Hiram Bryant, Esquire Wilcox, Elijah Wilcox, the tenements in possession a copy of the above declaration and notice and informed them of the purport thereof, and that unless they (page 15) defend the suit they will be turned out of possession.

of December, 1815.

And afterwards towit, at the May term of the Court (page 17) aforesaid in the year 1818 (until which time this Cause was continued)

Came the parties aforesaid by their attos. and thereupon came a Jury, towit, James Parks, Thomas Lewis, Daniel McIlvoy, Tho. Bryan, John Beigler, James Davis, Nathaniel Hart, Thomas Y. Bryant, Daniel Fairley, Andrew McKnight, (page 18) Richard Fox & Nicholas Sneed, who being elected, tried and sworn well and truly to try the issue found, upon their oath do Say, "We of the Jury find the deft. guilty of the trespass in the declaration of Ejectment mentioned and do assess the plaintiff's damage to one cent"

(Page 19) And afterwards towit, on a subsequent day of the term aforesaid, towit, the November term, 1818,

Came the plaintiff by his attorney, and Jacob Brinegar, Esq. Wilcox, and Elijah Wilcox the tenants in possession, and David Hagan by their atto.

(Page 20) Whereupon came a Jury towit, Herman Bowman, Harry Watkyns, Andw. F. Price, Preston Hampton, James W. Waller, Moses Scott, Joseph Craig, John Beagles, William Kindall, John Kinney, Allen May, and Henry Blount, who being elected, tried & sworn well and truly to try the issue joined by counsel of parties the Jury is adjourned over until tomorrow, and the Cause is continued accordingly.

(Page 21) And upon the motion of the defendants, it is ordered that Thomas Campbell, James Kincaid, Jones Hoy, Joseph Brandenburg, Samuel Brandenburg, Samuel Price (later listed as Moses Price) and Lewis Moore be and they are hereby appointed Commissioners, under the occupying claimant law to ascertain the rents and improvements &c and they are hereby ordered to make reports under each law of 1797 and 1812, and make return thereof to the next term of this Court, subject to any exception on the coming in of the report to the right of the defendants to have their improvements valued under the occupying claimant law.

SKETCH OF THE LIFE, EXPERIENCE AND DEATH OF MRS. E. S. AKERS, WHO DEPARTED THIS LIFE ON THE 22D OF MAY, 1821.

Eliza S. Akers, daughter of John and Eleanor Faris, was born in Flemingsburg, Kentucky, on the 27th day of August 1802.

In the fall of 1814, her sister Matilda departed this life, triumphant in the faith. (page 459)

On the 12th day of March 1818, she and I (Peter Akers) were married.

On the 26th of April 1819 she had her first son, John Bryan, who lived only seven weeks and two days.

On the 12th of September, 1820, she had her last son, William Dennis, who is yet living. (page 460)

BOURBON COUNTY MILITIA OFFICERS

BEFORE 1792

This listing of militia officers of Bourbon County is taken from the Executive Papers--Militia series at the Virginia State Library and from an additional list dated 16 April 1788 filed in the regular series of Executive Papers, Box 53.

Frontier conditions necessitated frequent changes in the militia establishment. Many officers acted for a considerable time before the actual issuance of their commissions by the Governor in Richmond. It is likely that further information about recommendations and qualifications of officers can be obtained from the Court Order Books of Bourbon County.

On 18 Sept. 1787 John Edward, Clerk of the Court, wrote that "one half of the militia being so much a frontier ... they cannot Imbody without great Risk to their familys."

In Search of British Ancestry. By Gerald Hamilton-Edwards. Baltimore. 1974. 3rd Edition. 296 pp., illustrated, indexed, cloth. \$15.00.

The genealogist, amateur or professional, who is searching for forbears in the British Isles, should not fail to take along a copy of this book. It is the most comprehensive treatment of the why, how, where and when to look for the who that has come to this reviewer's attention.

The first two chapters offer instructions in learning what has been published about the ancestor and family, what is known by relatives, and how to keep records of one's own research. Difficulties of identification, of locating the county or parish of origin, and of producing other facts may present themselves but every possible aid for clearing such problems is given by the author.

Chapters on civil registration, census reports, parish registers, wills and administrations, marriage licenses, Naval and Army records, the East India Company, record offices and depositories are included among others. There are chapters dealing exclusively with Irish, Welsh and Scottish record offices and depositories.

Chapter 29 contains a brief but very good discussion of searching for genealogical material in the United States, applying the same methods as those used in England.

The library of The Society of Genealogists, the Public Record Office, the British Museum and other libraries are described in detail.

One of the charms of In Search of British Ancestry is the author's delightful style. This is not tedious reading but entertaining and encourages the amateur to become a professional genealogist and the professional to become more enthusiastic about genealogy.

Mention should be made of the excellent bibliography and the attractive drawings.

A consistent acquisition policy of purchase, exchange or gift has secured for the collection the published county, city, town and village histories for all areas of the United States. The catalog lists only the cataloged and separately bound monographs and serials in the Research Libraries' United States local history classification scheme.

This catalog differs from the local history shelf list of the Local History and Genealogy Division in that the titles here are listed alphabetically by state with an alphabetical arrangement by locality within each state. This list, therefore, is not in the strict shelf list sequence of regional groupings of states.

Some 23,400 cards are contained in this catalog. The two volumes are bound in Class A library binding.

Page 36. July Court 1791. Ordered that Captain Hart's Company of Militia be divided by a line to run from the mouth of Bossman's Creek, thence to the Head thereof, thence along the Hickman Road to Captain Hart's branch, thence up the right hand fork thereof to the Head, thence a direct Course to the County line.

Jesse Richardson to be Recommended to his Excellency the Governor of Virginia as a Proper person to be appointed Captain of the Militia in the bounds in which Daniel Owsley lives, Harvey Ross Lieutenant and Edward Shackelford Ensign.

William Stone is appointed Overseer of the road from James Farris's to William Neel's in the Room of John Hall. It is Ordered that he with the Tithes allotted for that purpose do clear and keep the same in repair according to law.

For reasons appearing to the Court It is Ordered that the road leading from Baylor's Mill to Gilbert's Creek be established, agreeable to a Report thereon formerly returned, the persons thro whose Land the road doth pass failing to appear.

BLANFORD, FRANCIS * CATHARINE: WC 2086; BLwts. 28358-80-50 and 24857-80-55. Private in Captain Higdon's Company, Kentucky Militia. Enlisted November 10, 1814; discharged May 10, 1815. Residence of soldier 1851: Daviess County, Kentucky; residence of widow 1855: Daviess County, Kentucky; residence of widow 1871: Daviess County, Kentucky (P.O. Owensboro). Maiden name: Catharine Wathen. Marriage date: May 22, 1812, Fairfield, Nelson County, Kentucky. Death of soldier: July 16, 1852, Daviess County, Kentucky.

Application for pension made April 29, 1871, by Mrs. Catharine Blanford, aged 79, a resident of Daviess County, Kentucky, who, being first sworn, declared that she was the widow of Francis Blanford who served in War of 1812 enlisting as substitute for Tichenor in Capt. Leonard Higdon's Company, Kentucky Volunteers, at Bardstown, Kentucky, in 1814 and was honorably discharged in 1815, and that said husband was at the Battle of New Orleans; that she was married to said Francis Blanford on 22 May 1812 by Priest Baden near Fairfield, Nelson County, Kentucky; that her husband died at Daviess County, Kentucky, and she has not since remarried.

Report from Bounty Land Division states that Francis Blanford served in Capt. Higdon's Company from 10 Nov, 1814 to 10 May 1815. Service 182 days.

Marriage before Feb. 17, 1815, established by certified copy of Public Record. W.A. Blanford and Benedict Long testify to continued widowhood.

BLANFORD, GEORGE - HARRIET: WC 34683; BLwts: 20365-80-50. Private in Capt. Jacob Peacock's Company, Kentucky Militia. Enlisted 11/10/1814; discharged 5/10/1815. Residence of soldier 1850: Perry County, Missouri; residence of widow 1886: Lithium, Perry County, Missouri. Maiden name: Harriet McDonald. Marriage: January 20, 1817, Shepherdsville, Bullitt County, Kentucky. Death of soldier: April 24, 1854, Perry County Missouri. Death of widow: About 1891. Discharge certificate, promissory note and due bill signed by soldier in brief.

WIDOW'S BRIEF: Application filed December 11, 1886., Perry County, Missouri. Service alleged in Capt. Peacock's Company, Kentucky Militia, War of 1812. Third Auditor reports January 12, 1887 that the name of George Blanford is on the Company Rolls of Capt. Jacob Peacock from 11/10/1814 to 5/10/1815 and that the signature of Captain Peacock on discharge in bounty land case is identical with that on his Company Roll. Length of service: six months. Proof of identity: Identifying witnesses; claimant states correct service; residence and age the same as stated by soldier; signature identical with soldier's in bounty land claim. James McGlasson testifies that soldier showed him his land warrant about the year 1852.

Admitted April 15, 1889 at \$8.00 per month from March 9, 1878, the date of the Act and at \$12 from March 19, 1886.

Marriage date January 20, 1817, of George Blanford and Harriet McDonald shown by claimant's averment; alleges she has made the effort but is unable to furnish the record evidence. James Peacock testifies that he has been acquainted with the claimant and soldier since 1843 and knew they lived together as man and wife until the soldier's death April 24, 1854 and that claimant has not remarried. James M. McGlasson also testified to marriage. Claimant alleges that there was no legal barrier to marriage. Presumed that such is the fact, as claimant was but 18 and the soldier 22 at the time of their marriage.

29 Nov. 1886 Harriet Blanford, aged 87, resident of Lithium, Perry County, Missouri, being duly sworn, declares that George Blanford volunteered at Shepherdsville, Kentucky, in the War of 1812, and that they were married by Father Chaborow 20 January 1817 at Shepherdsville; husband died in Perry County 24 April 1854. Two promissory notes submitted to prove that she was married to soldier, as his estate paid these notes after his death - one for \$8.15, one for \$16.20. Widow dropped from Rolls 16 Dec. 1891 because of death.

He declares that he is married ; that his wife's name was Mary Ann Martin to whom he was married at Jefferson County, Kentucky, on 16th December 1841; that he served the full period of 60 days in the Military Service of the United States; that he is the identical John H. Blankenbaker who volunteered in the company of Captain Samuel Kelley, Colonel Callaway, at Middletown, Jefferson County, Kentucky, 20 August 1813 and honorably discharged at Maysville, Kentucky, on 5 November 1813; that he was present at the Battle of the Thames but was held in reserve; that he has received a Land warrant and refers to evidence therein filed; that he does not know where his discharge is. At the time of this statement he was seventy-five years old and resided twelve miles from Louisville in Jefferson County, Kentucky.

BLEDSON, MOSES O. - SOPHIA C.: WO 34274. Private in Capt. Thomas Kennedy's Company, Kentucky Militia.

State of Illinois, City of Chicago: Affiants Henrietta E. Owsley and Isaac R. Diller state that they are citizens of the city of Chicago, State of Illinois, that their ages are 44 years and 58 years; that they are personally acquainted with Sophia C. Bledsoe, widow of Moses Bledsoe, and that she has remained a widow continuously since the death of her said husband; that said Moses Bledsoe died the 17 day of November 1851 at Springfield, Sandamon County, Illinois,

6 December 1878. Sophia C. Bledsoe, aged 86, a resident of Chicago, Cook County, Illinois, being duly sworn, states that she was married to Moses O. Bledsoe on 4 January 1809 at Frankfort, Kentucky, that husband died at Springfield, Illinois, 17 November 1851.

License date 4 January 1809 states that marriage is shortly intended between Moses O. Bledsoe and Sophia Taylor, both of County of Franklin. Signed by Moses O. Bledsoe and John Glover. Teste: Willis W. Lee. Copy of marriage bond certified by James G. Crocket, County Court Clerk, with additional statement that the list of marriage certificates in his office was very incomplete.

Claimant died before the claim was completed.

BLESSETT (BLISSIT), GEORGE A. (J.) - MARGARET: WC 7391. Private in Capt. Aaron Hart's Company, Kentucky Militia.

Claim under Act of 1871 rejected February 27, 1873 by cause of insufficient service. 14 November 1872 residence of widow Hardin County, Kentucky; PO Big Spring, Breckinridge, Kentucky. Enlisted and discharged at Elizabethtown, Kentucky.

Enlisted September 18, 1812; discharged October 30, 1812; received Bounty Land warrants 37099-40-50 and 75480-120-55. Residence of soldier 1850: Hart County, Kentucky; 1855 Breckinridge County, Kentucky. Maiden name of widow: Peggy (Margaret) Miller. Marriage: April 2, 1812, Grayson County, Kentucky. Death of soldier July 9, 1862, 1862. Death of widow: about 1884. Length of service of soldier: 51 days - 8 days travel allowed. Admitted July 13, 1878.

20 December 1850 George Blissit, resident of Hart County, Kentucky, aged 65, being duly sworn, stated that September 1, 1812 in Hardin County, Kentucky, he volunteered for 3 months and was discharged at Vincennes, Indiana 1812, as will appear by the muster rolls of his said company, but when he was discharged his officer gave him an incorrect discharge - one made out for another man and for a different tour of service, which mistake affiant did not observe until he arrived at his home. John Smith's company of infantry belonging to the 13th regiment, Kentucky detached militia. It was signed by John Webb, Lt. Col., at Brandenburg, Kentucky, 15 May 1815.]

Residence of soldier: 1851-1855: Lewis County, Kentucky. Residence of widow: 1879: Three Prong, Greenup County (P.O. Boone Furnace, Lewis County) Kentucky. Soldier's first wife: Catharine Dummit; maiden name of widow: Elizabeth Zornes. Marriage: August 1, 1851, Greenup County, Kentucky. Death of soldier: September 27, 1868, Lewis County, Kentucky.

Application filed by widow May 29, 1878; duplicate filed April 1879. Third Auditor reports on May 2, 1854 reports the service of Henry Bloomfield in Capt. Benedict Bacon's Company, Kentucky Militia from 11/10/1814 to 3/10/1815. January 13, 1852 Auditor reports service from September 10, 1814 to April 9, 1815. Length of service 161 days before treaty of peace. Identity proved by testimony of James Morton and Jesse Fitzpatrick. Marriage: August 1, 1851 as shown by certified copy of a County record and allegation of the claimant. Abraham Logan and I. Stone testify that former consorts died two years prior to this marriage. Death of soldier April 27, 1868 as alleged by claimant and testified to by I. Stone and Marshal Baker.

As to the discrepancy in claimant's name widow states

she is unable to read and write and her husband's speech was so defective that he could not pronounce his own name so as to be understood and she is uncertain whether it is Bloomfield or Nrumfield.

9 April 1879 Greenup County, Kentucky, Elizabeth Brumfield, aged 68, a resident of Three Prong, after being sworn, declares that she is the widow of Henry Brumfield who served in Capt. Benedict Bacon's Company, that her husband was drafted at Old Town, Greenup County, in 1814 for term of more than 14 days and discharged 1814 or 1815. At time of enlistment he was 25 or 26 years of age, a farmer, born in New Jersey, about 5-8/12 ft. high, heavy built, dark hair, gray eyes; further states she was married to him at her own residence in Greenup County, Kentucky, on 1 August 1851 by one Barnabas Kiner, a minister of the Gospel and her maiden name was Elizabeth Zornes, and she has not remarried since his death. She further states that he was before married to Catharine Dumnit now dead, and that he died in Lewis County, Kentucky on 27 September 1868 and they always lived in Greenup County.

Marshal Baker corroborates widow's statement concerning the speech defect of her husband. Iroby Stone declares that soldier's first wife died in 1852 and that Eastham Zonn [Zorn] died about 1849 - widow's first husband.

Soldier applied for Bounty Land in 1855 under name of Bloomfield.

BLYTHE, JAMES: SC 19573; BLwts. 43650-40-50 and 51619-120-55. Sergeant in Capt. J. C. McWilliam's Company, Kentucky Militia. Enlisted 8/25/813; discharged 11/6/1813. Residence of soldier: 1850-1855 Madison County, Kentucky; 1872: Silver Creek, Madison (P.O. Richmond) Kentucky. Maiden name of wife Jane White. Marriage, death of soldier, death of widow - dates not given.

Declaration for pension filed August 12, 1872. Auditor's report: Length of service 70 days.

Loyalty testified to by Samuel Barnett and P. P. Ballard. Admitted 11/4/1872 from 2/4/1871.

8 August 1872 James Blythe, 78 years old, a resident of Madison County, Kentucky, being first sworn, declares that he is a widower and his wife's name was Jane White but she is now dead; that he served full sixty days in Capt. McWilliam's Company as sergeant. He was at Buford's Island, one of the guards who guarded prisoners taken by Perry in the victory on Lake Erie.
