Two distant genealogical publications have recently come to the Editor's desk: <u>The Lifeliner</u> and The Roadrunner.

The Lifeliner, published by the Genealogical Society of Riverside, P.O. Box 2557, Riverside, California, is in its tenth year, an interesting, wellestablished magazine, and readers of <u>The Kentucky</u> <u>Genealogist</u> may find it helpful in tracing their ancestors from the eastern seaboard to California.

The Roadrunner, the quarterly of the Chaparral Genealogical Society, P.O. Box 606, Tomball, Texas, 77375, appeared for the first time in the fall of 1974. Its editor and staff display experience in genealogical work and excellent judgment in the presentation of source records. The quarterly contains cemetery and church records, index to probate minutes of Waller County, Grimes County index to deeds, marriages in Montgomery County, Brazos County early births, queries and a surname index.

Manuscripts and copies of private or public records must cite ownership and/or depository of the original documents. Unless accompanied by sufficient postage contributions cannot be acknowledged nor returned.

IN 1873-1884

Old newspapers are valuable sources of genealogical and historical data. Unfortunately, they are scarce or non-existent in many cases. The Banner was published every Thursday at Princeton, Kentucky for about 30 years, but only scattered, miscellaneous copies can be found in libraries and private collections. The following deaths were compiled from a privately owned collection. The first date given is the date of the newspaper.

Sept. 4, 1873. Jacob Sigler, 89, died August 31, 1873, at the home of Dan Sigler in Caldwell Co. He was born in Loudon Co., Virginia on Dec. 4, 1783, was a soldier in the War of 1812, and came to Caldwell Co. in 1817.

Feb. 11, 1875. Mrs. Agnes L. McGoodwin, 28, wife of E. P. McGoodwin, died of consumption at her home in Princeton on Feb. 5, 1875.

Sept. 12, 1878. Mrs. Minerva Pickering, 65, died at her home in Caldwell Co. on Sept. 4, 1878, after a long illness. She was a native of Caldwell Co. and the wife of Thomas W. Pickering.

Jan. 2, 1879. Miss Polly Asher, a sister of Squire Jeff Asher, died on Dec. 27; she was an invalid all her life.

June 5, 1879. James Pemberton Scott, 9 month old son of Joseph and Amanda Scott, died at the family home near Scottsburg on June 2, 1879.

Sept. 4, 1879. John P. Gracey, depot agent at Princeton since 1872, shot and killed himself Sunday, leaving a wife and son.

Sept. 4, 1879. Mrs. John B. Downing died last Friday.

Sept. 4, 1879. James H. Hayes died at his home near Friendship of consumption on the 22nd of August 1879. He was born June 15, 1828 and lived in Christian Co. before settling in Caldwell Co. in 1857. He married Miss Elizabeth Mitchell in 1855.

Sept. 4, 1879. Frank McConnell, 10 year old son of Rufus McConnell of Donaldson, was shot and killed by David Cantrell, age 16, an orphan.

June 28, 1883. Thomas Saunders, an old and respected citizen of this county, died the 15th inst.

June 28, 1883. Mrs. Thomas Hunter, an invalid for several years, died on Monday evening last.

June 28, 1883. Eb. Morse died at his residence near Farmersville in this county on last Friday, the 22d in the 70th year of his age. He came to this county 64 years ago from South Carolina with his father's family.

Sept. 6, 1883. James Blanton Sasseen died Sunday night at his home in Princeton. He was born Mar. 15, 1807, in Garrard Co., Ky., came to Caldwell Co. in 1812 with his father Lewis Sasseen, married Miss Elizabeth Bright on Sept. 13, 1832, who survived him. He was in the tombstone business at Princeton.

Sept. 13, 1883. John A. Satterfield died of typhoic fever last Monday at his home in Caldwell Co.

Jan. 17, 1884. Dr. Timothy Brown Pool died in Princeton on Dec. 17, 1883, in the 82d year of his life. He was born in Rowan Co., North Carolina and moved to Christian Co., Ky. with his father Henry Pool in 1806. Dr. Pool married Miss Mary Brown and had a family of 4 boys and 4 girls. They moved to Caldwell Co. in 1853.

Volume 6, MARCH 1, 1848-FEBRUARY 1, 1849.

Volume 6, No. 1, March 1, 1848, page 24: The last words of the beloved Elizabeth Rose.... Her husband, Mr. John Rose, fought in the Revolution, and is gone. Her sons braved the dangers of battle in the western wilds, and some of them are gone; her children and grandchildren...

Last spring she started to Illinois to see her only living brother--(not named)...she returned to lay her bones in the "Old Church Yard" on Floyd's Fork, Ky. Where she sleeps by her husband, since the 22d of September...77 winters (of age)...

She was the grandmother of my wife... A(LLEN) KENDRICK. Jeffersontown, Ky., Nov. 5th, 1847.

Volume 6, No. 2, April 1, 1848, pages 47-48: Died- in Platte county, Missouri, November 2, A.D. 1847, brother Dudley Tribble, in the 29th year of his age... Brother Tribble was a member of the Christian church at Platt Union in this county, and a grand-son of elder Andrew Tribble, formerly of Kentucky.

Sarah Womach...lay sick at her uncle Joseph Bryant's, near Lexington, Ky., about ten weeks. Her parents were with her nearly all the time, and when her gentle spirit took its celestial flight, they brought her pale form to Middletown, some sixty miles..that she might sleep by her lamented brother in that beautiful grove which shades the family burying ground. (Date not stated.) She had lived a kind and dutiful child, with her parents, near twenty-three years, and a faithful member of the church eight or nine years...

S. B. (steamboat) Cincinnati, Dec. 5th, 1847. A(LLEN) KENDRICK.

Volume 6, No. 3, May 1, 1848, page 72: Died - In Graves County, Kentucky, Jan. 3d, 1848, at the residence of her Father, William Sisson, Miss Angelina Sission, in the 44th year of her age. Her parents, sisters, and brother, kindred and friends were the objects of her affectionate regard.

Volume 6, No. 7, September 1, 1848, page 168:

Died on the 28th of Nov. 1847, at the residence of her father, Mr. John Brame, Senr., near Garritsburg, Christian co., Kentucky, and Noah's Springs, Montgomery co., Tenn., Mrs. Agnes Anderson, consort of Mr. Peter Anderson, after a long and painful illness, leaving two young children, and an extensive circle of relations and friends to morn her loss.

The deceased was born in Mecklenburg county, Virginia, from which her father emigrated to Kentucky, some twelve or fifteen years since. She was about 29 years old when she died, and had for some years preceding her death, been an exemplary member of the Baptist church, at Olivet, Christian county, Ky.

Volume 6, No. 8, OCTOBER 1, 1848, page 192:

DIED, at his father's, near Oak Grove, Christian county, Ky., on the 31st day of March last, James Preston Hopkins, son, and only child, of brother Samuel D. and sister Mary L. Hopkins, aged 3 years, 2 months, and 28 days.

Volume 6, No. 10, DECEMBER 1, 1848, page 240: DIED-At the residence of his brother, in Trigg co., Ky., on the 2nd of August last, (1848) Dr. Philip Clayton Slaughter, of New Concord, Callaway co., Ky., aged 23 years and 3 months. He has left an affectionate wife and one child, and a large circle of relations and connections to mourn his untimely decease. Being a near connexion of the writer, he was well known to him ... He obeyed The Gospel a few years since, at Cadiz, Ky., under the preaching of bro. Henry T. Anderson, being a resident there at the time, engaged in the study of

medicine, under bro. Dr. Burnett. J. R. H. (JOHN R. HOWARD)

Volume 6, No. 11, JANUARY 1, 1849, page 284: James Martin, of Marshall county, Ky., departed this life, March 5th, 1848, in the 63d year of his age... He and his worthy consort were immersed by brother Benj. Lynn, some thirty-three years since, in Madison county, Ala., and some sixteen years after removed to Kentucky where he remained until his death.

S. B. A. (S. B. ADEN)

Sister Tucker is no more. The day we left Louisville, Nov. 29th... desired I should preach at her burial. (Left husband)

A(LLEN) KENDRICK S.B. (steamboat) Mustang, Dec. 2, 1848.

Volume 7, JUNE 1, 1849-MAY 1, 1850 Joseph S. Patton, John R. Howard, editors, Saint Louis, Missouri.

Volume 7, No. 1, JUNE , 1849, page 23:

In the "Observer and Reporter" published in Lexington, Ky., I see announced the death of sister "Rebecca I. Shelby, wife of Mr. Richard Shelby, of Missouri. She died on Tuesday the 13th of March; 1849, at Richland, the residence of Mr. Isaac Shelby."... her children weep over the grave of a fond and doating mother...

It was her good fortune to have been educated by that excellent man, Eld. P. S. Fall, near Frankfort, Ky... April 9th, 1849. T. M. ALLEN

Volume 7, No. 3, AUGUST 1849, page 72: Brunswick, Mo. July 16, 1849.

Bro. Patton:-

Brother Josiah Bounds, of this place, formerly of Bourbon co., Ky., departed this life on the 15th inst. E. E. RUSSELL

The Harbinger and our other papers will please copy.

Volume 7, No. 10, MARCH, 1850, page 240:

Elder John M. Barnes, was born in the town of Beaufort, South Carolina, on the 27th of August, 1805.

In December 1848, he removed to this place, and took the pastoral charge of the Christian church. In January following he commenced the first session of the South Kentucky Institute. ...2 o'clock, Monday, 4th inst. when he breathed his last; surrounded by an affectionate family...interred with Masonic ceremonies... Hopkinsville, Ky. Feb: 14, 1850.

Volume 7, No. 12, MAY, 1850, page 286: Gnoll, Ky., May 10, 1850. Bro. Patton:- It is with painful regret that I inform

Bro. Patton:- It is with painful regret that I inform you of the death of our beloved brother, E. G. Herndon, who departed this life last December... His family and congregation of which he was Elder have sustained an irreparable loss.

Page 60. Philip McGovern and Lewis Neill v. James Boyle. Case considered and Court ruled that Boyle was to pay McGovern \$249.00 the amount of the said judgment mentioned in bill of complaint, with lawful interest, and that complainant may "sue out the execution therefore" for goods and chattels of every description, as may be in hands of said defendant of the said Patrick Boyle, deceased, to be sold. Court further orders defendant to pay to Lewis Neill \$702.92, the amount of the note or final bill filed, as a part of the suit.

Page 61-62. Commonwealth v. John Smith, Ansel Hyde, Joseph Carnes and Abraham Hiley. Indictment for Riot. Plea of Not Guilty was entered. Jury summoned included Samuel Jolly, Samuel Stuckey, John Frank, Jr., Frederick Fraise, Henry Faith, James Smith, John Reaney, Terrance Connor, Thos. G. Alvey, Thos. Kinchloe, Richard Avit, and William Tindal. Jury ruled that John Smith and Ansel Hyde were guilty as charged, and Court fined them 10 shillings each. Jury ruled that Joseph Carnes and Abraham Hiley were not guilty, and they were to recover their costs against William Hardin, Jr.

Page 62-63. John Frank, Jr. v. William Hardin, Sr. On motion for new trial, objected to by attorney for defendant, a new trial was granted.

Page 63. Jacob Yocum v. Thos. Kincheloe. "Plaintiff came not," suit was non-suited, and plaintiff was ordered to pay to defendant his costs and 150 pounds of tobacco. Court adjourned.

Page 64. November 24, 1803. Samuel Connor by Terrance Connor, his next friend v. Daniel Barnes, Michael Miller, John Miller, and John Cofman. On case of trespass and assault and battery, judgment set aside; defendants pleaded not guilty, that plaintiff made first assault on them. Jury summoned included Daniel Hardin, Thos. G. Alvey, William Hardin, Jr., William Tindal, Friend McMahon, Archibald Pitt, John Frank, Jr., Benjamin Huff, John Walker, Thos. Wheeler, Henry Faith, and Aaron Rawlings.

Page 65. Court ruled that defendants were guilty, and assessed the plaintiff's damages at \$20.00.

Page 65. William Hardin, Sr. v. Samuel Stuckey. Case of Trespass. Suit dismissed, defendant to pay costs.

Page 66. November 24, 1803. James Sands v. Jacob Yocum. Continuance.

Page 66-68. George Hughs v. Archibald Pitt. Case of Trespass and Assault & Battery. Defendant says that on the day and place the declarations mentions, the plaintiff, with force and arms, entered the dwelling house of him, the said defendant, and there and then menaced, threatened and abused the wife of the defendant. Defendant says that "in defense of his said house and wife did then and there gently lay his hands on said plaintiff and put him out of the house of the said defendant and the defendant therefore saith that if any damage there and then happened it was in the defense of defendants house and family and not otherwise." Jury was summoned, to include Thomas Brown, Samuel Hamilton, Anthony Syms, Richard Avit, Barney Miller, James Smith, Torrance Connor, Samuel Stuckey, Michael Miller, William Walker, Joel Tullis, and Aaron Rollings. Jury found defendant guilty, and assessed damages at 1¢ and costs. Court adjourned.

Page. 69. November 25, 1803. On the motion of Daniel Hardin by his attorney asking Court to redocket the appeal of Daniel Hardin, against Daniel Wheeler which was dismissed at October term last.

Page 69-70. John Connor v. Barney Miller. Trespass and

Assault & Battery. Judgment vacated in clerks office, and defendant pleaded not guilty. Jury included Henry Faith, Thomas G. Alvey, James Smith, John Cofman, William Tindal, Thos. Kincheloe, William Hardin, Jr., Joel Tullis, John Reaney, William Hardin, Sr., Nelson Jolly, and James Duncan. Defendant found guilty, assessed damages at \$1.50 and costs.

Page 71. Benjamin Helm, assignee of Daniel Waid who was assignee of James Johnston v. James Ferry. On debt. Thomas Kincheloe appears for debtor as security. (Appearance bond)

Page 71. John Cofman v. Thos. G. Alvey, Samuel Connor, Henry Faith, and John Bates. Judgment vacated in clerks office, jury trial ordered for next Court.

Page 72. John Connor v. Christian Miller. Case of Trespass with arms. Jury included Joseph Carnes, Anthony Syms, Wm. Walker, Richard Avit, John Frank, Sr., Frederick Fraise, Friend McMahon, James Smith, Thos. G. Alvey, John Walker, Henry Faith, and Elisha Edwards. Jury found for plaintiff, and assessed damages at 1¢ and costs.

Page 73. Ansel Hyde v. Daniel Barnes. Judgment set aside in clerk's office, and new trial ordered. Jury included Joseph Carnes, Anthony Syms, William Walker, Richard Avit, Joel Tullis, Frederick Fraise, Friend McMahon, James Smith, Thos. G. Alvey, John Walker, Henry Faith and Elisha Edwards. Plaintiff did not appear, suit was non-suited, and plaintiff was ordered to pay defendant costs and 150 pounds of tobacco.

Page 74. Ansel Hyde v. Richard Avit. Judgment set aside in clerk's office and new trial ordered, with jury consisting of Joseph Carnes, Anthony Syms, William Walker, Frederick Fraise, James Smith, Thos. G. Alvey, John Walker, Henry Faith, John Cofman, Joel Tullis, Nelson Jolly, and James Duncan. Plaintiff did not appear, suit was nonsuited, and plaintiff ordered to pay defendant costs and 150 pounds of tobacco.

Page 75. Jacob Yocum v. William Walker. Case continued at plaintiff's costs. Defendant to recover his costs in continuance.

Page 75-76. John Connor v. Daniel Ferry. Clerks office judgment set aside, and new trial ordered. Case of slander. Defendant says words spoken were true and he could "so speak well and lawfully."

Page 77. Anthony Syms v. John Shepherd. Judgment in clerks office set aside, new trial ordered, and jury consisted of Jo Carnes, Torrance Connor, William Walker, Frederick Fraise, James Smith, Thos. G. Alvey, John Walker, Henry Faith, John Cofman, Joel Tullis, Nelson Jolly, and James Duncan. Defendant found guilty, assessed damages at \$65.00 and costs. Court adjourned.

Page 78. November 26, 1803. Christian Bringle v. Jacob Yocum. Appeared for jury trial, jury consisting of Joseph Carnes, John Reaney, Ansel Hyde, Barney Miller, Joseph Huston, Samuel Craig, John Brothers, Thomas Piety, Joel Tullis, Philip Taber, John Walker and James Duncan. Jury found for plaintiff, damages assessed at 32 pounds, 7 shillings, 9 pence and costs.

Page 79. Joseph Mason v. William Kelso and William Hardin, Sr. Suit on debt. Judgment in clerks office set aside. Defendants claim they do not owe debt. Jury trial was ordered for next term of Court.

Page 79-80. Joseph Huston, assignee, v. John Brothers and Thomas Wheeler. Suit on debt. Vacate the judgment in clerks office. Defendants say "they have fully and truly kept the prison bounds mentioned in the condition of the said writing obligatory and....in all things done and performed the condition of the said bond."

Page 81. Benjamin Helm, assignee, v. James Ferry. Suit of debt. Judgment in clerk's office vacated, and case taken under advisement.

Page 81. Plaintiff refused to reply until next Court. [Editor's note: This item should precede "Benjamin Helm..."

Page 82. Joseph Carnes and wife.v. William Hardin, Jr. Case dismissed, mutual consent. Plaintiff to recover costs against defendant.

Page 82. William Hardin, Jr. v. Jo Carnes. Case dismissed, mutual consent. Plaintiff to pay defendant costs.

Page 82-83. Jonathan Humphrey v. William Tindal. Clerks office judgment vacated and case deferred to next Court.

Page 83. James Ferry v. Jacob Yocum. Continuance.

Page 83-85. Ordered that all cases remaining on the docket of this Court undetermined be continued until the next Court here. Ordered that the following allowances

be certified to the auditor of Publick Accounts towit: To Joseph Allen, Clerk of the Court, for his ex-officio services for one year past, Thirty Dollars. Fifteen years of diligent research by Kathryn Owen has resulted in an excellent genealogical record for Clark County's pioneers and their descendants. Kentucky maintained a central registration of births and deaths only from 1852 to 1862 and from 1911 to the present, so that during many years of the State's history tombstone inscriptions were the only public source of vital statistics.

Approximately 275 early cemeteries were visited in gathering these inscriptions. The names of settlers and their families from the eighteenth century to recent years, Revolutionary soldiers and other prominent figures of the country's history are listed - 2,500 of them.

<u>Old Graveyards of Clark County, Kentucky</u> is the contribution of Miss Owen to the State's bi-centennial celebration. But it will long be an important addition to the reference literature of early Kentucky. Information is given as to dates of birth and death, relationships, the war service of the deceased and notes concerning graveyards and tombstone inscriptions are added.

In her Preface Miss Owen calls attention to the fact that the Kentucky Legislature has enacted laws to prohibit the destruction of cemeteries large and small. She also expresses appreciation of the generous cooperation of many persons interested in the completion of her book.

History of Woodford County, Kentucky. By William E. Railey. (1938) Reprinted Baltimore 1975. 449 pp. Illustrated. Indexed. \$17.50.

Genealogists will welcome this reprint of William E. Railey's <u>History of Woodford County, Kentucky</u>, originally published in 1938, as it contains hundreds upon hundreds of family sketches, marriage records of Woodford County 1789-1799, soldiers from Woodford County in the War of 1812 and the census of 1810. In these few lists more than 5,000 early Woodford County residents are named. In the family sketches data on the Kentucky immigrant, such as the state or country of his origin, names of his wife and children, are contained.

The account of the settlement, governments and wars in which Woodford's citizens participated is interesting. The fact is emphasized that while the great portion of the settlers migrated from Virginia, many came from Maryland, North Carolina and Pennsylvania, and small groups from other states. The book is recommended to all readers but especially to genealogists because it is a storehouse of vital statistics.

The reviewer cannot resist quoting one item found in the Supplement of the Woodford County history (page 421): "Circuit Judge William B. Ardery, Paris, whose district includes Woodford County, has his troubles. He admitted that while addressing the Woodford County grand jury this week [1937] at Versailles: 'It is a difficult matter to charge a grand jury in a county like Woodford,' he declared, 'where there is almost no crime to talk about. The county jail is empty and only two cases were referred to the grand jury, by the lower courts.'"...

Oldham County Records, Volume 1: Cemeteries. Co-Editors Edna Scott McKechnie and Willada Hickman Dent. With photographs by Martha Lee Klein and Theodore E. Klein. n.p. 1974. \$15.00.

The Oldham County Historical Society is to be congratulated on its project to publish important genealogical data for the benefit of all those whose ancestors were among the early settlers of that area. <u>Oldham County Records, Volume 1: Cemeteries</u> is the first of a series of planned publications. Future volumes will contain abstracts of Will Books, 1, 2, 3 and 4, the Census records of 1830, 1840 and 1850, and abstracts of Court Order Book 1.

In 1962 some 73 adults and children copied nearly three thousand tombstone inscriptions found in cemeteries in Oldham County. In 1973 approximately three thousand five hundred more inscriptions were copied. At this time many excellent photographs were made of the stones. All known family, church and public cemeteries were recorded before completion of the work. Mrs. McKechnie and Mrs. Dent then compiled and edited the mass of material with meticulous care so that few errors, if any, will be found. Their work entailed the notation of births and deaths, relationships of those buried, whether a doctor, minister, or member of the Masonic Lodge.

The cemeteries are numbered for easy reference in using

the index which was prepared by Mrs. McKechnie. The locations of the cemeteries are indicated by numbers on a road map printed by the State Highway Department.

A fascinating section of tombstone photographs by Mr. and Mrs. Klein follows the sketches of two family graveyards.

History of Fentress County, Tennessee. By Albert R. Hogue. (1916, 1920). Reprint. Baltimore. 1975. xxxii, 165 pp. Illustrated. Indexed. \$10.00.

In 1916 Albert R. Hogue stated that the purpose of his history of Fentress County was to relate the part their county had played in State and national affairs, and to inspire a higher order of citizenship by citing their past endeavors in historic events. In 1920 the World War Memorial Edition was published, containing thirty additional pages of data proving that the citizens of Fentress County continued to respond to the call of the nation and meet its needs for the services of men and women and for money. Short sketches of those serving in World War I, including Alvin Cullom York, appear.

In the original history the county's location, scenery, invigorating air and health-giving waters are described. Jamestown, the county seat, is situated on the Cumberland Plateau. It was at one time called Sand Springs, possibly because of the several fine springs of water that bubble up from the sand. Later it bacame Obedstown of the "Gilded Age" by Mark Twain. Fentress County is the old home of Mark Twain's ancestors. His father, John M. Clemons moved from Jamestown a few months before Mark Twain was born.

While some general history is related, the book is chiefly a collection of personal and family sketches. References to marriage, occupation, place of residence of some three hundred and fifty persons will aid the genealogical researcher. An index provides the names contained in the sketches.

Va.; Hiram W. Grove's Store Ledger containing hundreds of names from Frederick and Berkeley counties, Virginia; a Genealogy of Berkeley County, Va. [W.Va.] from about 1634 through its changes to 1820.

Tennessee Soldiers in the Revolution. By Penelope Johnson Allen. (1935) Reprinted Baltimore, 1975. 71 pp. \$5.00.

The reprint of this book is especially welcome at this time when so much interest is being shown in the Revolutionary period. The title implies that it is only a roster of the soldiers of the Revolution. Although there is a significant list of such soldiers taken from the Revolutionary Army Accounts of North Carolina for service by men from the western-most counties of Washington and Sullivan, later Tenneesee, there are also sections devoted to wills of Washington County, marriages of Blount and Davidson counties, and Revolutionary grants in Davidson County.

More than 1500 soldiers residing in Washington and Sullivan counties, 1781-1783, are named. The wills are chiefly of the period 1780-1820, the marriages of the period 1790-1802. All pertinent names and dates are given in the several groups, totaling in excess of 2,000 persons.

<u>Twenty-four Hundred Tennessee Pensioners: Revolution</u> <u>[and] War of 1812.</u> By Zella Armstrong. (1937) Reprinted Baltimore, 1975. 121 pp. \$6.50.

After the Revolutionary War thousands of veterans moved into Tennessee when it was erected as a state and hundreds of them were granted pensions. In this list eleven of the original thirteen states are represented. The pensioners of the War of 1812, however, are almost without exception Tennesseans.

In her Foreword Miss Armstrong explains that information for the roll of Tennessee Pensioners was compiled and collated from the published Government lists commonly called the list of 1816, the list of 1818, the list of 1828, the list of 1832, the Census of 1840, and also the list of heirs of non-commissioned officers killed in service, the manuscript record of the Knoxville Agency, Blount County records. Zella Armstrong rendered an excellent genealogical service in publishing all these data in one book.
