LEWIS COUNTY FAMILIES

This information was gathered from old lawsuits filed in the Lewis Circuit Court, Vanceburg, Kentucky. It was compiled and contributed by Dr. William M. Talley, of Vanceburg, Kentucky, and Montreal, Quebec.

The city of Vanceburg, Kentucky, was laid out by Moses Baird and Joseph Calvin Vance, on a tract of land that was originally patented to Alexander Keith Marshall. At the time of its incorporation and plat, the town was in the county of Mason. The date of the town's establishment was 1797.

According to File 353, Joseph C. Vance heirs vs. John G. McDowell, Oct., 1814, the following persons were the heirs of Joseph C. Vance, when he died in Ohio: (1) John Vance, (2) David Vance, (3) Joseph Vance, (4) Jane, the wife of John Taylor, (5) Samuel Vance, (6) William Vance, (7) Moses Baird Vance, and (8) Bridgett Vance.

One of the earliest residents of Vanceburg, Kentucky, was Thomas Shain (or Shane). According to File 1913, G. W. Parker vs. the heirs of Thomas Shain, dec., Feb. 1835, Thomas Shain died intestate, leaving The Following heirs (in Greenup and Lewis counties and some outside the State of Kentucky): (1) Nancy Shain, his widow, (2) David Shain, (2) Alexander Shain, (3) Thomas Shain, (4) Priscilla, the wife of John Liles, (5) Levi Shain, (6) Elizabeth Shain, (7) William Shain, (8) Mary Shain, (9) Jacob Anderson and Lucinda Gammon, children of Mary Shain Anderson, late Mary Gammon, (10) James Mills, son of Esther Mills, late Esther Shain, (11) John W. McDowell, Mason McDowell, Elizabeth McDowell, Mary Jane McDowell, Mahala McDowell, William F. McDowell, the children of Betsey McDowell dec. (late Betsy Shain) and John F. (or S.) Smith, the child of Cynthia Smith, late McDowell, (12) Harriett Shain, (13) Angelina Shain, (14) Amanda Shain, and (15) Lewis J. Shain.

(Note: It appears from the listing that three of the daughters -- Mary Gammon Anderson, Esther Mills, and Betsey or Elizabeth McDowell -- died before their father and left several heirs. Also, it appears that one granddaughter, Cynthia McDowell Smith, had also died, leaving a son as heir. It is probable, but unverified, that the last four mentioned heirs may have been the children of a deceased son, or, perhaps, they were the youngest children, by a second wife.)

The following family relationships were abstracted

from some of the old notebooks of Alfred Harrison, one of Lewis County's old surveyors. The book number and its date head the listing of relationships.

Book No. 29, dated 1888:

- page 42 --- Memorandum of Susan Fry's estate from her brother, Allen S. Young. Received a letter from Daugherty and Bonar dated Apr. 7, 1888 stating Allen S. Young died without a will and left an estate of \$10 or \$11,000. Most of it consists in notes & money. The letter dated April 14 says that W. J. Rule is the administrator and has all the notes and money in his hands. The letter dated Sept. 17 says the administrator will pay out a part of the money in 10 or 15 days.
- page 38 --- Robert Gill's children requested by Jerry Blanton to be bound out. Names of children, to wit, George T. Gill and Mahala A. Gill.
- page 78 --- Mary C. Veach John S. Smith heired about 72 acres from J. C. McDowell. He sold it to Champ Osborn; he sold it to Sheets or Hackworth. Howell owns ten acres laid off the lower end of said 72 acres.
- page 109 -- Heirs of Jacob Applegate, who died Aug. 30, 1888: Horace Applegate, Mason Applegate, Benjamine Applegate, Thomas Applegate, Alexander Applegate, Albert Applegate, Sylvester Applegate, Medaline Hukle and Joseph H. Hukel (her husband), Eveline Duzan and John A. Duzan (her husband), Susan Spence and Jackson Spence (her husband), Hannah R. Applegate who married James Madders (Meadows) and died leaving the following children, to wit, Alexander, Mary C., Annie E., Sarah J., Thomas H., and Emma (or Evna?), all over 21 years old.

Book No. 25, date ?? (1888 maybe)

page 6 ---- David Crawford's heirs: to wit, Mary (widow); Lewis Crawford, Mary Botkin, Samuel Crawford, Elizabeth Gullett, Sarah Riley, Rachel Thomas,

page 74 --- Burrel Lambert's heirs: G. Lambert and Susan Keeton (jointly); Phenetia Lambert; G. W. Bruce, Alice Liles and Sam Patton (jointly); Sarah Davis, Charles C. Davis, Geo. B. Davis, Ida C. Davis, Lettie Davis. Elizabeth J. Davis, Sarah Davis, and Phentie Davis (jointly); Nancy McGlothlin; Burrell Lambert; Benjamin F. Lambert; Susan Hern.

page 76 --- Anderson Deatley's heirs, 1889: Elizabeth R. Thomas, Annie M. Bradley, Lettie M. Fenwick, Sarah Gidding, John J. Deatley, and Axie, Edward and Alma Deatley.

Back page: Sammie Young, nephew of Mrs. Fry, letter dated Nov. 5, 1888.

One source of data often overlooked or ignored by genealogists is bastard cases or illegitimate births. Several bundles of "Bastard Recognizances" are filed in the county clerk's office in Caldwell County, Kentucky. Usually, it was feared that the bastards would become dependents of the county so the court made an effort to assist the mother in obtaining support for the child from the father. Often the names of witnesses and bondsmen are listed in the original papers. The oldest bundle, dated 1815-1829, is abstracted below.

Mary Bridges swore that James Barnett, Jr. was the father of female child born 27 Sept 1814 at the house of Hugh Bannister.

Matilda R. Duning swore that William Galloway was the father of her female child born 27 Sept 1814.

Polly Newman swore that Hiram T. Pinell, yeoman, was the father of her female child born 20 July 1815 at the house of Simpson Newman.

Polly Bird swore that Milton Finley was the father of her female child born 7 Nov 1817 at the house of Thomas L. Hancock.

Abigail Johnson swore that James M. Hall was the father of her male child born 30 July 1819.

Polly Guess swore that Robert Hooker was the father of her female child born 15 Oct 1819 at the house of Joseph Guess.

Priscilla Armstrong swore that Isaac Simpson, laborer, was the father of her female child born 28 Dec 1820.

Abigail Johnson swore that James M. Hall was the father of her female child born 29 Jan 1822 at the house of Benjamin Johnson.

Polly Smart swore that John Bolton, laborer, was

the father of her male child born 20 May 1822.

Nancy Morse swore that Allen Pearce, laborer, was the father of her male child born 12 March 1825 at the house of William Morse.

Charity Lane swore that Thomas Anderson was the father of her male child born 30 July 1828 at the house Lincy Campbell.

Teressa Stevens swore that William Roberts, laborer, was the father of male child born 15 May 1828 at the house of Alexander E. Lowery.

Page 221. - Friday - July 19, 1805 Present, Honorable Henry P. Broadnax, William Comstock and James Jennings, Esq.

On reconsideration of the motion of Jo Allen to quash an execution on a replevin bond against Samuel Stuckey and Elijah Hardin, so ordered.

Page 221-2 Jo Huston v. James Ferry - in Debt Plaintiff appeared by attorney, defendant "came not". Plaintiff to recover from defendant and Thomas Kincheloe his appearance bail debt of 6 pounds, 5 shillings, 9 pence plus 6% interest from July 19, 1804.

Page 222 - Jo Huston v. James Duncan, Jr. - in Debt Plaintiff appeared by attorney; defendant did not appear. Plaintiff to recover from defendant and John Pate, the late sheriff, his appearance bail, 5 pounds, 17 shillings

3 pence plus 6% interest from middle of January 1805.

Page 222-3. Jo Huston v. Presley Cummings - in Debt Plaintiff appeared by attorney; defendant did not appear. Plaintiff to recover from defendant and Moses Cummings, his appearance bail, 5 pounds, 1 shilling, 3/4 pence with 6% interest from middle of January 1805.

Page 223. Jo Huston v. Daniel Barnes - in Debt Plaintiff appeared by attorney; defendant did not appear. Plaintiff to recover from defendant and Samuel Crawford, Jr., his appearance bail, 12 pounds, 3 shillings, 2 pence, half-penny, with interest of 6 pounds, 11 shillings, $7\frac{1}{2}$ pence as a part thereof, since July 20, 1804 and interest of 3 pounds, 9 shillings, 7 pence on the balance from March 4, 1805.

SOME OF THE DESCENDANTS OF JAMES SWART(S) REVOLUTIONARY WAR SOLDIER OF VIRGINIA AND KENTUCKY

The Will of John McFarland is of Record in Fauquier County, Virginia. The Legatees were: John McFarland, (nephew); and children of Robert McFarland, (brother); and Rachel Dabroc, (niece). Executrix: wife, Jane McFarland. Witnesses: James Batson, Jesse McVeigh, and M. Lacy. The Will was dated Jan. 16, 1802 and proven July 26, 1802.

In a Fauquier County Deed executed Nov. 2, 1809, and recorded Jan. 28, 1811, John McFarland, Grantor, was"of the County of Franklin, State of Pennsylvania." This was a Sale to William R. Swart.⁸

The marriage of Jane McFarland to Matthew Weatherby took place in Fauquier County, Virginia, on Jan. 12, 1804. They were married by William Williamson, a Presbyterian Minister.⁹

A Deed of Trust between Jane McFarland and Mathew Wetherby was executed on Jan. 12, 1804, and recorded in Fauquier County, Virginia, on May 28, 1804. This was a Marriage Contract. The following information is contained in the Contract.

"This Indenture made between Matthew Wetherby of Leesburg in Loudoun County and State of Virginia of the first part; Jane McFarland widow and relict of John McFarland late of Fauguier County and State aforesaid deceased of the second part, and James Crain of the County of Fauquier and Burr Powell of the County of Loudoun of the third part. Whereas a marriage is shortly intended to be had and Solemnized by the permission of God, by and between the said Matthew Weatherby and the said Jane McFarland and whereas the said Jane McFarland is possessed of a considerable real and personal Estate under the will of her deceased husband, John McFarland, consisting of the land whereon she at present resides, an improved lott in the town of Middleburg and all the personal Estate contained in the Inventory of the said John McFarland's Estate as recorded in Fauquier County Court a Copy of which appraisement is hereunto annexed. And whereas the said Matthew Wetherby is entitled to a considerable real Estate consisting of houses and lots in and about the town of Leesburg in the county of Loudoun, and whereas

it hath been agreed that the said Matthew Weitherby should after the intended marriage have, receive and enjoy during the joint lives of them the said Matthew Wetherby and Jane McFarland the Interest and occupation of all the real and personal Estate owned by the said Matthew and Jane, but that the real Estate and personal Estate of the said Jane together with the Interest and profits thereof from and after the decease of such of them the said Matthew Wetherby and Jane McFarland as should first happen to die should be at the sole and and only disposal of the said Jane McFarland notwithstanding her Coverture; and whereas it hath been also agreed that in case the said Jane McFarland should after the intended marriage had, happen to survive the said Matthew Wetherby that she should during her life have possess occupy and enjoy all the Estate real and personal which the said Matthew is now possessed of as well as what he may at his death have, subject however to be disposed of by the said Matthew at her death in any mannerthat he may by his last will and testament direct or appoint. From and after the decease of such of them the said Matthew Wetherby and Jane McFarland as shall first happen to die then upon trust, that he the said James Crain his Executors administrators and assigns shall and do assign transfer and pay over all the said property or so much thereof as shall then be undisposed of to the said Jane in case she survive the said Matthew Wetherby but if she die before him then unto such person and persons and at the time or times and in such parts and proportions manner and form as the said Jane McFarland shall from time to time notwithstanding her Coverture, by any writing or writings under her hand and Seal attested by three or more credible witnesses or by her last Will and testament in writing to be by her signed sealed published and declared in the presence of the like number of witnesses direct limit or appoint, to the intent that the same may not be at the disposal of or subject to the control debts forfeitures or engagements of the said Matthew Weatherby her intended husband and in default of such direction limitation or appointment then to go in equal proportion to Elizabeth Swart, John Swart, Jane Swart, and William Swart, the children of her brother , James Swart, who resides in Kentucky, share and share alike. And this Indenture further witnesseth that in pursuance of the agreement before recited and in consideration of the sum of one dollar to the said Matthew Wetherby in hand paid by the said Burr Powell at and before the ensealing and delivery of these presents the receipt whereof is hereby acknowledged he the said Matthew Weatherby hath granted

bargained sold assigned transferred and set over and by these presents doth grant bargain sell assign transfer and set over unto the said Burr Powell his Executors administrators and assigns all the Real Estate to which he is entitled either by law or equity consisting of lotts and houses in and adjoining the town of Leesburg to have and to hold the said lotts and houses in and adjoining the town of Leesburg unto the said Burr Powell his Executors administrators and assigns Upon Trust."¹⁰ Signed and sealed by: Matthew Wetherby, Jane McFarland,

James Craine, and Burr Powell. Teste: L. Brooke, Clerk.

The Will of Mathew Weatherby is of Record in Loudoun County, Virginia. It was written on Oct. 5, 1821, and Recorded on Feb. 11, 1822. He left one House and Lot on Loudoun St. in Leesburg, Va. to the Episcopal Church of Leesburg; one frame house & brick house, House & Lot, on King St. in Leesburg to Jacob Hadely; another House and Lot on the west side of the main road leading from Leesburg to Aldie, Middleburg, and the Carolinas to Jacob Hadely. Matthew Weatherby does not mention his widow, Jane, in his Will.

The Will of James Battson is of Record in Loudoun County, Virginia. It is dated Nov. 22, 1811. It leaves one half of his Estate to his wife, Hannah, and one half to his nephew, James Battson -- son of John Battson. Witnesses were Jane Weatherby and William Dennis.¹²

Hannah Battson's Estate is of Record in Loudoun County, although her will is not Recorded reference is made to the Will by her Executor, William R. Swart -

"Cash paid my expenses at Court at May & June Courts, 1827, in proving Will and takeing out letters testamentary and paid O'Dunham for attending as a witness to prove the Will -- I paid Jessee McVeigh's application for appraising one day and for one day settleing estate account."

Cash in the Estate was distributed to the following Heirs: Elizabeth Elliot, George Swart, Samuel Swart, James Swart, Thomas Rogers, James Rogers, Thomas M. Strain, John Rogers, Rebecca Swart, David Spahr, Hamilton Rogers, Joseph Clarke, John Morris, and Joshua Robinson. A distribution of funds resulting from the sale of Hannah Battson's wheat crop was made in which Jane Weatherby received a one-sixth interest. 13

The Settlement of the Estate of Jane Weatherby of Fauquier County, Virginia, was very involved and covered over a six year span of time. Reference is made in the Appraisal, dated Feb. 22, 1828, and Recorded May 26, 1828, of two Law Suits in Chancery: Wetherby vs. Hadley in Superior Court in Winchester, Va., and Wetherby Binn's -- Clerk of the Superior Court of Loudoun Co., Va., in Superior Court of Chancery, Richmond District.

From the previous information one can reconstruct the Swart Family of Loudoun Co. and Fauquier Co., Va. as migrating to the area, probably from Pennsylvania, beginning in 1770.

- #1. John Swart married Elizabeth
 - 2. Hannah Swart married James Battson.
 - Jane Swart married first John McFarland and 3. second Matthew Weatherby.
 - 15 Phoebe Swart married William Rogers. 4.

According to the Pension Record of James Swart, the son of John Swart, James returned to Loudoun County after the close of the War. However he fought in the Battle of Blue Licks in Kentucky on Aug. 19, 1782. His name is inscribed on the Battle Monument at Blue Licks State Park, Blue Licks, Ky.¹⁶ The Pension Record also states that James Swart

"emigrated to Kentucky in 1793." This was the year in which he received the Bounty Land Grant of 100 acres which was assigned to William Burr Harrison.

There is another reference to land for James Swart. This is for 200 acres from the State of Virginia, Warrant No. 1593, for service as a Soldier of the Virginia Line during the Revolutionary War. The date of the Warrant is August 20, 1783. This is apparently the land that James Swart settled on in what is now Robertson Co., Ky.

The 1800 Tax List for Kentucky lists James Swart as living in Nicholas Co. and a Henry Swart as living in Mason Co. It is likely that the two men were cousins. Adrian Swart, of Loudoun Co., Va., had sons: Barnet, James, Henry, and Tunis Swart. A Henry Swart appears in the 1830 Lewis Co., Ky. Census, aged sixty to seventy. James Swart was taxed in 1802 in Nicholas County for 300 acres on Johnson Creek. He continues to appear each year straight through to 1812. Then Margaret Swart appeared in 1813 and on through 1833. However she is paying on only 50 acres.¹⁰ The 1810 Census of Nicholas County lists James Swart

as Head of Household and over forty five years of age. He had three sons under ten years of age and one son between ten and sixteen. His wife, Margaret, was listed in the twenty six to forty five age bracket. There were two daughters, one under ten years, the other in the ten to sixteen year bracket.

James Swart married first Jane Rogers and second the widow, Margaret Thomas.²⁰ James Swart died Intestate in Nicholas Co., Ky. on May 10 (?), 1813. Margaret Swart, his widow, was one of the people appointed by the Court as Administrator and Grantee of the Estate of James Swart in July of 1813.²¹

As a matter of Family Tradition it has been stated that, "The body of James Swart rests in an unmarked grave on the old Governor Desha Farm in Mason Co., Ky." D.A.R. papers state that Jane Swart, the first wife of James Swart, died in Kentucky. This writer has not been able to definitely locate the place of burial for either Jane or James Swart. Margaret Thomas, the widow of James Swart, is buried in Mt. Pisgah Cemetery in Fleming County, Kentucky. The inscription reads: "Margaret Swartz. died 9 Dec., 1869, age 97 years, gone but not forgotten." Samuel C. Swartz gave land for this Ceme-tery, which is now in very poor condition.²² Martha D. Royse, of Flemingsburg, Ky., made three trips to Mt. Pisgah to find the grave of Margaret Swart.

Ordered that Skinner Hudson pay Thomas Kelsoe 340 Pounds of Tobacco for attending four days and traveling Twenty miles four times as a witness for him against Isaac Collett.

James Logan Exhibited and made Oath to a list of his own taxable property as follows, to wit: one white male above Twenty-one, one above Sixteen, one Black above Sixteen, and Five Head of Horses, which is ordered to be Certified to the Sheriff to Collect.

ADDENDA TO "SAMUEL WATT, PIONEER"

Shortly after the publication of the first installment of "Samuel Watt, Pioneer" in <u>The Kentucky Genealogist</u>, we received some additional information from a previously-unknown, very distant cousin. A resident of Madison County, Illinois, he had read the article and was thoroughly familiar with the area in which two of Samuel's children had settled. He told us that these two, James and Elsie (Mills) were buried, with a number of their descendants, in a family cemetery near Troy, Illinois, on land which had been owned either by James or by his wife's family, the Stices. In addition, he said that some of James' sons had left Madison County and settled in Warren County, Illinois, and that there was some information about the family in an old Warren County history.

We immediately went to look for the cemetery and found it without difficulty. It had been reasonably well kept and most of the stones were quite easy to read. A list of the burials is included here. In general the data on the stones corresponds closely with what we had previously learned, though we were pleased to have the more exact tombstone dates.

The information in the history -- "Historical Encyclopedia of Illinois and History of Warren County," Vol. II, 1903 -- was brief but added a bit more to our knowledge of Samuel Watt. As told by his great-grandson Benjamin F. (son of Felix K., grandson of James) Samuel Watt was born in Pennsylvania; tradition as previously given said he was born on shipboard coming from Ireland. In addition, the history gives the name of Samuel's father as John Watt and said he had come from Ireland. As to Samuel's military service, the history stated that Samuel served first in the militia and afterward in the regular army, indicating that the records previously referred to (in The Kentucky Genealogist) were indeed those of "our" Samuel.

Benjamin Watt also noted that Samuel had died in Warren County, Kentucky, at the age of 68, which places his birth date about 1759. This cannot be verified, of course, but it is close to our estimate. Pennsylvania required militia service at age 16; a Samuel Watt appears

on a list of the Plumstead District, Bucks County, for 1775.

Following is a listing of the Watt cemetery. Buried in this small plot are two of Samuel Watt's children, James and Elsie; four adult children of James and two who died young; three adult sons and one small child of Elsie; at least 13 grandchildren of Elsie and eight grandchildren of James; and several others who were either grandchildren or great-grandchildren.

Continuing efforts in Edmonson-Warren counties, Kentucky, to locate Samuel's grave have not been successful.

WATT CEMETERY

About 1½ miles south of Troy, Illinois, and slightly west, on land where Samuel Watt's son James lived and died. A fenced right-of-way leads to it and it has been reasonably well kept. Inventoried 5 September 1976 by Miss Lois Stanley and Mrs. George F. (Maryhelen) Wilson.

Stones were read starting at the southeast corner, up the row northward, then back down the second row. There are a number of unmarked graves.

First: what appeared to be three unmarked graves.

Robby Peterson: December 26, 1964-August 22, 1974 (Identity of this child, the last burial is not known. A little toy chipmunk marked the grave.)

Cowles -- a large obelisk, tumbled and in sections. On one side: Dear children: Margaret Cowles July 1, 1842 - January 19 1858 September 2, 1845 - November ? Sarah J. Oct. 27, 1847 - November 30, Joseph M. 1853 October 3, 1849 - June 3, 1852 Mary E. November 21, 1852 -Rachel M. Infant No dates John November L859, August 10, 1888

Other side: Sam Cowles August 12, 1816 - September 11, 1889, 73 years and 29 days Malinda Cowles died June 5, 1891 aged 71 yrs.

There were also individual stones for the Cowles children:

BOOK REVIEWS

Kentucky Obituaries 1787-1854. Compiled by G. Glenn Clift. With an Index by Anita Comtois. Baltimore (1941-1943) Reprinted 1977. 254 pp. \$15.00.

The valuable information contained in this book was originally published in ten instalments in The Register of the Kentucky Historical Society during the years 1941-1943. The skill with which Mr. Clift compiled these genealogical data and the added Index make the reprint an indispensable aid for the researcher.

The obituaries are listed in the order in which they appeared in the Kentucky newspapers originally. The notices have been edited to include the name of the deceased, the place of residence, the names of wife or husband, parents or other survivors, date of death, and other genealogical details.

The newspapers from which the obituaries were excerpted are held in the Lexington Public Library. They are the Kentucky Gazette, Kentucky Reporter, Argus of Western America, Observer, Observer & Reporter, and Reporter.

More than 5,000 obituaries are published in this one volume and 8,000 persons named.

West Virginia Estate Settlements. An Index to Wills, Inventories, Appraisements, Land Grants and Surveys to 1850. Compiled by Ross B. Johnston. (1955-1963) Reprinted Baltimore 1977. 176 pp. \$10.00.

Approximately 25,000 West Virginians living in the thirteen oldest counties of West Virginia before 1850 are named in this volume. The thirteen counties -Hampshire, Berkeley, Monongalia, Ohio, Greenbrier, Harrison, Randolph, Hardy, Pendleton, Kanawha, Brooke, Wood and Monroe - were all formed prior to 1800. Each county is dealt with in the order of its formation.

The data presented were abstracted from copies of estate settlements on file at the West Virginia State Department of Archives and History. The material includes information from wills, inventories, appraisements, land grants and surveys.

This work is basically an index of names of all who figured as principals in settlements of estates. As an enumeration of associated family members this is possibly the best research tool available for that part of Virginia which became the State of West Virginia.

Originally published in the journal <u>West Virginia</u> <u>History</u>, the twenty-one parts have been excerpted and consolidated in this convenient one-volume edition, permission having been granted by the Department of Archives and History of West Virginia, publisher of the journal.

<u>West Virginians in the American Revolution.</u> Compiled by Ross B. Johnston. (1939-1947) Reprinted Baltimore 1977 320 pp. \$15.00

First published in <u>West Virginia History</u>, this compilation is a comprehensive record of West Virginia Revolutionary soldiers. These men had at some time lived in what is now the State of West Virginia, but their military service had been rendered in other states, noticeably Pennsylvania, Virginia and Maryland.

The data given for each soldier usually provides name, age, date of birth, place of enlistment and service, pension file number, service record, dates pension applied for and granted, place of residence, names of wife and children, names of comrades in arms. The amount of information varies depending upon the materials available to the compiler.

The completed undertaking resulted from eight years labor and has scarcely an equal in West Virginia genealogy. The issues of West Virginia History containing these data are now rarely available, thus making this reprint volume a most valuable research aid.

Genealogy of Some Early Families in Grant and Pleasant Districts, Preston County, West Virginia. By Edward T. King. (1933) Reprinted Baltimore 1977 223 pp. \$12.50

Mr. King states that his original intention to write a history of the King family in Preston County, West Virginia, developed into a genealogy of several related families of early settlers in Grant and Pleasant Districts, Preston County, West Virginia. The Districts were formed in 1852 and prior to June 1863 Preston County was in the State of Virginia.

The families presented include the names Christopher, Connor(er), Cunningham, King, Matheny, Ryan, Street,

Thorpe, Walls, Wheeler, Wolf and Wolfe. In addition, Bible records of eighteen families are given, also membership lists, class meetings, histories of five early churches, as well as marriages performed there. Tombstone records from fortywone cemeteries in Grant and Pleasant Districts of Preston County, West Virginia, are featured. It is probable that 7,500 persons are named in these sections.

Comparatively few copies were published in 1933 by Edward T. King so that the book has been almost unobtainable. Genealogists will welcome this wealth of information.

<u>George Adam Mann 1734-1821. A Family on Four Frontiers:</u> <u>Pennsylvania, Virginia, Kentucky, Ohio. By Dorothy</u> C. Knoff. New Orleans. 168 pp. \$20.00 plus 50 cents for mailing expenses; for New Jersey residents \$1.00 sales tax.

Mrs. Knoff states that her first aim in making a study of George Adam's Branch of the Mann family has been "to give a semblance of life.... to its members and to the time and places in which they lived." She has accomplished this in a delightful manner.

Jerg Bernhart Mohn (Georg Bernhardt Mann), a Palatine, father of George Adam Mann, arrived at Philadelphia September 21, 1732, with his wife, Anna Margrit, having been imported in the Pink Plaisance "from Rott" but last from Cowes." After several months he traveled with his family and others by pack-train to Lancaster County, sixty miles west.

Continuing with George Adam Mann's branch of the family, and including Jacob Herman (Harmon) and his family, detailed accounts of their travels to and sojourns in Virginia, Kentucky and Ohio are given. Descriptions of the beautiful mountains and valleys in all four states are vivid and the reporting of the frontier life of the Valley Germans during the Revolution, the Peaked Mountain Church, the Wilderness Road, the activities in Nicholas County, Kentucky, and Green and Clinton Counties, Ohio combine to portray the atmosphere of the period. The activities of the Mann and Harmon families are documented by legal and Bible records, census reports, tombstone inscriptions.

Part Four contains an excellent genealogy of the Mann family, supported by official data. It is illus-

trated with photographs down to and including "Bell Mann Cooper and Dorothy."

Art work, lettering and the illustration for the title page are by Dolores Croneberger.

Seven maps and three surveys cover the vast area traveled.

Early Marriage Records of Casey County, Kentucky: 1807-1915. By Phillip A. Rice, Kathleen Goff, Charlotte Mason and Edward Mason. New Orleans. 1977. \$17.50.

These records are divided into two volumes in the one book: Volume One 1808-1900 and Volume Two 1901-1915. They have been compiled from official records in the Casey County Courthouse at Liberty, Kentucky. The lists are arranged alphabetically by the grooms' names. Unfortunately there is no index of brides' names. However, this book is a most valuable research aid and will be welcomed by genealogists. Libraries will find this an important addition to their Kentucky data.

A short history of Casey County and the dedication of the work precedes the marriage records.

A picturesque scene of 'the Casey County Courthouse, demolished in 1888, is the photographic illustration opposite the title page.
