The first Annual Institute on Genealogy and Family History, sponsored by the Committee for Advanced Genealogical Research and the Houston Community College System, in cooperation with Clayton Library for Genealogical Research, will be held at Astro Village, Houston, Texas, June 4-8, 1978.

It has been endorsed by the Board of Certification of Genealogists and approved by the Executive Council of the American Society of Genealogists. Directors of the Institute are Winston De Ville, Richard S. Lackey and Mary Lewis Ulmer.

Among the lecturers will be John Frederick Dorman, Fellow, American Society of Genealogists, who will speak on Virginia and Kentucky.

The National Institute on Genealogical Research will be held May 8-26, 1978. Classes will be taught by distinguished archivists, genealogists and librarians at the National Archives Building in Washington, D. C. Several field trips to record repositories in the Washington area are scheduled. The registrant may choose in addition a trip to the Virginia State Library and Virginia Historical Society at Richmond or one to the Pennsylvania Historical and Museum Commission and State Library of Pennsylvania at Harrisburg.

WILLIAM JOSEPH TALLEY  
OF FLEMING COUNTY, KENTUCKY

NOTE: Although the name is written both Tally and Talley, for the sake of consistency, it will be spelled with the "e" except specific records which spell it otherwise.

William Joseph Talley has been a very elusive person to trace. He was born in Hanover County, Virginia, and was a son of William Talley and Elsia (Price) Talley. Sometime before the Mexican War he moved to Richland County, Illinois. After the Mexican War, in 1849, he arrived in Fleming County, Kentucky, where he married his second wife. After her death, in 1874, William J. Talley moved back to Illinois, married his third wife, and died sometime in the mid-1890s.

His date of birth is unknown. In several places he gave his age very inconsistently. The 1850 census of Fleming County gives his birthdate as 1812, the 1870 census of Fleming County gives it as 1820, and his third marriage record in Richland County, Illinois, gives it as 1822, but his application for a Mexican War pension gives his birthdate as December 22, 1800. It is quite likely that his birthdate was approximately 1822 and the birthdate on his pension application is a mistake caused by a reversal of numbers.

When William J. Talley applied for a Mexican War pension in the State of Illinois, he stated that he enlisted in the State of Illinois, that he was in the Battles of Buena Vista, Monterrey, and was at Mexico City. Also, he was wounded in the shoulder in one of the battles as he carried his commanding officer off the battle field. He did not receive a pension because his name could not be found on the roster. He stated that he had always believed his name had been entered incorrectly on the list of his company. It is known that when he arrived in Fleming County, Kentucky, in 1849, he had a crippled shoulder and the family always stated that it was a war injury. (This latter information came from an interview with Mrs. Sarah Jane Borders, of Fleming County, on June 26, 1950. She was a niece, by marriage, of William J. Talley and remembered him well.)



The three marriages of William Joseph Talley:

(1) First marriage: no information. Family tradition says he was married prior to his arrival in Fleming County and his third marriage record in Richland County, Illinois, verifies this.

(2) Second marriage: to Elizabeth Jane (Mers) Keal, the widow of Henry B. Keal, and daughter of Samuel and Christeny (Plank) Mers, of Fleming County, Kentucky.

(3) Third marriage: to Mariah A. Harmon, a widow, in Richland County, Illinois.

Marriage Book A, Fleming County, Ky.:

William G. J. Tally to Elizabeth Keel, September 10, 1849  
Samuel Mers, security.

(Note: William J. Talley signed his marriage record with the signature "W.G.J.Tally." It is not known what the "G" stood for.)

- (1) Samuel Keal, born about 1838
- (2) Leander C. Keal, born about 1841
- (3) Cummins Keal, born about 1847

(Note: Henry B. Keal and Elizabeth J. Mers were married Mar. 20, 1836, by Rev. Peter Hon, in Fleming County, Kentucky)

The children of William Joseph Talley and Elizabeth Jane (Mers) (Keal) Talley:

(1) William J. Talley, Jr., who married Mary F. McCall, at the Battle Run Christian Church, Fleming County, Ky., Feb. 14, 1877. He was born about 1852.

(2) Henry Talley, born about 1853, married Ruth Pearce, in Fleming County, Ky., Sept. 7, 1874. He and his family moved to Missouri or Kansas.

(3) Hickerson Belt Talley, born about 1857, married (1) Nancy J. Holland, in Fleming Co., Ky., Sept. 21, 1876, and (2) Sarah Argo. He is buried in the Olive Branch Cemetery, Fleming County, but he has no gravestone.

(4) Robert T. Talley, born January 6, 1861, died June 24, 1934. He married: (1) Mary Jane Ramey, in Fleming County, Ky., Oct. 19, 1882, and (2) Lou Teacie Raméy, both daughters of John Ramey and Mary Jane (Cochran) Ramey. Robert Talley and both wives are buried at Elizaville Cemetery, Fleming County, Ky.

(5) Cynthia Ann Talley, born about 1851, married Henry Jackson, in Fleming County, Ky., on May 31, 1866. Henry Jackson was many years her senior, having been born about 1811. They had only one child: James Henry Jackson, who died shortly after his marriage to Matilda F. Crump, on Oct. 17, 1894, in Fleming County. According to his marriage record. James Henry Jackson was born about 1872. Cynthia Ann Talley Jackson died young.

Virtually all of the Tally / Talley families of Bourbon, Fleming, Mason and Nicholas counties, Ky., are descended from William J. Talley and his wife, Elizabeth Jane Mers Keal.

It has never been determined what relationship William J. Talley was to the other Talley families of Richland County, Illinois. Extensive research at Olney, Illinois, indicates that most of the Talley families of that area came originally from Lebanon County, Tennessee. William J. Talley stated on two occasions that he came from Hanover County, Virginia.

This writer welcomes any correspondence on this family.

HEWITT, JUDGE J. M. (1793-1869)

"DEATH OF A VIRGINIAN

"The Frankfort (Ky.) Yeoman announces the death of Judge J. M. Hewitt, who held many positions of trust and honor in that State - among them judge of the Louisville Circuit and member of the Constitutional Convention. He was born in Stafford County, Va., near the mouth of Aquia Creek, on the 29th day of December 1793 and was commissioned a second lieutenant in Col. Stanard's regiment of the regular army in May 1815, participating in some of the closing scenes of the War of 1812.

"In March 1816 he obtained a license as an attorney and commenced the practice of law at the bar of Prince William County, Va., but soon becoming dissatisfied with the location, he emigrated to Kentucky on horse back and resumed his profession at Bowling Green in that state in 1817. From that time until his death his career was a successful one."

N.B. This is Judge John Marshall Hewitt, youngest child of Major William Hewitt (1747-1795) of Stafford County, Va. and his wife nee Catherine Edmonds (1756-1823) who were married in 1779 in Fauquier County, Va. Oddly, Judge J. M. Hewitt had an elder brother, John Edmonds Hewitt who was named for his maternal grandfather. George H.S.King.

ACTS PASSED AT THE FIRST SESSION OF THE TWENTY-SEVENTH GENERAL ASSEMBLY FOR THE COMMONWEALTH OF KENTUCKY, BEGUN AND HELD IN THE TOWN OF FRANKFORT, ON MONDAY THE SEVENTH DAY OF DECEMBER 1818 ...

Page 662 - CHAP. CCCLVI - An Act for the benefit of Frances Lewis Approved February 2, 1819

Whereas it is represented to the present general assembly, that Frances Lewis has been cruelly and inhumanly treated by her husband, Tiptan Lewis, that he has abandoned her for nearly two years, and left no means of support what ever, and she is entirely dependent on her mother, who is in indigent circumstances: Be it enacted by the General Assembly of the Commonwealth of Kentucky, That the marriage of the said Frances Lewis, with the said Tiptan Lewis, is hereby totally dissolved.

Page 664 - CHAP. CCCLX - An Act for the relief of Eliza G. Ball Approved February 3, 1819

... that Eliza G. Ball has been cruelly and inhumanly treated by her husband, Spencer Ball; that he has absconded her in a country distant from her friends and relatives, leaving her without the means of support, dependent on the compassion of strangers: ... That the marriage of said Eliza G. Ball, with the said Spencer Ball, is hereby totally dissolved.

Page 700 - CHAP. CCCLXXXV - An Act for the relief of Elizabeth Armstrong Approved February 6, 1819

... about the year 1813, a certain Benjamin D. Armstrong came to this state, and shortly thereafter married a certain Elizabeth Scott, with whom he lived a short time, and it was then reported and believed that the said Benjamin D. Armstrong had, at the time of his said marriage, a wife living in the state of Tennessee, and that upon his hearing said report, [he] left his said wife Elizabeth, and has never since returned to her: ... That the bonds of matrimony solemnized between the said Elizabeth and Benjamin D. Armstrong, so far as respects the said Elizabeth,

be, and the same are hereby set aside and declared null and void.

ACTS PASSED AT THE FIRST SESSION OF THE TWENTY-NINTH GENERAL ASSEMBLY FOR THE COMMONWEALTH OF KENTUCKY, BEGUN AND HELD IN THE TOWN OF FRANKFORT, ON MONDAY THE SIXTEENTH DAY OF OCTOBER 1820 ...

Page 47 - CHAP. XL - An Act granting a Divorce to Elizabeth Western Approved, November 23, 1820

Whereas it appears that James Western, the husband of Elizabeth Western, who has petitioned for a divorce, is habitually a drunkard, has wasted and dissipated his estate by gambling and debauchery: that he has frequently beat and cruelly treated her, and that there is no prospect of reformation: but that said Western has abandoned his wife with seven children: Therefore,

Be it enacted by the General Assembly of the Commonwealth of Kentucky, that said Elizabeth Western, formerly Elizabeth Gale, be and she is hereby absolved and released from the bonds of matrimony: and the said Elizabeth is hereby restored to, and invested with all privileges and immunities of a single woman, as fully as if the marriage between the said Elizabeth and James Western had never been solemnized.

Page 130 - CHAP. CVII - An Act for the divorce of Cynthia Carson Approved, December 13, 1820

... that David Carson of Rockcastle county, has for several years last past treated his wife Cynthia in a most shameful and unfeeling manner: that he has given himself up to idleness, intemperance and debauchery: that he spends much of his time with an idle, dissolute woman, and takes from his wife and children their only means of support, for the maintenancē of said dissolute woman:

... That the said Cynthia Carson be, and she is hereby divorced from her said husband, and the bonds of matrimony solemnized between the said David and Cynthia Carson shall be, and the same are hereby set aside and held for nought, and the said Cynthia restored to all the privileges of a feme sole.

Page 148 - CHAP. CXXII - An Act for the divorce of Betsey Craig, Polly Stewart and Martha Dunlavy Approved, December 19, 1820

... that Benjamin Craig has treated his wife, Betsey

Craig, with great cruelty and inhumanity, insomuch as almost to deprive her of her life, and hath provided no means for her support: That Levi S. Stewart has left his wife, Polly Stewart, in a disolate situation, and gone to another state, and married another woman, with whom he lived in adultery in this state: And that Daniel Dunlavy hath abandoned his wife, Martha Dunlavy, since April 1819, without leaving any means for her support, and that he hath joined the Shakers; for which causes their wives have severally prayed to be divorced: ... That the said females be, and they are hereby divorced from their said husbands, and that they be restored to all the rights and privileges of femes cole (sic).

Page 178 - CHAP. CXLV - An Act for the divorce of sundry persons. Approved, December 23, 1820

... that Elizabeth Dunn, wife of William H. Dunn, was at the time of their marriage pregnant by another man, and of which the said William was ignorant: That Jane Hughes, wife of John Hughes, was, about four months after their marriage, delivered of a child by another man; that she was a prostitute, and of which the said John was ignorant: That Joanah Anderson, wife of Vincent Anderson, at their marriage had another husband: That Elizabeth Carstarphen, wife of Robert E. Carstarphen, was, at the time of their marriage, pregnant by another man, and of which the said Robert was ignorant: That Ann Smock, wife of Henry Smock, of Mercer county, has been guilty of adultery, and has abandoned her husband; For which their husbands have severally prayed to be divorced:

... That [the] marriages between the parties aforesaid, shall be, and the same are hereby totally dissolved.

... That Sally Clarke, of Green county, be divorced from her husband John Clarke - it appearing he has abandoned her for seven years, and without providing for her any means of livelihood, and had lived in a state of dissipation and idleness.

ACTS PASSED AT THE SECOND SESSION OF THE THIRTIETH AND THE FIRST SESSION OF THE THIRTY-FIRST GENERAL ASSEMBLY FOR THE COMMONWEALTH OF KENTUCKY, BEGUN AND HELD IN THE TOWN OF FRANKFORT, ON MONDAY THE THIRTIENTH DAY OF MAY: AND THE TWENTY-FIRST OF OCTOBER, 1822.

Page 98 - CHAP. CCCCXVII - An Act to divorce Rebecca Walker Approved, December 2, 1822.



Whereas, it is represented to the present General Assembly of the Commonwealth of Kentucky, that William Walker was arrested and recognised to appear before the circuit court of Fayette, to answer to several charges of felony, but forfeited his recognisance, and fled from this commonwealth and justice, and at the same time abandoned his wife Rebecca Walker to extreme indigence, Therefore upon the petition of said Rebecca,

Be it enacted by the General Assembly of the Commonwealth of Kentucky, That the marriage contract between the said William and Rebecca be dissolved, and that the said Rebecca be, and is hereby divorced.

Page 203 - CHAP. CCCCXCVII - An Act for the relief of Nancy Mosley Approved, December 10, 1822

Whereas it is represented that John O. Mosley of Christian county has treated his wife Nancy Mosley cruelly, has been convicted and sold (sic) as a vagrant and will not provide for the support and maintenance of his family.

... That the marriage between said John and Nancy be, and the same is hereby forever dissolved.

Page 217 - CHAP. CXIII - An Act for the divorce of Peter Pursell Approved, December 11, 1822

... that Catharine Pursell, the wife of Peter Pursell, when he married her, was pregnant by another man, which fact she concealed from her husband, for which he hath prayed to be divorced:

... That the marriage between the said parties, be, and the same hereby is totally dissolved.

ACTS PASSED AT THE FIRST SESSION OF THE THIRTY-THIRD GENERAL ASSEMBLY FOR THE COMMONWEALTH OF KENTUCKY, BEGUN AND HELD IN THE TOWN OF FRANKFORT, ON MONDAY THE FIRST DAY OF NOVEMBER IN THE YEAR OF OUR LORD 1824

Page 16 - CHAP. 13 - An Act to annul the marriage of George and Polly Utley.

Be it enacted by the General Assembly of the Commonwealth of Kentucky, that the marriage of George Utley with his wife Polly, be, and the same is hereby annulled and vacated and set aside, to all intents and purposes, and in the same situation as if the said marriage had never taken place.

[Approved November 25, 1824]



Page 62 - CHAP. 57 - An Act for the benefit Ermina M'Haney and Elizabeth Chrisman ... that William F. M'Haney, husband of Ermina M'Haney, has been guilty of felony, and divers other offences equally criminal, and finally abandoned her:

... That the bonds and obligations, of matrimony, solemnized and existing between the William and Ermina be, and the same are hereby dissolved, and the said Ermina forever discharged therefrom.

... That the said Ermina is restored to her maiden name and all the privileges and immunities of a feme sole.

111 that Isaac Chrisman, late of Jessamine county, who intermarried with Elizabeth Chrisman, late Elizabeth Proctor, did feloniously steal and carry away a cream-coloured mare, the property of Elijah East of the county of Jessamine, and that the said Chrisman was taken into custody for the same, but effected his escape without a trial, and is now going at large:

... That the marriage of the said Elizabeth Chrisman and Isaac Chrisman be, and the same is hereby dissolved and the said Elizabeth Chrisman be restored to all the privileges of a feme sole, and that she hereafter bear the name of Elizabeth Proctor.

[Approved, December 27, 1824]

Page 63 - CHAP. 58 - An Act for the divorce of Sally Buster

... That the marriage contract heretofore existing between Robert Buster and Sally Buster, his wife, be, and the same is hereby declared to be null and void, so far as relates to the said Sally Buster, and that she be divorced and forever free from said contract, and restored to all the rights and privileges of a feme sole.

[Approved, December 27, 1824]

Page 63 - CHAP. 59 - An Act for the benefit of Jesse Baker, jun.

... that Mildred Baker, wife of Jesse Baker, junior, was at the time of their marriage, pregnant by another man, of which the said Jesse was ignorant:

... That the marriage between the aforesaid Jesse and Mildred, shall be, and the same is hereby totally dissolved.

Otho Brashears served in Capt. Peter Dudley's Company. He was shot through the hand at Fort Meigs. Invalid Pension granted 20 April 1816 at \$4 per month. Pension was increased to \$8 per month under later law.

Widow's pension approved October 18, 1879. She states that at the time of enlistment soldier was 18



years old, 5 ft. 10 or 11 inches, dark hair, dark eyes, dark complexion, a farmer; birthplace unknown. That she was married in Hancock County, Kentucky, January 17, 1836 by Mason, a Justice of the Peace. That her husband was previously married to one Mary Wells.

Affidavit from Justice of the Peace Mason stated that he married Otho Brashears and Mrs. Julia Ann Jackson on January 15, 1837 in Hancock County, Kentucky.

William Brashear served 68 days including 1 day travel as a private in Capt. James Armstrong's Company Kentucky Militia, War of 1812.

State of Indiana, County of Clark, 15 Jan. 1851, William L. Brashear appeared, and, being duly sworn, declared that he was a private in Captain James Armstrong's Company; that he volunteered at Augusta, Kentucky, 29 August 1813 and was at the Battle of the Thames and was discharged at Aberdeen, Ohio, 3 Nov. 1813. That he was born in Bracken County, Kentucky, Oct. 8, 1797 and was then (1851) a resident of Washington County, Indiana.

War of 1812 Service Pension Act of March 9, 1878. Mahala Brashears, Little Fork, Washington County, Indiana, widow of William B. Brashears, a private in Capt. James Armstrong's Company, Kentucky Militia, stated that she and her husband were married 17 March 1831 in Scott County, Indiana, by William Truelock, J.P.; that her husband died February 23, 1868; that her maiden name was Mahala Spurgeon. It was reported on April 19, 1887 that the widow was 75 years old and still active and in good health; that soldier had died at 75 about twenty years before.

Page 72-74. March 3, 1817. Charles Y. Duncan, Sheriff of Daviess County, to Elisha Adams. On writ of fieri facias, from clerk's office of Daviess County, dated May 6, 1816, directed to the sheriff, commanding him that of the estate of William Adams, Eli Adams, Elisha Adams, William Head and Hannah, his wife, late Hannah Adams, Jane Adams, Peggy, Susanna, and Elizabeth Grey Adams, heirs at law of James Adams, deceased, that he should cause to be made \$115.00 plus interest of 6% from April 9, 1810 until paid, to be levied on the lands of the said James Adams, which William H. Woolsey lately recovered in the Daviess Circuit Court. Also the sum of \$13.50 costs. The land, being part of 4000 acre tract on waters of Beaver Creek, now called Pup Creek, patented in the name of Samuel Oldham, being the part unsold and remaining, which was advertised to be sold on July 6, 1816, and said land being unsold for want of bidders. The Fulton Genealogical Society has published another valuable book presenting genealogical resource material. From these marriage bonds the names of those marrying between 1822 and 1845 in Hickman County, Kentucky, have been recorded with the dates of marriage. The date of the License and the date of the Return have been noted in some instances. In the marriage of Andrew J. Rash and Mary Thompson the marriage is reported as having taken place 17 July 1832, the license dated 9 July 1833 and the return 15 Feb. 1834. Where it has been difficult to read the names two are listed as in "Outlaw" or "Outland."

Index to the 1810 Census of North Carolina. Compiled

by Elizabeth Petty Bentley. Baltimore. 1978.  
282 pp. \$17.50.

This Index is destined to become one of a handful of books routinely used by anyone conducting research into North Carolina genealogy. Although the census schedules for Cravens, Greene, New Hanover and Wake counties are missing, nearly 64,000 heads of households appear in this Index, 3,000 more than in the index to the 1800 census. Like that volume, this work presents first the family name of the head of household, followed by his Christian name, his county of residence, and the page number of the census schedule.

Mrs. Bentley adds much to the value of the book by her instructive Introduction, setting forth a statement of methodology, suggestions for dealing with irregular spellings, and a description of the contents of the original census returns. In two Tables she further describes the mechanics of the Index.

A map of North Carolina at the beginning of 1800 showing approximate county divisions within present state boundaries is included.

Now Mr. Hollowak has produced a work of major proportions to facilitate research concerning some 60,000 persons. His book is designed as a finding aid to the thousands of marriages and deaths which were noted in The Sun between 1837 and 1850. The main Index is arranged alphabetically by the surname of the subject, except that in the instance of a marriage only the name of the groom is in alphabetical order.
