

JESSE HOLMES' COMPANY, KENTUCKY MILITIA, 1806

The original manuscript of this roll is preserved in the Marion Amis Green Collection, folder 4, Manuscript Department, The Filson Club, Louisville, Kentucky. This company was attached to the 18th Regiment, 2nd Brigade, 6th Division. The 18th Regiment was from Shelby County and the first commissions were issued 21 December 1794. [G. Glenn Clift, The "Corn Stalk" Militia of Kentucky, 1792-1811 (Frankfort, 1957) page xiv.] All commenced service 25 December 1806.

LIST OF CAPTAINS FROM KENTUCKY IN THE WAR OF 1812

This list is preserved in the Charles Stewart Todd Papers, folder 19, Manuscript Department, The Filson Club, Louisville, Kentucky. Undoubtedly it was among the papers of Goy. Isaac Shelby, whose daughter Letitia married Charles S. Todd, the son of Supreme Court Justice Thomas Todd. Because so many Kentuckians served in this war it should prove of interest as proof of service for these officers as well as in documenting the number of men in their companies and their county of residence. In Kentucky Soldiers of the War of 1812 (Frankfort, 1891) reprint indexed edition Baltimore 1969, the following names on this list could not be found in the index: John Fortner, R. C. Megowen and John Dessert. They may be listed under a variant spelling that did not occur to the editor or they may be names not previously recorded. Variants found which clarify names on this list were Eleazor Heddin, Gustavus W. Bower, Conrad Overdewple (for Overduph) and Joseph McCloskey (for McClaskey). Y. Ewing is Young Ewing and Matthew Flonoy is Flournoy. The printed report misreads Phillip Shiveley as Shireley.

New Port 1st September 1813

A return of Kentucky mounted volunteers mustered on the 30th & 31st days of August, and continued until the first day of September, 1813 at said Place, by the order of his exellency Isaac Shelby Govenor of Kentucky and under his Command, to Join the North western army, under the command of Majr. Genl. W. H. Harrison.

GENERAL AND FIELD OFFICERS, KENTUCKY MILITIA, 1813

The original manuscript list is preserved in the Charles Stewart Todd Papers, folder 19, Manuscript Department, the Filson Club, Louisville, Kentucky. The document was owned originally by Todd's father-in-law, Gov. Isaac Shelby. The latest date in the text is 25 June 1813, but the manuscript itself is not dated, although it is reasonable to assign a year date of 1813 to it. The list was prepared during the War of 1812 as part of military preparations for the Governor. The last entries are incomplete and scrawled as though written in haste as an addition to the earlier entries which are carefully scribed.

PENSION APPLICATIONS FOR WAROF 1812 SERVICE

(Continued from volume 24, page 134) BRUCE, Durett. S.O. 7292, S.C. 7584; BLWt. 19774-160-50.

8 Jan. 1851. Randolph Co., Mo. Durrett Bruce of said county, aged about 60, declares he was a private in the company of Capt. John Martin in the 5th Regiment, Kentucky Volunteers, of Col. William Lewis. He volunteered at Winchester for six months and was discharged at home on his return, being sick on parole. He was a private in the company of Capt. James Simpson in the Battalion of Mounted Volunteers commanded by Major Peter Dudley on an expedition in Upper Canada, volunteered at Winchester, Clark Co., Ky., in the latter part of the summer of 1814 and was discharged on his return to Kentucky about 1 Feb. 1815.

28 June 1814. Winchester, Ky. John Martin, captain of one company under Col. William Lewis, commandant of the 5th Regiment, Kentucky Volunteers, certifies Derrit Bruce performed a tour of six months under him.

1 Feb. 1815. Frankfort, Ky. James Sympson, captain, and Peter Dudley, major, certify Durrett Bruce served a tour on an expedition to Upper Canada and is entitled to credit for four tours of 30 days each.

27 Jan. 1852. Randolph Co., Mo. Derrett (X) Bruce of said county, aged about 61, declares he served until taken sick about 15 Nov. 1812 and was then placed in the hospital and was dangerously ill until about the close of the campaign.

27 Jan. 1852. Randolph Co., Mo. James Emerson of said county, aged 62, declares he was a private in Capt. John Martin's company and knows Durret Bruce was a soldier from about the middle of Aug. 1812 until unable to perform duty and placed in the hospital.

1 April 1871. Randolph Co., Mo. Durrett Bruce of Moberly, aged 81, declares he married Sarah Stevens, now deceased, on 13 April 1813 at Clark Co., Ky. He enlisted in Capt. John Martin's company, Col. Lewis' regiment, at Winchester, Ky., in 1812 and was discharged at Fort Defiance, Ind., in 1812. The regiment marched to Fort Wayne and then to Fort Defiance. He enlisted a second time in Capt. James Simpson's company, Kentucky Militia, at Winchester in 1814 and was discharged at Detroit, Mich. He was at the burning of Detroit Mills.

His pension was last paid to 17 Feb. 1886; he was dropped from the rolls because of death.

War of 1812 Pension Applications

BRUCE, Eli. S.O. 6614, S.C. 3945; BLWt. 3031-80-50, 15486-80-55.

2 Nov. 1850. Clark Co., Ky. Eli Bruce, private in the company of Capt. James Sympson in the Battalion of Mounted Volunteers of Major Peter Dudley, declares he volunteered at Winchester, Ky., Oct. 1814 for four months and was discharged at Detroit, Dec. 1814.

31 March 1855. Clark Co., Ky. Eli Bruce of said county, aged 60, declares he was a private in the company of Capt. James Sympson, Mounted Men, in regiment of Kentucky Volunteers of Col. Peter Dudley and volunteered in Clark County about 1 Sept. 1814 and was discharged at Detroit 10 Dec. 1814.

1 Feb. 1815. Frankfort, Ky. James Sympson, captain, and Peter Dudley, major, certify Eli Bruce served a tour on an expedition to Upper Canada and is entitled to credit for four tours of 30 days each.

1 April 1871. Clark Co., Ky. Eli Bruce of Winchester District in said county, aged 76, applies for a pension. He married **Temperance Dollard** at John Gordon's [?] in Clark County 26 Feb. 1828. He resides $4\frac{1}{2}$ miles east of Winchester.

The Third Auditor reported Eli Bruce served from 20 Sept. 1814 to 20 Nov. 1814, 62 days.

Bounty land warrant 3031 for 80 acres was issued 17 March 1851. Bounty land warrant 15486 for 80 acres was issued 15 Dec. 1855.

BRUCE, John (widow Catharine D.). Old War Invalid file 4270; W.O. 354, W.C. 25857; BLWt. 26890-80-50, 36906-80-55.

18 March 1833. Harrison Co., Ky. John Bruce of said county declares in the fall of 1814 he rendezvoused at Newport, Ky., in the company of Capt. Memorial Forest of the 16th Regiment, Kentucky Militia, commanded by Col. Andrew Porter. He marched with the regiment to Fort Malden in Upper Canada where he was stationed until 5 April 1815, one month after the expiration of his term of service. He returned home with his health much impaired. On his march to Malden he had to pass through a tract of country called "Black Swamp" and in passing he was exposed to more than his constitution and system would bear and was attacked with violent rheumatic pains. He there contracted the disease which appears incurable for it has afflicted him ever since. notwithstanding all medical applications. On his passage through said swamp he became so disabled as to have to be placed on horseback and then supported. During the balance of the tour he was almost incessantly, more or less, afflicted with the most violent and excruciating pains. Whenever he is accidentally or otherwise exposed, even slightly, he is so affected as to be disabled from labor.

18 March 1833. Harrison Co., Ky. John Mann, late lieutenant, and William Hutcherson, a member of Capt. Memorial Forest's company, certify John Bruce contracted a violent rheumatism, from exposure, in crossing the "Black Swamp". The disease disabled Bruce from marching on foot and he was scarcely able to go forward on horseback.

11 Feb. 1833. Harrison Co., Ky. Joel C. Frazer, M.D., late Surgeon's Mate, 16th Regiment, Kentucky Militia, declares John Bruce, a private in Capt. Memorial Forest's company under Col. Andrew Porter, was mustered in at Newport, Ky., accompanied the regiment to Fort Malden in Upper Canada, and on the route through a tract of country lying between Forts Findley and Meigs known by the name of the "Black Swamp" from exposure to mud and water became violently affected with inflamatory rheumatism, so much so that he had to be transported on horseback in incredible pain. He has known him ever since and he has been subject on slight exposure to violent attacks of the disease and has for some time been unable to obtain a livelihood by manual labor.

15 March 1833. Harrison Co., Ky. G[eorge] H. Perrin, quarter master sergent in the 16th Regiment, Kentucky Militia, states since his return from the expedition he has engaged in the study and practice of medicine in Cynthiana. John Bruce was severely attacked with acute rheumatism.

10 March 1851. Harrison Co., Ky. John Bruce of said county declares he joined the company of Capt. M. Forest in the 16th Regiment, Kentucky Militia, at Cynthiana, Ky., 1 Oct. 1814 for six months and was discharged at Detroit, Mich., in April 1815.

10 March 1851. Harrison Co., Ky. William Hutcherson attests to Bruce's service.

22 May 1855. Harrison Co., Ky. John Bruce of said county, aged 65, applies for additional bounty land.

26 Dec. 1870. Harrison Co., Ky. Catharine D. Bruce of said county, aged 45, declares her husband John Bruce died in Harrison County 3 Oct. 1870 of dropsy which resulted from a sore leg. They were married in Harrison County 10 April 1856 by Samuel Rogers, minister. Her name was Catharine D. Cloe. Her children under 16 are Henry R., born 15 Nov. 1857, and Lewis V., born 8 June 1865. Her post office is Colemansville, Ky.

10 April 1856. Harrison Co., Ky. John Bruce, widower, born in Pennsylvania, and Catharine D. Clowe [Cloe], born in Kentucky, were married at the house of John Bruce in the presence of John Barnes and Hamilton Bruce by Saml. Rogers, E.C.C.

War of 1812 Pension Applications

30 Dec. 1870. Harrison Co., Ky. John Newton Smith, M.D., of Berryville P.O., Ky., declares he attended John Bruce in his last illness previous to his death 3 Oct. 1870. Bruce stated he had been afflicted with a running sore on his leg for more than forty years and a doctor from Owen County had almost healed it up. Very soon afterward Bruce was taken very ill with an attack of chills and fever which finally terminated in dropsy and soon afterward ended his life. He has no doubt his life was lost by healing up the sore leg.

31 Dec. 1870. Delaware Co., Ohio. Thacker W. Hedges, M.D., of Birkshire P.O., late from Colemansville, Ky., declares he waited upon Catharine D. Bruce, wife of John Bruce, at the births of Henry R. on 15 Nov. 1857 and Lewis V. on 8 June 1865.

24 May 1879. Pendleton Co., Ky. Catharine D. Bruce of Cordova, Ky., widow of John Bruce, declares her husband enlisted 9 Sept. 1814 and was discharged at Fort Malden 10 March 1815 from Capt. Forester's [sic] Company, 16th Regiment, Kentucky Volunteer Militia. At the time of his enlistment he had hazel eyes, dark hair and was 5'9'' high. She was married at Colemansville, Ky., 10 April 1856 and her name was Catharine D. Cloe. Her husband was married to Betsy Remington who died at Cynthiana many years ago. John Bruce resided since his discharge near Cordova, Grant Co., Ky., near Colemansville, Ky., and died near Colemansville 3 Oct. 1870.

24 May 1879. Pendleton Co., Ky. W. P. Cloe, aged 37, and H. W. Dunaway, aged 38, both of Colemansville, Ky, declare they were present when John Bruce died and assisted at his burial.

10 March 1879. Harrison Co., Ky. Wesley Howard and Permelia G. Howard state they saw Catharine D. Bruce (maiden name Cloe) and John Bruce married at Colemansville, Ky., 10 April 1856.

John Bruce was placed on the invalid pension roll under the Act of 24 April 1816 at \$5.33 1/3 per month to commence 27 March 1833 and raised to \$8 per month 20 May 1837.

Catharine D. Bruce was pensioned under the Act of 9 March 1878 and certificate 25857 was issued 14 July 1879.

Bounty land warrant 26890 for 80 acres was issued 16 Jan. 1852.

Bounty land warrant 36905 for 80 acres was issued 27 June 1856.

The Third Auditor reported John Bruce served in Capt. Memorial Forrest's Company, 16th Regiment, Kentucky Militia, from 10 Sept. 1814 for six months to 8 April 1815. The rolls afford no evidence of his having been injured. BRUER, Asahel (widow Mary A.). S.O. 24860, S.C. 18824; W.O. 41701, W.C. 32312; BLWt. 9994-40-50, 29964-120-55.

18 Nov. 1850. Champaign Co., Ill. Asahel Bruer of said county, aged 58, declares he was a private in the company of Capt. Richard Soward in the 3rd Regiment of Mounted Riflemen commanded by Governor Shelby of Kentucky. He volunteered at Newport, Ky., 28 Aug. 1813 for sixty days and served over two months and was discharged about 1 Nov. 1813.

11 April 1855. Champaign Co., Ill. Asahel Brewer (signed Bruer) of said county, aged 62, applies for additional bounty land.

9 Aug. 1871. Champaign Co., Ill. Asahel Bruer of Urbana in said county, aged 78, declares his wife's name was Martha Day. They were married in Bracken Co., Ky., 7 Sept. 1815. He was enrolled in Capt. Aaron Statton's (afterwards Richard Soward's) company of Col. Payne's regiment, Kentucky Volunteers, under Governor Shelby. He volunteered at Mason Co., Ky., 28 Aug. 1813 and was discharged at the mouth of Sandusky River on Lake Erie 1 Nov. 1813. He was called on by Governor Shelby of Kentucky to relieve Fort Meigs in the northern part of Ohio from a siege of the Indians under **Tecumseh** and the British under Generals Procter and Elliott. His regiment after Perry's victory on Lake Erie was fought was with other troops embarked upon the ships of Commodore Perry at the mouth of Sandusky and crossed into Canada where he participated in the battle where **Tecumseh** was slain. He saw the scalp of Tecumseh a few moments after his death and saw it cut into numerous fragments and divided among the Kentucky troops. After the battle his regiment returned to the mouth of Sandusky River and was discharged.

12 Nov. 1881. Champaign Co., Ill. Mary A. Bruer of Urbana, aged 54, declares she is the widow of Asahel Bruer. His description at enlistment was age 20, occupation farmer, born Mason Co., Ky., 17 Feb. 1793, height 5'8'', blue eyes, hair and complexion light. She was married in Champaign Co., Ill., 15 Aug. 1875 by W. T. Spruill, M. G., and her name was Mary A. Christie. Asahel Bruer was previously married to Martha Day 7 Sept. 1815; she died 18 July 1873. He died at Urbana, Ill., 14 Sept. 1881. He settled at Urbana about 1832 and she came to Urbana in 1869 and previously resided in New York City.

15 Aug. 1875. Champaign Co., Ill. Asahel Bruer and Miss Mary A. Christie were married by W. F. T. Spruill, M.G.

The Third Auditor reports Asahael Bruer served from 28 Aug. to 3 Nov. 1813 in Capt. Richard Soward's company.

Bounty land warrant 9994 for 40 acres was issued 20 June 1851.

War of 1812 Pension Applications

Bounty land warrant 29964 for 120 acres was issued 14 Nov. 1855. He was pensioned at \$8 per month from 5 Sept. 1872. The widow's pension was last paid to 4 Dec. 1883.

BRUFF, James. S.O. 17583, S.C. 11524; BLWt. 9038-160-50.

18 Dec. 1850. Union Co., Ill. James Bruff of said county, aged 57, a private in the company of Capt. Samuel Swearingen in the 19th Regiment, U.S. Infantry commanded by Lt.Col. Thomas B. V. Home, declares he volunteered at Kenawa [Kanawha] Salt Licks, Va., 13 July 1813, for twelve months, and was discharged at Lebanon, Ohio, 20 July 1814.

20 July 1814. Lebanon, [Ohio]. Tho. B. V. Home, Lieutenant Colonel, 19th U.S. Infantry, certifies James Bruff, private in the 19th Regiment, late 26th Regiment, enlisted for twelve months from 13 Jan. 1813 and is entitled to pay from 1 March 1814 to 13 July 1814. He has drawn short stockings, three pair shoes, one stock, five shirts, one pair woolen overalls, one vest, one coat, one cap complete, one linen jacket. He is $5'10\frac{1}{2}''$ high, dark eyes, dark hair, fair complexion, 21 years of age and a laborer when he enlisted. He is entitled to the usual allowance for travelling and subsistance from Lebanon, Ohio, the place of discharge, to the Kenawa [Kanawha] Salt Licks in Virginia, the place of enlistment.

22 July 1814. Cincinnati, Ohio. James Bruff gives receipt for his pay in full [endorsement on back of above].

The Third Auditor reports James Bruff served in Capt. Samuel Swearingen's company, 26th Regiment, U.S. Infantry, from 13 July 1813 to 28 Feb. 1814, 231 days.

Bounty land warrant 9038 for 160 acres was issued 8 Oct. 1851.

His pension was last paid to 4 Sept. 1883 and he was dropped because of death.

BROMFIELD, Micager (widow Ellender). W.O. 8693.

2 March 1872. Lawrence Co., Ky. Elendor (X) Brumfield of said county, aged 84, declares she is the widow of Micager Brumfield who was discharged at Norfolk, Va., in 1813. Her husband received a land warrant about 1852 [*sic*]. She was Elendor Clay and was married in 1803 at Taze [we]ll Co., Va., by Mr. Lockwood. Her husband died at Lawrence County 28 Nov. 1837. Her post office is Louisa, Ky.

Bounty land warrant 25690-160-50 was issued to Eleanor (maiden name Clay) widow of Micajah Brumfield, for his service in Capt. Preston's company, Virginia Militia, for about nine months in 1791, 1792 or 1793. Marriage was proven 15 Feb. 1802.

Pension application was rejected for want of evidence of service in the War of 1812.

John Allen. He volunteered at Richmond, Madison Co., Ky., in July 1812 for six months and was discharged at Urbana, Ohio, 20 Feb. 1813.

14 April 1855. Christian Co., Ky. Elijah Brummett of said county, aged 62, applies for additional bounty land.

1 Jan. 1856. Christian Co., Ky. Wilmoth(X) Brummett of said county, aged 38, applies for additional bounty land. She was married to Elijah Brummett in Christian County, 19 April 1832, by B. Ezell, a Baptist minister. Her name was Wilmoth Hill. Her husband died at home in Christian County 30 Oct. 1855.

19 April 1832. Christian Co., Ky. Elijah Brummett to Wilmouth Hill. License. No minister's return.

16 Sept. 1879. Christian Co., Ky. Wilmouth (X) Brummett of said county, aged 64, declares she is the widow of Elijah Brummett. She supposes her husband at enlistment was aged about 17 or 18 years, occupation a batter, born Virginia, height 5'10", hair dark, eyes blue, complexion fair. She was married to him near Bainbridge in Christian County, 19 April 1832, by Bailum Ezell, M.G. Her name was Wilmouth Hill. Her husband died in Christian County 30 Oct. 1855. After his discharge her husband settled in Kentucky and lived in Christian County from about 1825 until his death. She has lived near Bainbridge from her birth to the present time.

12 April 1887. Christian Co., Ky. W. T. Williamson of Hopkinsville, in the livery business, declares Mrs. Wilmouth Brummett died at her residence near Sinking Fork, 27 Sept. 1886, aged about 70, leaving no children surviving her.

The Third Auditor reports Elijah Brummett served in Capt. Kerby's Company, Kentucky Militia, from 15 Aug. 1812 to 7 May 1813.

Bounty land warrant 33202 for 80 acres was issued 1 April 1852.

Bounty land warrant 11816 for 80 acres was issued 16 Nov. 1855 but was cancelled.

Bounty land warrant 19851 for 80 acres was issued 25 Jan. 1856.

BRUSH, Israel. S.O. 11048, S.C. 16948; BLWt. 21911-160-50.

28 Nov. 1850. Clermont Co., Ohio. Israel Brush of said county, aged 56, declares he was a private in the Quarter Master General's Department commanded by Gen. Gardner at Franklinton, Ohio, and was engaged for six month in teaming with the understanding he was to

have credit for six months in military service. The service commenced about 18 Nov. 1812 and he continued until by exposure to the inclemency of winter he was so badly frozen as to be unable to do any service and was discharged at Franklinton. He returned home to Mason Co., Ky., where be volunteered or was hired. He was a private in the 1st Company commanded by Capt. Thomas McConnell of the 2nd Regiment of Col. H. Zumwalt, Ohio Militia, hired as a substitute for Thomas Sargent, and rendezvoused at Bethel (Dunamstown), Clermont County, 4 Sept. 1813 for six months. He marched from Bethel to Franklinton where orders were to detail two men from each company and attach them to the Quarter Master Department. He was one thus detailed from Company 1st and his father was the other. He served as a teamster until the expiration of his term and was discharged at Franklinton. He was also a private in the company of Capt. Joseph Logan in the regiment of Col. Porter of Kentucky Militia (he thinks 16th Regiment), hired as a substitute for John McGowen who was drafted in the company. They rendezvoused at Newport, Ky., about 10 April 1814 for six months, served six months and were discharged at Fort Malden about 10 March 1815.

28 Nov. 1850. Clermont Co., Ohio. William Lanham declares he was a private in the first company commanded by Capt. Thomas M. Connell of the 2nd Regiment of Col. Zumwalt of Ohio Militia, rendezvoused at Bethel, Ohio, and marched to Franklin Co., Ohio, where he knew Israel Brush was attached to the Quarter Master Department.

28 Nov. 1850. Clermont Co., Ohio. Jarad Brush declares he was in the Quarter Master Department at Franklinton, Ohio, for six months but was discharged before the expiration of the six months on account of disability. He was also a private in the company of Capt. Joseph Logan in the regiment of Col. Porter, commencing at Newport, Ky., 10 Sept. 1814 and was discharged at Malden about 10 March 1815.

5 Dec. 1851. Jared Brush, Felicity P.O., Clermont Co., Ohio, and Israel Brush write regarding their service in the War of 1812. They were substitutes for Enoch Ruggles and John McGowen.

18 April 1871. Clermont Co., Ohio. Israel Brush of Bethel P.O. in said county, aged 76, declares he married Mary Frazier in Hamilton Co., Ohio, 7 Oct. 1824. He volunteered in Capt. Stephen Smith's Company, Zumitt's [sic] Regiment, at Bethel in Oct. 1813 and was discharged at Franklinton, Ohio, 6 March 1814. In 1812 he served six months as teamster in Glascoe's Brigade, Kentucky Quarter Master Department, and volunteered again in 1813 as above stated and volunteered a third time in Capt. Logan's Company, Col. Porter's Regiment, Kentucky Volunteers. He was last paid pension to 4 Dec. 1881 and was dropped from the rolls in 1885 for failure to claim pension.

The Third Auditor reports service in Capt. Joseph Logan's Company, Kentucky Militia, from 9 Sept. 1814 to 9 March 1815.

BRUSH, Jared, widow Mary A., W.O. 25652, W.C. 19277; BLWt. 27127-80-50, 12123-80-55.

11 Dec. 1850. Clermont Co., Ohio Jared Brush of said county, aged 52, declares he engaged for four months with the understanding he was to have credit for a six month tour of military service and continued until he became so badly frozen he was unable to perform any service and was discharged. His service commenced in Mason Co., Ky., 17 Nov. 1812. He was a substitute for Enoch Ruggle who was drafted in the company of Joseph Logan of the 16th Regiment of Col. Andrew Porter, Kentucky Militia. The company rendezvoused at Newport, Ky., 10 Sept. 1814. He served six months and was discharged at Fort Malden 10 March 1815. They rebuilt Fort Malden. He recollects Adjutant James Newton.

8 Dec. 1850. Clermont Co., Ohio. Israel Brush attests to the statements of Jared Brush relative to his service in the Quarter Master Department.

11 April 1855. Clermont Co., Ohio. Jared Brush of said county, aged 56, applies for additional bounty land.

31 May 1878. Clermont Co., Ohio. Mary A. Brush of said county, aged 56, declares she is the widow of Jared Brush who was a private in the company of Capt. Logan under Majors Kennedy and Thrasher of the Kentucky Militia, under Col. Sewmalt [*sic*]. She cannot give a full description of her husband at the time of his enlistment since she was not then born. She was married in Clermont County 29 Oct. 1844 by Rev. Vincent — [blank], M.G. Her name was Mary Ann Carr. Her husband died at his home in Clermont County 20 Dec. 1868, aged 71. She has lived no other place than Clermont County before or since her marriage.

The widow was pensioned at \$8 per month from 11 Feb. 1879. She died 14 July 1907. G. A. Wolf of Mount Washington, Ohio, was her administrator.

Bounty land warrant 27127 for 80 acres was issued 14 Jan. 1852. Bounty land warrant 12123 for 80 acres was issued 13 Nov. 1855.

BOOK REVIEWS

INDEX TO THE VIRGINIA GENEALOGIST, VOLUMES 1 – 20, 1957 – 1976. John Frederick Dorman, compiler. 1981. 941 pp. \$40.00 Order from Genealogical Books in Print, 6818 Lois Drive, Springfield, Virginia 22150.

Of all finding aids the most welcome is a carefully prepared cumulative index. All too many genealogical journals are produced haphazardly with no index whatever. From its inception *The Virginia Genealogist* has provided a full name and subject index annually. Now in its twenty-eighth volume, *The Virginia Genealogist* ranks in the forefront of state genealogical journals with an outstanding record for publishing primary source material and compiled genealogies for Virginia. It has become a pricnipal research source for genealogists and historians.

While the annual indexes have been a great help for quick location of specific references, they require an individual search through each year's index. Now in one book the first twenty volumes can be searched conveniently for a specific reference, saving time and effort.

Mr. Dorman is without question one of the finest genealogists ever developed in the United States and the leading modern authority on Virginia. Over the years he has produced a remarkable number of record abstracts for Virginia counties, complied genealogies of individual families, scores of articles and has established *The Virginia Genealogist*. His diligence and willingness to create worthwhile reference sources is nowhere more evident than in this painstakingly produced volume.

Genealogical Books in Print deserves great praise for publishing this valuable book. No one working on Virginia and Kentucky families can afford to overlook it. It is essential for genealogical and historical libraries, who will find it used heavily by their patrons. We cannot commend this superb work too highly.

THOMAS STONESTREET OF BIRCHDEN, WITHYHAM, EAST SUSSEX, AND OF "BIRCHDEN" IN CHARLES COUNTY, MARY-LAND, WITH HIS POSTERITY DOWN TO THE SIXTH GEN-ERATION. Warren Skidmore. 1983. 119 pp. \$25. Order from the author, 171 Goodhue Drive, Akron, Ohio 44313.

The Stonestreet family is thoroughly traced in this well-researched genealogy. The unusual name aided Mr. Skidmore in his work. The family tended to be landed and prosperous, which provided good records to follow. Branches settled in Virginia, North Carolina, Ohio, Indiana, and Illinois. Several descendants settled in Kentucky, locating in Jefferson, Oldham, Jessamine and Owen counties.

Mr. Skidmore provides biographical accounts of the family members with full footnote citations to sources. He properly states when facts are not known. Appendices containing full accounts of Stonestreet records in Sussex, England are provided as is a listing of unplaced persons named Stonestreet. A thorough name index is included.

The one jarring error is the constant spelling "Farquier" for Fauquier County, Virginia.

Stonestreet descendants will find this a dependable book and should acquire a copy as it is limited to a hundred copies. Libraries collecting histories of individual families will not regret buying this book.

The availability of these fundamental records for Estill, Madison and Rockcastle Counties is most welcome. Little is in print for the eastern counties of Estill and Rockcastle and those with research interests there will be grateful to have access to these helpful sources. Madison is a large and populous county always popular with Kentucky researchers so the volumes dealing with Madison should be widely appreciated. The abstracts of early Madison County wills and appraisements should be of particular interest as a quick indexed guide to these important records. All names mentioned and all places of land holdings are listed. It provides valuable research information and clues for further research. The original pages in the manuscript are cited, which allows access to the full source record.

Researchers will want to consult these sources and genealogical collections in libraries will find them of interest to their patrons.

VIRGINIA GENEALOGICAL RESEARCH. George K. Schweitzer. 1982. 187 pp. \$9.00. Order from the author, 7914 Gleason, C-1136, Knoxville, Tennessee 37919.

Since Kentucky was part of Virginia until 1792 and because ties between the two states remained strong thereafter, researchers concerned with Kentucky families must also be interested in Virginia records as the origin of many Kentucky settlers is in Virginia.

Dr. Schweitzer has prepared a series of very good manuals for special research areas. His latest covers the Commonwealth of Virginia. The first chapter provides an historical overview of Virginia from its founding to modern times since good genealogical research requires an understanding of the history of the area covered. He clearly shows the differentiation in Virginia between the counties and the independent cities, several of which have now absorbed their parent counties. The geography of the state is described with an accompanying map. Virginia's geography has been important in determining settlement patterns and the various areas have distinct names, such as the Northern Neck, Southside, Middle Peninsula, etc.

The second chapter describes the various types of records both public and private. Included here are sections on vital records, cemeteries, Bibles, churches, printed county histories, city directories, periodicals, military records, atlases, newspapers and county records. A discussion of record locations is given in the third chapter. This covers courthouses, major libraries, regional libraries and collections outside Virginia. The last chapter covers each county alphabetically and lists the county seat, date of formation with parent counties and a citation to the discussion of that county in *The Virginia Genealogist* series on Virginia counties. Surviving records with dates are listed for court houses, other record repositories and libraries. Societies are listed with addresses. Printed county histories are cited with bibliographical details.

As with all Dr. Schweitzer's books, extensive bibliographies are provided for further research. This is always a most helpful feature.

We recommend this manual highly as a helpful aid for Virginia research and one you will want to consult frequently.

FEDERAL CENSUS WASHINGTON COUNTY, KENTUCKY 1850. Faye Sea Sanders. 1982. 103 pp. \$12.00. Order from the compiler, 311 Sage Road, Louisville, Kentucky 40207.

Once more Mrs. Sanders has brought to us a valuable record for Washington County. She has wisely transcribed the document in its original order so that whatever value the location of households and

method of enumeration holds is not lost. The 1850 census is the first to list all people by full name, age, gender, occupation and state of birth. So it is a very valuable and much consulted genealogical source.

A full name index is supplied for quick access to the transcription. The text is clear and Mrs. Sanders' by now great familiarity with the families of this old county give assurance of accurate transcription.

Obviously this is a source of the greatest interest for Washington County research. It deserves a place in every genealogical library with a Kentucky holding of any consequence and its moderate price makes is available to the individual researcher.

FEDERAL CENSUS MERCER COUNTY, KENTUCKY 1850. Faye Sea Sanders. 1983. 131 pp. \$13.00. Order from the compiler, 311 Sage Road, Louisville, Kentucky 40207.

Located in central Kentucky, Mercer County is full of history. Kentucky's oldest settlement, Harrodsburg, is the county seat and it was here that the famous colony of Shakers at Pleasant Hill was established. Due to the county's age and fame, this record holds special interest and we are glad to have it available for easy reference.

The census has been literally transcribed as it exists in manuscript form and fully indexed by each name.

Mrs. Sanders is to be commended for her most diligent work in transcribing early Kentucky records and making them available to a wide public. This is tedious, time-consuming and thankless work. We are greatly in her debt and the editor wishes to thank her for her tireless labor to preserve our irreplaceable past.

We recommend this work to the attention of researchers and to all diligent librarians.

THE SOUTHSIDE VIRGINIAN. Lyndon H. Hart and J. Christian Kolbe, editors. Quarterly. \$16.00 per annum. Order from Box 118, Richmond, Virginia 23201.

This is a welcome and promising addition to the ranks of independent genealogical periodicals. The original colonies are always of great interest to genealogists. Since it was the most populous colony, Virginia holds a special interest for researchers and because it was Kentucky's parent, Kentucky research is closely connected with the Old Dominion.

The Southside is that area of Virginia bordering North Carolina and lying below the James River. It includes the counties of Princess Anne, Norfolk, Nansemond, Isle of Wight, Southampton, Surry, Sussex, Prince George, Chesterfield, Dinwiddie, Powhatan, Greensville, Amelia, Nottoway, Brunswick, Cumberland, Prince Edward, Mecklenburg, Charlotte, Halifax, Henry and Pittsylvania. Many settlers of Kentucky originated in this section of Virginia.

The first three issues contain a variety of records for many of the counties covered, including will book abstracts, tithable lists, family cemeteries, powers of attorney, church records, indentures, marriages, militia fines, guardian bonds, Bible records and brief accounts of individual families.

Each issue contains forty-eight pages. The text is printed by offset from typed copy. We hope an annual index will be included to enhance the reference value of the journal.

Those with an interest in Southside Virginia will find this new journal worthy of their support. It is reasonably priced.

WAR OF 1812 GENEALOGY. George K. Schweitzer. 1983. 69 pp. \$7.00. Order from the author, 7914 Gleason Road, C-1136, Knoxville, Tennessee 37919.

Dr. Schweitzer has once again issued a specialized genealogical research guide providing valuable information. This booklet is concerned entirely with locating data on ancestors who served in the War of 1812.

Following his usual format, Dr. Schweitzer begins with a concise historical discussion of the War of 1812, which provides a chronological history of the battles, a discussion of causes, maps and a brief bibliography. Original record sources available for research and providing documentation of service are discussed and located. Particular emphasis is given to records at the National Archives and state archives, but information on other record sources and printed primary materials is also provided. A listing of principal surviving sites ends the text.

As with all Dr. Schweitzer's works, this is a very helpful treatment and should be consulted by those researching the period of the War of 1812. Since so many Kentuckians participated significantly in the conflict, it should be especially interesting to readers of *The Kentucky Genealogist*.
