These random notes were gathered in the course of research and reading for a planned volume concerning *The Battles and Massacre on River Raisin, January* 18-23, 1813. The absence of even partial rosters of troops who served at Raisin prompted a search for participants in the two battles and at the massacre.

Sources generally were newspaper files owned by the Society, county pension lists, county histories and contributed cemetery and other local records. Newspaper accounts of the annual reunions held by the veterans at Paris, Kentucky, were read for names of veterans attending. These reunions were inaugurated in 1866 and held annually until 1883 or 1884. At the 1883 meeting, the 8 old soldiers attending voted one more reunion, to be held June 18, 1884. No account of this reunion was found and it is possible that the last was held in 1883. Oddly, at the 1877 reunion 39 of the veterans attended and 39 deaths were reported; at the 1878 meeting, 25 met and 25 were reported dead; the 1880 reunion saw 15 answer roll call, and the historian announced 15 dead; 12 met for the 1881 meeting, and again 12 were reported dead since the last gathering.

No concerted attempt was made to authenticate the soldier's organizational unit and time of service. A listing from the Adjutant General's report of Kentuckians in the War of 1812 was given, however, when it was apparent that reasonable accuracy could be maintained.

An explanation of the abbreviations used follows the last entry.

ADAMS, ELISHA. One of the last three veterans; living in Lincoln County in Sept., 1879. Yeoman, 16 Sept. 1879. AG: Pvt., Capt. James S. Wade's Co., 7th Regt., U. S. Inf.

ADAMS, WILLIAM. Fayette and Harrison counties. Enlisted at Georgetown in Aug., 1812; also served in the Revolution; received pension No. S-6464. Harrison County Pension List.

ADAMS, WILLIAM. Mt. Vernon, Ky. Pvt., Capt. Ellis' (later Richard Matson's) Co., Aug. 15-Oct. 15, 1812; married Rebecca Lawrence, b. 1784-d. 1844. NSUSD 1812, Ohio, No. 9917.

ADAMSON, GEORGE. Mason County. Attended 11th annual reunion, 1876, aged 85. Yeoman, 24 June 1876; TK, 21 June 1876. AG: Pvt., Capt. John Dowden's Co., Pogue's Regt., KM.

AKERS, LARKIN (N. or H.) Jessamine County. Ensign, Capt. Thomas Lewis' Co., KM, commanded by Col. William Dudley: WIA at Dudley's Defeat, 5 May 1813; resident of Muhlenberg County in 1854. Christian County Pension List.

ALLEN, GEN. JAMES. Greensburg, Ky. Born Apr., 1770, Albermarle Co., Va.; officer War of 1812; killed by a fall from his horse 25 Nov. 1836. OR, 14 Dec. 1836; C, 7 Dec. 1836.

ALLEN, JOHN. Mason County. Born 9 Oct. 1771, on the ship *Partless*, while his parents were coming from England; remembered the Revolution and was a soldier in 1812; also recollected having seen General Washington and hearing him converse. *TK*, 22 Mar. 1876.

ALLEN, CAPT. JOSEPH. Hardinsburg, Ky. Born 20 Sept. 1774; his father emigrated to Kentucky about 1780, remaining a short time in the fort at Danville. "That place becoming too straight for him, he, together with Mr. Daviess (father of the celebrated Jo. H. Daviess) put up a couple of log cabins three or four miles from the fort, where they lived for some years." Capt. Allen went to Breckinridge County when it was almost a wilderness, was elected Clerk of the County Court in 1800 and held the office for 56 years. In the war of 1812 "he was active in raising volunteers, and in keeping with his character, put his own person in the fore front of the peril." He died at Hardinsburg, 23 April 1862. C, 7 May 1862.

ALLEN, M. W. Scott County. Attended 6th annual reunion, 1871, aged 81. C, 7 July 1871. Not in AG under these initials.

ALLEN, WILLIAM W. Franklin County. Attended 8th annual reunion, 1873, aged 82; 11th reunion, 1876, aged 85. WC, 24 June 1873; Yoeman, 24 June 1876; TK, 21 June 1876. AG: Pvt., Capt. Joseph Clark's Co., 3rd Regt., KMV.

AMMERMEN, ALBERT. Pendleton County. Pvt., Capt. Michael Glaves' Co., 1st Regt., KVM; WIA Jan. 18, 1813, at Frenchtown; moved from Kentucky to Adams County, Illinois, in Sept., 1835; placed on Kentucky pension rolls, 30 Nov. 1820. Pendleton County Pensions; Sen. Doc. 514.

ANDERSON, JOHN. Christian County. One of 150 picked Kentucky volunteers who fought with Perry on Lake Erie; assigned to the *Niagara*. Not listed in U. S. War Dept. list of these "Horse Marines." Perrin, W. H., *History of Christian County*... 1884, p. 171.

ANDERSON, OLIVER. Jessamine County. Born in Jessamine County [sic] 18 Feb. 1794; "he enlisted in the army which marched from Kentucky in 1813 to the relief of the Northwestern frontier and was present at several battles . . . and was wounded and taken prisoner at River Raisin." He died in Lexington in Jan., 1873. Yoeman, 6 Feb. 1873. AG: Pvt., Capt. Patrick Gray's Co., Lewis' Regt., KVM.

ANDREWS, ABRAM M. Fayette County. "An old soldier of 1812; died in Fayette County, 10 Aug. 1875, aged 81 years; he was father-in-law of A. H. Sidener. He was buried at Old Union." TK, 11 Aug. 1875; C, 7 July 1871; WC, 24 June 1873.

ARCHER, MOSES. Pvt., Capt. Doherty's Co., 7th Regt., U. S. Inf.; enlisted from Adams Co., Miss., 1 Dec. 1811; injured; discharged 25 Dec. 1812 at New Orleans; married Mary Clark, 21 Apr. 1841. He died 18 Mar. 1846 in Polk Co., Mo. Caldwell County (Ky.) Pension List.

ARMSTRONG, BENJAMIN. Hopkins County. "He was a soldier of 1812, and was with 'Old Hickory' at the battle of New Orleans on the 8th of January, 1815, and from that time until the period of his death he never failed to observe, in his quiet and unobtrusive way, the 8th day of January; and at the close of the 8th day of January, 1873, he calmly breathed his last." Yeoman, 15 Feb. 1873. AG: Pvt., Capt. Robert Thruston's Co., KDM, 10 Nov. 1814-10 May 1815.

ARMSTRONG, JAMES R. Boyle County. Born in Penna., 1787; attended the 1870 and 1871 annual reunions. *TK*, 22 June 1870; *C*, 7 July 1871. AG: Pvt., Capt. George Trotter's Co., 1st Regt., Ky. Light Dragoons.

ARMSTRONG, THOMAS. Franklin County. Pvt., Capt. Peter Dudley's Co.; POW at the Rapids, 1813. Argus, 12 Feb. 1814.

ARMSTRONG, WILLIAM. Bourbon County. Pvt., Capt. Maurice Langhorne's Co.; married Mary Wilson, in Harrison Co., 31 Jan. 1816; living in Scott County when placed on pension roll, 10 Oct. 1821. He died 16 Oct. 1831. Scott County Pension List; Sen. Doc. 514.

ARTUS, JAMES. Another who fought with Perry on Lake Erie. Yeoman, 11 Jan. 1879. AG: 4th Sgt., Capt. John Payne's Co., Ky. Light Dragoons.

ASBURY, HENRY. Jefferson County. Pvt., Capt. William Walker's Co.; enlisted 1 Sept. 1812; discharged 25 Dec. 1812; he lived later in Highland Co., Ohio, and in Madison Co., Ohio. Jefferson County Pensions.

BAILEY, ABRAM. Daviess County. Attended 10th annual reunion, 1875, aged 80. Yeoman, 26 June 1875. Not in AG.

BAKER, JOHN. Fayette County. Enlisted 1813 as a regular, for 5 years, in Capt. Caleb Holder's Co., 17th Regt.; married Cynthia Hutchinson, in Madison County, 30 Apr. 1817. He died at Lexington, 22 Oct. 1856. Issue: Surilda Baker; Palina Baker, b. 9 May 1842; Ellen Baker. Fayette County Pension List.

BAKER, JONATHAN. Clark County. Born in Clark, 1794; attended reunion of 1870. TK, 22 June 1870. AG; Pvt., Capt. John H. Morris' Co., KMVM.

BAKER, COL. JOSHUA. Mason County. Born 11 Mar. 1763, Frederick Co., Va.; married Mason Co., Ky., 9 June 1790, Susannah Lewis (9-13-1768 - 11-24-1813). He was at Strode's Station at the time of the siege, 1 Mar. 1781. "This distinguished patriot commanded a regiment in 1815 at New Orleans. He died at Nashville, Tenn., in April, 1816. Lexington Reporter, 10 Apr. 1816. Col. Baker was actively identified with the early military history of Mason County.

BAKER, OBEDIAH. Cumberland County. "He was a volunteer in the last war in Gen. King's Brigade, though past the age for military duty. He died 19 May 1839, at an advanced age." C, 28 May 1839. AG: Pvt., Capt. Samuel Wilson's Co., KMVM.

BALL, LEWIS H. Nicholas County. Attended 8th annual reunion, 1873, aged 80; also reunions of 1875 and 1876. Yeoman, 26 June 1875; WC, 24 June 1873; TK, 21 June 1876.

BANTA, PETER. Bourbon County. Attended annual reunions of 1871, age 80; 1873, 1874; died 22 Mar. 1875, aged 83. C, 7 July 1871; WC, 24 June 1873; Yeoman, 27 June 1874, 26 June 1876. AG: Pvt., William M. Rice's Co., KMV.

BARKER, JUDGE THOMAS. Bourbon County. Born there 10 Jan. 1795; married, 1818, Frances Dawson, "who yet lingers at death's door;" removed to Missouri, 15 Oct. 1838, resided in Monroe County until his death, 20 Feb. 1875. He was a Whig and Union man, but Democrat after the war. He was a noted short horn trader; member of the Christian church for 30 years, and buried by the

Masons. His home was near Paris, Mo. TK, 3 Mar. 1875, which states that "he was a soldier in 1812, and served faithfully."

BAY, JOSEPH. Montgomery County. Born in Pendleton Co. [sic]; Pvt., Capt. Thomas Morris' Co.; applied for pension while living in Montgomery County, 3 Apr. 1833, aged 66 years. *Montgomery County Pension List.* He was placed on the pension roll before, 29 Dec. 1820. Sen. Doc. 514.

BEALL, LEONARD. Winchester, Ky. Attended annual reunions of 1871, aged 75; 1873-1875 and 1876. C, 7 July 1871; WC, 24 June 1873; Yeoman, 27 June 1874; TK, 21 June 1876. Not in AG. Two Leonard Ball entries.

BEALMEAR, DANIEL V. Crittenden County. Cpl., Capt. Robinson's Co., 7th U. S. Inf.; enlisted 15 Apr. 1814; WIA. Union County Pensions.

BEAN, JOHN AUGUSTUS. Mason County. Born in Charles Co., Md., 5 Mar. 1792, son of Leonard Bean, a revolutionary soldier; they came to Mason County in 1806. "John A. Bean enlisted in Capt. Moses Dimmett's Co." He died in Aug., 1879. Yeoman, 12 Aug. 1879. Not in AG, Demmitt's Co.

BEARD, HENRY. Fayette County. "Served in the 42nd Regt.; died 17 Mar. 1838, at an advanced age." KG, 22 Mar. 1838. AG: Pvt., Capt. N. G. S. Hart's Co., Lewis' Regt.

BEATTY, JAMES. Fayette County. Attended 8th annual reunion, 1873, aged 79. WC, 24 June 1873.

BELL, THOMAS. Franklin County. A volunteer in Capt. Thomas Morris' Co.; injured about 1 Jan. 1813 (right arm dislocated). He also served three years in the American Revolution. Franklin County Pension List.

BELL, WILLIAM. Bourbon County. Served in Capt. Maurice Langhorne's Co.; was living in Henry Co., Ind., 1821 or 1822. Scott County Pension List.

BELT, DENNIS. Pvt., Capt. George Stockton's Co.; served in Capt. Holme's Co., 28th Regt., U. S. Inf., when wounded in action 4 Mar. 1814. Fleming County Pension List.

BENNETT, DR. JOHN. Covington, Ky. A successful practitioner at different times in Cynthiana, Falmouth, Newport and Covington. In 1813 he entered the army under the appointment of Assistant Surgeon; 1841, elected to Kentucky Senate; died at the Covington residence of Mr. H. B. Clemons, 31 Jan. 1847, aged 53. C, 10 Feb. 1847. AG: Surgeon's Mate, Williams' Regt., KVM, commanded by Col. William Williams.

BERRY, COL. ROBERT. Nicholas County. "He was a native of Virginia and one of the early pioneers of Kentucky; engaged in almost all of the campaigns against the Indians and was out three times as captain of a company in 1812. A

braver man, or a better soldier never faced an enemy. On one occasion he, alone, took 17 British soldiers prisoners." He died 10 Feb. 1850, aged 82. C, 26 Feb. 1850. AG: Capt., Lt. Col. James Allen's Regt., 18 Sept.-30 Oct. 1812; Capt., Col. Richard M. Johnson's Regt., 20 May-19 Nov. 1813.

BERRY, S. M. Scott County. Attended annual reunions of 1876, aged 80; 1881 and 1883. Yeoman, 24 June 1876, 20 June 1881, 21 June 1883.

BERRY, WILLIAM. Living in Owen County when he applied for pension, 5 Oct. 1866, aged 80 years; married Sally Dawson, Owen County, 4 June 1848. He was charged with disloyalty and his pension suspended because he was said to be in favor of the seceded states. Scott County Pension List.

BERRY, WILLIAM C. Clark County. Veteran of 1812 who died between June, 1870, and June, 1871, annual reunions. C, 7 July 1871.

BICKNALL, LINSFIELD. Estill County. Pvt., Capt. Leslie Comb's Spies, 2 June-29 Sept. 1813; Pvt., in same, 17 Apr.-3 June, 1813; pensioned 28 July 1820. Sen. Doc. 514.

BINGHAM, ISAAC. Madison County. Pvt., Capt. Christopher Irvine's (James Dyametto's) Co. POW at the Rapids, 1813. Argus, 12 Feb. 1814.

BLAKE, GEORGE. Carlisle, Ky. Attended annual reunions of 1873, aged 79; 1874-1876. WC, 24 June 1873; Yeoman, 27 June 1874, 26 June 1875; TK, 21 June 1876.

BOSTON, CAPT. JOHNNY. Woodford County. "A soldier of 1812. Died 13 Jan. 1875, aged 93 years." TK, 20 Jan. 1875; Yeoman, 26 June 1875.

BOURNE, WALKER. Montgomery County. Born 5 May 1790, Culpepper Co., Va.; emigrated to Kentucky when 7 years old with father, James Bourne, a Revolutionary soldier; magistrate of Montgomery County for many years and at one time sheriff; served at the battle of the Thames; he was a teacher of note and one of his pupils was Richard Menifee, under whom Bourne served in 1812. He died 6 Feb. 1873. Reid, Richard, Historical sketches of Montgomery County, 1926, p. 64-5.

BOWMAN, WILLIAM. Woodford County. Died in October, 1875. His death was reported at the 1876 annual reunion in "Deaths of soldiers of the War of 1812 since June 18th, 1875." TK, 21 June 1876.

BOWMAR, JAMES H. Served in Capt. McCracken's Co., KVM. Died about 1 Dec. 1812 at Fort Defiance. *Palladium*, 10 Feb. 1813, with poem by friend.

BOYD, A. Harrison County. Attended 8th annual reunion, 1873, aged 81. WC, 24 June 1873.

BOYD, MAJOR WILLIAM. Bath County. Born 1796; died 30 Mar. 1881. "He was a drummer in Col. Owen's Regt., War of 1812." Yeoman, 5 Apr. 1881.

BRADFORD, CHARLES. Fayette County. Cpl., Capt. Nathaniel Hart's Co., at River Raisin; WIA, Jan. 18, 1813; POW, Jan. 22, 1813; pensioned 29 Dec. 1820; died 1 Sept. 1822. Fayette County Pension List; Sen. Doc. 514.

BRANHAM, CAPT. BENJAMIN. Scott County. Died at New Castle, of cholera, July, 1833. OR, 7 Aug. 1833. One of this name was Captain of a company, KMI, commanded by Col. Richard M. Johnson, 20 May-15 Aug. 1813.

BRANHAM, STANDFORD. Scott County. One of the veterans reported as having died between June, 1870, and June, 1871, annual reunions. C, 7 July 1871. Sanford Branham listed in AG as serving in Capt. John Duvall's Co., KDM.

BRENAUGH, THOMAS. Lincoln County, Pvt., Capt. Armstrong Keir's Co.; POW at the Rapids [Dudley's Defeat]. Argus, 12 Feb. 1814.

BREST, JOHN, JR. Garrard County. Entered service as Pvt., 1 Feb. 1813, Capt. William Garrard's Co., Vol. Light Dragoons; WIA 30 Apr. 1813 at Fort Meigs. He applied for a new pension certificate, to replace one lost, 17 Feb. 1865, at Xenia, Ohio. Bourbon County Pension List.

BRIEN, JAMES. Marshall County. "A resident of the Purchase for 55 years, a soldier of the War of 1812, one of the oldest and most consistent Democrats in Kentucky. Died Apr. or May, 1875, aged 83 years." TK 19 May 1875. Probably the James Brian listed in AG.

BRITTAIN, GEN. GEORGE. Harlan County. An early settler of Kentucky; served with the 54th Regt. (Knox County) during the war; died in Nov., 1850, aged 83. C, 22 Nov. 1850.

BRITTAIN, WILLIAM. Mason County. Pvt., Capt. John Baker's Co.; served with distinction at the two sieges of Fort Meigs. Died 2 Mar. 1876, aged about 84. TK, 15 Mar. 1876.

BROWN, HENRY. Pvt., Capt. Adair's Co., 17th Regt., U. S. Inf.; enlisted 25 Apr. 1814 and died in service 11 Jan. 1815. Wayne County Pension List.

BROWN, IRWIN. Pvt., Cpt. William Ellis's (Richard Matson's) Company of Kentucky Rifles; placed on pension rolls 8 Dec. 1825; died 8 March 1826. Sen. Doc. 514.

BROWN, JOHN. Born in Ireland; enlisted 23 July 1813 in 23rd Regt., U.S. Army; a shoemaker. Woodford County Pension List.

BROWN, SAMUEL. Floyd County. Enlisted May or June, 1813, in Capt. Charles Quary's (?) Co.; WIA; discharged in 1815. Floyd County Pension List.

BROWN, SCOTT. Franklin County. Emigrated from Virginia, 1790; for many years a magistrate of the county and for two years sheriff; "volunteered

in the late war when nearly 50 years old, marched to the frontier and ventured his life to protect his country;" died at his home four miles above Frankfort, near the Kentucky River, 3 June 1842, in his 77th year. C, 14 June 1842.

BROWN, WILLIAM. Pvt., Capt. Gray's Co., 3rd Regt., U. S. Inf.; injure... 27 Oct. 1817. Christian County Pensions.

BRUCE, ELI. Winchester, Ky. Attended 9th annual reunion, 1874, aged 79; died in Feb., 1876, aged 81. Yeoman, 27 June 1874; TK, 21 June 1876. AG: Pvt., Capt. James Sympson's Co., 5th Mounted Vol. Inf., 20 Sept.-20 Nov., 1814.

BRUCE, JOHN. Harrison County. Pvt., Capt. Thompson Ward's Co., Pogue's Regt.; pensioned 21 May 1833. Sen. Doc. 514.

BUCKNER, GEORGE. "An old citizen of Lexington and soldier of 1812; died at Lexington, Missouri, 17 Jan. 1871; father of William Buckner who resides with his brother-in-law, Asa Bean." TK, 1 Feb. 1871. AG: Pvt., Capt. John Edmiston's Co., 1st Rifle Regt., 15 Aug.-14 Oct. 1812.

BULLOCK, JAMES P. Clark County. For many years Clerk of the County Court. "In early manhood he volunteered in Capt. Clark's Co., from Clark County, in the War of 1812, and was terribly wounded in the engagement of Dudley's Defeat, from the effects of which he never fully recovered and which finally caused his death." Died in Sumner Co., Tenn., 2 Feb. 1858. C, 5 Mar. 1858. AG: Pvt., Capt. Joseph Clark's Co., KM., 4 Mar.-4 Sept., 1813.

BUSEY, ARTHUR. Shelby County. Attended 10th annual reunion, 1875, age 79. Yeoman, 26 June 1875. AG: Pvt., Capt. James Ford's Co., KDM., 10 Nov. 1814-10 May 1815.

BUSH, NELSON. Clark County. Attended 6th annual reunion, 1871; 8th, 1873; died 3 Oct. 1874, aged 84. C, 7 July 1871; WC, 24 June 1873; Yeoman, 26 June 1875. AG: 1st Cpl., Capt. Joseph Clark's Co., KDM., Mar.-4 Sept. 1813.

BUSH, COL. PLESANT. Clark County. Died Sept. 9, 1853. (Lexington, Ky.) Statesman, 13 Sept. 1853. AG: Ensign, Capt. James Sympson's Co., KMVM., 26 Aug.-5 Nov. 1813.

BUTLER, COL. ANTHONY. Logan County. "Born in South Carolina about 1774; as a lawyer and statesman he stood high in the confidence of Gen. Sumpter and patriots of the Revolutionary era; in 1807 he removed to Logan County, where he served as President of the Branch Bank at Russellville;" appointed Lt. Col., 28th Inf., U. S., 11 Mar. 1813; Col., 2nd Rifle, 21 Feb. 1814; discharged 15 June 1815; when victory was won in the Northwest he was placed in command at Detroit, Malden and Sandwich; after returning to private life he represented Logan County in the Legislature, 1818-19; in 1820 he was defeated by John Adair for the governorship; he had moved to Monticello, Miss.,

by the end of 1824. Argus, 20 April 1820; Heitman, v. 2, p. 268; Draper MMS.

CALMES, GEN. MARQUIS. Woodford County. "Served in the Revolution and in the War of 1812; died 27 Feb. 1834." OR, 6 Mar. 1834. Not in AG.

CALVERT, WILLIS. Boone County. Entered service 15 Aug. 1812, Pvt., Capt. John Hamilton's Co., Lewis' Regt.; WIA, 18 Jan. 1813; POW, 22 Jan. 1813; married 14 Feb. 1828, Rebecca A. He died 15 June 1849 at Nashville, Tenn. Boone County Pension List.

CAMPBELL, JOHN. Mason County. Born there; enlisted there, 1812, as rifleman; 1st Sgt., Capt. Henry R. Graham's Co., 1st U. S. Rifles; discharged at Newark, 6 Nov. 1813, because of wounds. Later lived in Madison and Lincoln Counties. Mason County Pension List; Madison County Pension List.

CAMPBELL, LT. COL. JOHN B. Of 11th Regt., U. S. Army; died at Williamsville, 28 Aug. 1814, of wounds received at the battle of Chippewa (5 July 1814). KG, 19 Sept. 1814.

CAMPBELL, ROBERT M. Clark County. Born Mercer County, 1793; attended annual reunions of 1871, 1873, 1875 (from Fayette Co.) 1876, 1883 (from Winchester, Ky.) aged 90 years. C, 7 July 1871; TK, 22 June 1870, 21 June 1876; Yeoman, 26 June 1875, 21 June 1883; WC, 24 June 1873. AG; Pvt., Capt. Abraham S. Drake's Co., KVM, 8 Feb. 1814-8 Aug., 1815.

CARLISLE, ROBERT. Fayette County. Attended 8th annual reunion, 1873, aged 78. WC, 24 June 1873.

CARRICK, ROBERT. Scott County. Born Penna., 1795; attended reunions of 1871, aged 77; 1875-6 (from Fayette County). TK, 22 June 1870, 21 June 1876; C, 7 July 1871; Yeoman, 26 June 1875.

CARTER, WILLIAM. Pvt., Capt. Lynn West's Co.; placed on pension rolls, 1816, 1824, 1833. Sen. Doc. 514.

CARVER, BILLY. Gallatin County. "Uncle Billy Carver, a pensioner of 1812, is 83 years old, yet as full of fun as a dog is of fleas." TK, 22 Mar. 1876.

CASE, JOSEPH. Bourbon County. Born there, 30 Aug. 1791 (same year and month in which his wife was born); soldier War of 1812, served as a spy; died 25 Mar. 1870. aged 79 years. TK, 30 Mar. 1870.

CASEY, THOMAS. Falmouth and Pendleton County. Attended annual reunions of 1873, aged 76; 1874-76. WC, 24 June 1873, Yeoman, 27 June 1874, 26 June 1875, 24 June 1876.

CAWTHON, (CORTHRAM), ELEAZER. Madison County. Pvt., Capt. Dudley Farris' Co.; POW at the Rapids, 1813. Argus, 12 Feb. 1814.

CHAMBERLIN, THOMAS. Fayette County. Cpl., Sgt., in Capt. Nathaniel

Hart's Co., 14 Aug. 1812-10 Mar. 1813; in battles of Jan. 18 and 22, 1813; WIA, Jan. 22, POW Jan. 22 or 23, 1813; returned from captivity in Mar., 1813; pensioned 4 June 1833. Fayette County Pension List; Sen. Doc. 514.

CHAMBERS, MAJ. BENJAMIN S. Scott County. Lived at Georgetown; removed to Little Rock, Ark., where he died 14 Oct. 1833, leaving his wife and six small children, all daughters. Benjamin Stuart Chambers was an officer in 1812, member of Col. William Whitley's "Forlorn Hope," member of the Legislature and clerk of the Scott Circuit Court. OR, 31 Oct. 1833; C, 12 Nov. 1833. AG: Quartermaster, Col. Richard M. Johnson's Regt., KMI, 20 May-19 Nov. 1813.

CHAMBERS, GEN. GEORGE. Louisville, Ky. Born 1793; his death was announced at the annual reunion of June, 1875, as one of 19 old soldiers who had died since the 1874 reunion. He was a son of Dr. James Chambers, who was killed in a duel with John Rowan, at Bardstown, 3 Feb. 1801. His mother was Jude, a daughter of Judge Benjamin Sebastian. His father, Dr. James, was a colonel in the American Revolution, the son a volunteer in 1812. "Judge for twenty years without intermission, of the thousands of cases litigated before him not one was ever reversed by the Court of Appeals. When only 15 years of age he could split rails at the rate of 100 per day. He first learned the hat business, then studied law. He was married three times. He had a beautiful female child born unto him in his 74th year, which was made occasion for an assembly of the Bar and the presentation of a silver cup to his little daughter, Maggie White." He died near Louisville 8 Jan. 1875, aged 81. One of his daughters, Martha M., died 1 Aug. 1836, aged 19 years. One George and one George M. Chambers listed in AG: Louisville Daily Journal, 4 Aug. 1836; Yeoman, 26 June 1875; TK, 20 Jan. 1875. CORRECTION -

His mother was Amelia Sebastian, daughter of Judge Benjamin Sebastian, not Jude as stated therein. James Chambers and Amelia Sebastian were married in Jefferson County, probably in 1789, the bond being dated 30 Oct. 1789. Jefferson County Book I, p. 9.

CHAMBERS, JOHN. Mason County. Born New Jersey, 6 Oct. 1780; brought to Washington, Mason County, 1794; served on staff of Gen. William H. Harrison, War of 1812; Governor, Territorial Iowa; died at Paris, Ky., 21 Sept. 1852. C, 27 Sept. 1852.

CHAMBERS, JOHN. Coles County, Illinois. Attended 6th annual reunion, 1871, aged 80. C, 7 July 1871.

CHANDLER, W. L. Robertson County. A pensioner of War of 1812; died 22 May 1875, aged 82 years, 1 month, 10 days. His father was Circuit Clerk Chandler, of Robertson. TK, 21 June 1875; Yeoman, 5 June 1875.

CHINN, DR. JOSEPH G. Bourbon County. Born there 1 Apr. 1797;

volunteered at age of 15 and was severely wounded in the foot; attended annual reunions of 1870-71, 1873-76, 1881, 1883, from Lexington. TK, 22 June 1870; C, 7 July 1871; Yeoman, 27 June 1874, 21 June 1883, 20 June 1881; WC, 24 June 1875. AG: 1st Cpl., Capt. William Hutchison's Co., KMVM, 31 Aug.-8 Nov. 1813.

CHINN, WILLIAM. Bourbon County. Moved to Bourbon about 1847; was in the battles of River Raisin; died in Scott County, 22 Jan. 1872, aged 82. TK, 31 Jan. 1872.

CHISM, JAMES. Clark County. Attended annual reunions of 1870, aged 83; 1873, 1876. TK, 22 June 1870; WC, 24 June 1873, 24 June 1876.

CHORN, SAMUEL. Clark County. Born Mercer Co., 6 Apr. 1787; moved to Clark Co., 1793; attended annual reunions of 1870-71. TK, 22 June 1871; C, 7 July 1871.

CHRISTIAN, THOMAS. Fayette County. He was at Dudley's Defeat and one of the men who ran the gauntlet there; died 9 Jan. 1876, in Fayette Co., aged 85. TK, 26 Jan. 1876, 21 June 1876. AG: Pvt., Capt. Archibald Morrison's Co., KDM, Mar. 2-Sept. 2, 1813.

CHURCH, WILLIAM S. Franklin County. "He was a soldier of the War of 1812, and one, and almost the last, of the family of Churches so well known in an early day as spies, Indian fighters and true and faithful soldiers." He died at his residence on Main Elkhorn, near Stedmanville, 20 Apr. 1876, in his 85th year, and was buried near his home by his neighbors. Yeoman, 25 Apr. 1876; TK, 26 Apr. 1876.

CLARK, JOSEPH. Franklin County. Born Frederick Co., Va., 28 July 1793, son of Matthew and cousin of Gen. George Rogers Clark; removed with his parents to Nelson Co., Ky., 1798, later to Franklin; enlisted at 18 in Capt. Paschal Hickman's Co., captured at Frenchtown and held until war's end, being one of the 12 or 13 of this company of 86 who escaped to return home; sheriff of Franklin Co., 1831, and farmer until his death, 10 Nov. 1875. Portrait in Kentucky Historical Society. C, 9 June 1871.

CLAY, GREEN. Madison County. Born Powhatan Co., Va., 14 Aug. 1757; became Major-General on outbreak of War of 1812; headed 3,000 Kentuckians at the relief of Fort Meigs; died 31 Oct. 1828, and was buried on his estate within a few hundred yards of the present White Hall. Lexington *Reporter*, 19 Nov. 1828.

COMBS, GEN. LESLIE. Fayette County. Born near Boonesboro, 27 Nov. 1793; his wife Mary was born at Little Compton, R. I., 16 June 1823 and died 10 Aug. 1857. He joined the Kentucky volunteers in 1812 at Fort Wayne. Here he was attached by General Orders, Ensign, 1st Regt., KV, under Colonel Scott. He carried General Winchester's intelligence of advance toward Frenchtown

t General Harrison and so was absent from both battles and the massacre there, Jan. 18-23, 1813. He died 22 Aug. 1881. Notes by Chas. R. Staples; Narrative of Gen. Leslie Combs, p. 5.

COMBS, CAPT. WILLIAM R. Frankfort, Ky. "The eldest living brother of Gen. Leslie Combs. He was a gallant officer in the War of 1812-15; in peace, as fearless as any man on earth, and very powerful in single combat." He died on Easter Monday (April, 1866) in his 80th year. Yeoman, 5 Apr. 1866.

CONNELLY, ALEXANDER. Frankfort, Ky. Died 16 Apr. 1868, aged 75, at the residence of his nephews, A. and T. Carrick. 'An old soldier of 1812. C, 8 May 1868. AG: Alexander Conley, Pvt., Capt. James Hall's Co., 3rd Regt., KDM, 1 Sept.-25 Dec. 1812; Pvt., Capt. Andrew Coombs' Co., KM, 8 Feb.-7 Mar. 1815.

COOK, WILLIAM. Scott County. Pvt., Capt. Joseph Redding's Co.; enlisted 15 Aug. 1812, discharged 4 Mar. 1813; residence in 1814, 1824, 1850-56, Grant County, Ky.; 1864, Bartholomew Co., Ohio; 1871, Soldiers' Home, Montgomery Co., Ohio; WIA, POW, Jan. 22, 1813; married Sarah S. Reed. He died 16 March 1884. Fayette County Pension List.

COONS, BENJAMIN. Oldham County. Enlisted at Newcastle, Ky., 29 Aug. 1813; Ensign, Capt. Edward George's Co., KMV. He was 75 in 1850 and still residing in Oldham. Oldham County Pension List.

CORD, ZACHEUS. Fleming County. 1st Lieut., Capt. Phillips's Co., 10th Regt., KM.; discharged 29 Sept. 1813; lost his eyesight due to illness in service. Fleming County Pension List.

CRADDOCK, JESSE. Hart County. Born Pendleton County, S. C., 25 Dec. 1794; removed to Kentucky when 4 or 5 years of age; "he participated in the struggles, and endured the hardships and fatigues of two campaigns in the War of 1812, the last campaign being under the command of Gen. McArthur." He died at his residence in Munfordville, Hart Co., 28 Feb. 1847, in his 53rd year. C, 16 Mar. 1847.

CRAIG, GEORGE W. Harlan County. "His services were rendered to his country in the last war, as an officer. He was at his death surveyor of the county of Harlan, which office he had held in that, and the county of Knox, together, for upwards of 30 years. By his judicious arrangement of difficulties, he acquired the name of Yellow Creek Pacificator, in the portion of Harlan in which he resided. He died in Nov., 1833, leaving a large family." C, 26 Nov. 1833. AG: 1st Lieut., Capt. Thomas Laughlin's Co., KMVM.

CRAWFORD, A. B. Bourbon County. "Born in Montgomery Co., Md.; removed to Kentucky 1811; served in war of 1812 in Capt. Morris' Co.; reared

8 children; died 27 Apr. 1876, at the home of his son-in-law, B. F. Soper, aged 87 years lacking 15 days." TK, 3 May 1876. He is not in the AG list of Capt. John H. Morris' Co., from Bourbon County. He lived at North Middletown, Bourbon Co. Yeoman, 27 June 1874.

CRAWFORD, J. B. Clark County. Attended 8th annual reunion, 1873, aged 77 years. WC, 24 June 1873.

CRAWFORD, THOMAS. Boyle County. He was 84 in 1877; was in the battle of the Thames, in Capt. McAfee's Co. *Yeoman*, 16 Oct. 1877. AG: Pvt., Capt. Robert B. McAfee's Co., KMI, 20 May-19 Nov. 1813.

CRAWFORD, WILLIAM. Boyle County. Attended annual reunions of 1871, aged 76, and 1875. C, 7 July 1871; Yeoman, 26 June 1875. AG: Pvt., Capt. Joseph Allen's Co., KMVM, 16 Sept.-30 Oct. 1812

CREWS, JOHN, Enlisted at Newcastle, Henry County, Ky., 1812, in 7th U. S. Inf.; married Lucy Hardwick, in Bedford Co., Va., in 1794 or 1795, when she was 16 or thereabouts. *Trimble County Pension List*.

CRIGLER, NICHOLAS. Boone County. Born Madison Co., Va., 2 Feb. 1772; removed to Boone Co., Ky., 1829; married 23 Jan. 1816; father of Robert L. Crigler. A soldier in 1812 from Virginia? He died in Boone County 13 Jan. 1871. TK, 1 Feb. 1871.

CUNNINGHAM, CAPT. JOHN. Bourbon County. "He had been a prominent citizen of Bourbon for years, and had represented that county in both houses of the Legislature, and held the office of Justice of the Peace for a number of years. He was a soldier of the War of 1812." Died 17 Aug. 1864, in his 70th year. C, 22 Aug. 1864.

CURL, JOHN. Bourbon County. Attended annual reunions of 1871, 1874-75; voted in the Clintonville precinct, 1874, aged 86 years. *C*, 7 July 1871; *Yeoman*, 27 June, 8 Aug. 1874, 26 June 1875.

CURRY, MAJOR J. R. Harrison County. Attended 6th annual reunion, 1871, aged 82; 1875-76. C, 7 July 1871; Yeoman, 26 June 1875.

CURRY, JAMES. Mercer County. Attended 8th annual reunion, 1873, aged 76; 1875. WC, 24 June 1873; Yeoman, 26 June 1875.

CURTIS, ELIJAH. Lincoln County. "The oldest man at present living in the county; 101 years of age. He was a teamster in the War of 1812, and recollects the incidents of that war as readily as we do those of our late civil contest." Yeoman, 18 Sept. 1877.

CURTIS, JAMES. Pvt., 7th Regt., U. S. Inf., under Capt. Jeofry Robinson; WIA at age of 40, on 23 Dec. 1814 at New Orleans. Hopkins County Pension

List.

DANIEL, ABNER G. Boyle County. Attended 10th annual reunion, 1875, aged 83. Yeoman, 26 June 1875. "His wife, Mary, died 24 Aug. 1876, aged 65, to make the handsome old veteran of 1812 a widower for the fourth time." TK, 21 June 1876.

DANIEL, HENRY. Montgomery County. Born in Virginia; removed to the southeastern part of Clark Co., Ky., when quite small; read law with Henry Clay, obtained license in 1809 and settled in Mt. Sterling until the outbreak of War of 1812; volunteered and rose to Captain. "A brave man never drew a sword or bore a commission." He died 5 Oct. 1873, nearly 91 years of age. Reid, Richard, Historical Sketches of Montgomery Co., Ky., 1926, p. 46-7; Yeoman, 14 Oct. 1873.

DANIEL, JESSE. Fayette County? Died of erysipelas, 13 Mar. 1853, in his 88th year. C, 12 Apr. 1853. AG: Lieut., Capt. William Farrow's Co., 3rd. Regt., KMV, 1 Sept.-Oct. 1, 1812.

DARNELL, SPENCER. Served in KM, under Lt. Col. William Dudley; WIA, 5 May 1813 at Fort Meigs; POW, paroled 10 May 1813. Fayette County Pension List.

DAVENPORT, COL. RICHARD. Danville, Ky. Major, 17th Inf., U. S., 12 Apr. 1812; resigned 1 Feb. 1813; Lt. Col., Ky. Volunteers, 31 Aug.-8 Nov., 1813; died in August, 1818. Lexington, Ky., Reporter, 26 Aug. 1818.

DAVIDSON, COL. JAMES. Lincoln County. Served in 63rd Regt. (Lincoln Co.) He was at the battle of Tippecanoe and stated later that John King, q.v., killed Tecumseh. He was Treasurer of Kentucky, 1825-1840; died 31 May 1861, aged 83 years, 6 months and 18 days. C, 14 June 1861; Yeoman, 14 June 1881.

DAVIDSON, CAPT. MICHAEL. Lincoln County. Served as Ensign, Capt. George Murrell's Co., KMV, 18 Sept.-30 Oct. 1812; Captain of his own company, KMV, Davenport's Regt., 25 Aug.-8 Nov. 1813. He died 9 Mar. 1847, aged 69 years. OR, 20 Mar. 1847.

DAVIS, GEORGE. Mercer County. He was in the battle of New Orleans; attended 8th annual reunion, 1873, aged 77; 1875-76. WC, 24 June 1873; Yeoman, 24 June 1875; TK, 21 June 1876.

DAVIS, JAMES S. Pvt., Capt. B. W. Saunders Co., 17th Regt., U. S. Inf.; WIA about 14 Aug. 1814 at Mackinaw, Mich.; married Jane Elam, in Wayne Co., Ky., 24 Dec. 1831. He died in Wayne County 29 Nov. 1844. Wayne County Pension List.

DAVIS, SOLOMON. Pulaski County. "He was a soldier of '12, never drew a pension; an inmate of the Asylum for the Poor, he fell dead from his chair in December, 1876, aged 80 years." TK, 9 Feb. 1876, 21 June 1876.

DAVIS, MAJOR WILLIAM MILTON. Shelby County. "During the late war with Great Britain, he held a captain's commission in the volunteer army of the U. S., and was at the battles of the Thames and New Orleans, and for several years past has been one of the confidential commissioners of the Federal Government in the Indian negotiations." He died 24 Dec. 1836 in his 40th year. C, 18 Jan. 1837.

DAWSON, JOHN. Sgt., Capt. Michael Glaves Co.; born 24 Nov. 1791, Bracken Co., Ky.; at battles of River Raisin; died 12 Nov. 1850; buried Clear Lake District, Sangamon Co., Ill. Honor Roll of Soldiers buried in Illinois, Vol. 1. (MS)

DERBIN, NAPOLEON M. Harrison County. Served in War of 1812; died in March, 1871, aged 55 years. TK, 22 Mar. 1871.

DILLARD, REV. R. T. Attended 9th annual reunion, 1874, aged 77. Yeoman, 27 June 1874.

DOHONEY, WILLIAM (Dehoney). Pvt., Capt. John Duvall's Co., KVM; WIA, 5 May 1813; received a pension commencing 4 June 1821. Owen County Pension List.

DOLLARHIDE, COL. THOMAS. Pulaski County. Senator from Pulaski, 1819-1821; member House of Representatives (Kentucky), 1814-1818; died at Frankfort, 18 Nov. 1821. Lexington, Ky., Reporter, 17 Dec. 1821. AG: Capt., Kentucky Mounted Volunteers, 18 Sept.-27 Oct. 1812.

DOUGHERTY, HENRY. Harrison County, 1st Cpl., Capt. John D. Thomas' Co., Boswell's Regt.; pensioned 21 Mar. 1817. Sen. Doc. 514.

DRAKE, CAPT. ABRAHAM S. Lexington, Ky. Born 1781; died 6 Sept. 1831. Lexington, Ky., Reporter, 14 Sept. 1831. He was Capt., Col. Francisco's Regt., 4 Feb.-8 Aug. 1815.

DUCKER, ENOCH. Fayette County. Enlisted 29 Mar. 1812 (or 9 Mar. 1813?) in Capt. John C. Morrison's Co.; married Mary Craig, in Woodford Co., 4 June 1846 or 1848; (her first husband, William M. Craig, died 14 Sept. 1832); he died 27 or 29 March 1871. Woodford County Pension List.

DUDLEY, AMBROSE, JR. One of eleven sons of Rev. Ambrose Dudley, famed Baptist minister of Fayette and Captain in the American Revolution;

Ambrose the son saw much service in 1812 including action at Thames. Yeoman, 18 Sept. 1884.

DUDLEY THOMAS. Brother of Ambrose, Jr., above. He saw extensive service in 1812 and in 1815 was Captain of a company in Lt. Col. John Francisco's Regt. Yeoman, 18 Sept. 1884.

DUDLEY, JEPTHA. Brother of Ambrose, Jr., and James, above. He resided in Franklin County and died there 20 Mar. 1863, aged 85 years. C, 23 Mar. 1863. He resigned 13 May 1813 as magistrate of Franklin and was commissioned an officer in the 25th Regt., U. S. Inf., under Col. Thomas Deye Owings. (Capt., 25th Inf., 29 May 1813; resigned 1 June 1813. Heitman, v.1,p. 386; Yeoman, 18 Sept. 1884.

DUDLEY, COL. PARKER. Fayette County. Served in battle of New Orle: ns and was Receiver of the U. S. Land Office at Palmyra, Mo., where he died in Sept., 1853. Lexington, Ky., Statesman, 27 Sept. 1853.

DUDLEY, PETER. Franklin County. Another of Rev. Ambrose Dudley's sons; born 21 Mar. 1787; the family moved to Frankfort in Dec., 1804; engaged in trading expeditions between Frankfort and New Orleans, and was in the mercantile business until war broke out; served as Lieut. in Capt. Paschal Hickman's Co., 1812-13; after the massacre of Hickman's men, Lieut. Dudley returned to Frankfort and raised his own company, which he headed and led into action; as major of Kentucky Mounted Volunteer Infantry, he led his troops in action now referred to as "McArthur's Raid;" in private life he headed many public enterprises, including service as commissioner to contract for two Kentucky state houses; he was president of the Old Bank of Kentucky and Adjutant General for more than 20 years; Treasurer of Kentucky, 1840, and member of the Military Board of 1861. He died 17 June 1869. C, 18 June 1869; 25 June 1869; Yeoman, 18 Sept. 1884.

DUDLEY, THOMAS PARKER. Fayette County. Another of Rev. Ambrose Dudley's sons, (see above for others); born in Fayette County, 31 May 1792; moved to Frankfort when 16 and remained there until the war of 1812 broke out; enlisted and was wounded at River Raisin; was Quartermaster General at battle of New Orleans; later he was Quartermaster General of Kentucky for two years, and for eight years cashier of a bank in Frankfort. He became pastor of his father's church at Bryan Station and held that office 62 years. He died 10 July 1886. KG, June 1, 1870; Western Reserve Historical Society, Historical and Archaelogical Tracts, No. 1.

DUDLEY, WILLIAM. Fayette County. Colonel under Gen. Green Clay at Fort Meigs where he was severely wounded, then slain, in action known as "Dudley's Defeat." Yeoman, 18 Sept. 1884.

DUNCAN, CAPT. JAMES, JR. Bourbon County. Born 8 July 1782, son of Capt. James and Elizabeth Strode Duncan; served in War of 1812; married 2 Apr. 1807, Nancy Musick. He died in Clay Co., Mo., 25 March 1841. Mrs. W. B. Ardery, *The Duncans of Bourbon County*, c 1943, p. 5-6.

DUNCAN, MAJOR JERE (JEREMIAH). Paris, Ky. Born there 12 May 1792; attended annual reunions of 1870-71, 1873-76; died 5 Oct. 1876. TK, 22 June 1870, 21 June 1876; C, 7 July 1871; WC, 24 June 1873; Yeoman, 27 June 1874, 26 June 1875. AG: Pvt., Capt. Richard Matson's Co., KMI, 15 Aug.-19 Nov. 1813.

DUNKERSON, WASHINGTON. Christian County. "One of the 150 picked Kentucky volunteers who fought with Perry on Lake Erie; assigned to the *Niagara*. Not listed in the War Department list of these first "Horse Marines." Perrin, W. H. County of Christian . . . 1884, p. 171.

DUNLAP, MAJOR ALEXANDER. "He was a Kentuckian by birth; volunteered in the War of 1812, was taken prisoner at 'Dudley's Defeat,' and would have been sacrificed if he had not been recognized as a Mason by a British officer. He was afterwards in the battle of the Thames, and for his gallantry on that occasion he was made a Captain, U. S. Army. He died 10 Nov. 1853 at Jacksonville, in his 68th year." C, 29 Nov. 1853. AG: Pvt., Capt. James Dyametto's Co., KDM, 12 Mar.-12 Sept. 1813; paroled by the enemy 5 May 1813.

DUVALL, COL. JOHN. Scott County. "Died at his residence in Scott, 7 Sept. 1859, in his 77th year. He was a citizen of Scott for 67 years and had represented that county in the Legislature, besides filling various other civil offices in it. He commanded a company in the last war with Britain and served a campaign under General Harrison." C, 23 Sept. 1859.

EASLEY, WOODSON G. Shelby County. Born in North Carolina; removed to Kentucky 1811; volunteered in 1812 and served a tour of duty with the Northwestern army; died at his residence in Shelby County, 8 Dec. 1854, aged 64 years, 3 months and 22 days. C, 18 Dec. 1854. AG: 2nd Cpl., Capt. James S. Whitaker's Co., KMV, 25 Aug.-8 Nov. 1813.

EASTIN, MAJOR CHARLES. Fayette County. "The first white child born in Lexington, Ky.; died at the residence of his son, Capt. J. M. Eastin, 16 Sept. 1865, aged almost 90 years. He married in Shelbyville, in 1803, and from there emigrated to Indiana, settling in Madison. He served in the War of 1812, during the years of 1812 and 1814. He moved to Kentucky from Indiana in the spring of 1830, settling in Fayette county about 8 miles from Lexington. He was entirely blind for six or seven years preceding his death. He was survived by his wife and five of 13 children, three daughters and two sons." OR, 27 Sept. 1865.

EASTIN, THOMAS. Bourbon and Clark counties. Pvt., Capt. William Garrard's Co.; WIA at battle of Mississinewa, Ind., about 18 Dec. 1812; married 18 Dec. 1823, Meriam Colmers, in Woodford County; he was 5' 10" tall, had auburn hair and blue eyes. He died 20 May 1859. Clark County Pension List.

ECKLAR, JOHN. Harrison County. Attended 6th annual reunion, 1871; his death was reported at the 1876 reunion as occurring between the meeting of 18 June 1875 and that of 17 June 1876, aged 82 years. C, 7 July 1871; TK, 21 June 1876.

EDDLEMAN (EDELMAN), AARON. Harrison County. Attended the 6th annual reunion, 1871, aged 80; 1873-74, 1876. C, 7 July 1871; WC, 24 June 1873; Yeoman, 27 June 1874; TK, 21 June 1876.

EDDLESON, I. Harrison County. Attended the 11th annual reunion, 1876, aged 80. Yeoman, 24 June 1876.

ELDEN, JOHN. Harrison County. Attended 8th annual reunion, 1873, aged 78. WC, 24 June 1873.

EMERSON, CAPT. JOHN. Burkesville, Cumberland County. Born near Chambersburg, Pa., in which state he lived until the close of the Revolution; served in that war, and was at the fall of York, where he witnessed the surrender of Lord Cornwallis; removed to Kentucky at a very early date. "He wielded the axe that struck the first blow where now stands the proud city of Lexington, Kentucky . . . at the advanced age of 62 years he volunteered his services under Hopkins to be led once more, as a private soldier. Entering the army, as mentioned above, at the commencement of the revolution, he was appointed Lieutenant of his company, and was engaged at Brandywine, Germantown and Monmouth, among other battles . . . As a member of the lower branch of our State Legislature, he was a firm friend of the head-right settlers south of Green River, and the first mover of that series of laws which have received the appellation of the Relief System . . . At the age of 54 he studied law as a profession . . . and arrived at the highest honor of his profession." He died at his home in Burkesville, 17 Feb. 1836, aged 86 years, and was given a military funeral on 18 Feb. 1836. C, 2 Mar. 1836.

ESTES, ABRAHAM. Clark County. Pvt., Capt. Edmonson's (afterwards Capt. Richard Bledsoe's) Co.; WIA at River Raisin 18 Jan. 1813; POW, 22 Jan. 1813; married in Fayette County, 24 Dec. 1813, Beulah Schooler; he died in Clark County, about 11 Sept. 1825. Clark County Pension List; Bourbon County Pension List; Senate Doc., 514.

ESTES, CLEMENT. Bourbon County. Cpl., Capt. Richard Bledsoe's Co.,

Col. Allen's Regt.; WIA, 18 Jan. 1813, at River Raisin. Bourbon County Pension List.

EUBANKS, JOSEPH. Lincoln County. One of the last three veterans of the War of 1812 living in Lincoln in Sept., 1879. Yeoman, 16 Sept. 1879.

EVANS, GILEAD. Headquarters, Nicholas County. Born in Delaware, 4 July 1794, only child of John and Rachel (Taylor) Evans; married first Anna Trigg (1794-1864); second, Mrs. Rose Ann Sanders. History of Bourbon, Scott, Harrison and Nicholas Counties, 1882, p. 777-8. He attended the annual reunions of 1871, 1873-76, 1881, 1883. C, 7 July 1871; Yeoman, 27 June 1874, 26 June 1875, 20 June 1881, 21 June 1883; TK, 21 June 1876. AG: Pvt., Capt. Robert Henley's Co., KVM, 10 Sept.-9 Oct. 1814.

EWALT, SAMUEL. Bourbon County. Attended 6th annual reunion, 1871, aged 79 years. C, 7 July 1871.

EWING, COL. YOUNG. "One of the earliest settlers in this part of Kentucky. He was in several of the most important battles to the north during the last war between the United States and Great Britain, and he served in the Legislature of Kentucky [from Christian County for more than 30 years]. He died in La Grange, Tenn., 5 Oct. 1833, aged about 60 years. C, 19 Nov. 1833, from Green River Advocate.

FAIR, JAMES. Lexington, Ky. A native of Bedford Co., Va. He was a soldier in the late war with Great Britain and a spy attached to Gen. Wayne's Army. He died 10 Feb. 1847, aged 80 years. OR, 24 Feb. 1847. AG: Pvt., Stewart W. Megowan's Co., KV, 15 Aug.-14 Oct. 1812.

FARROW, JUDGE KENAZ. Montgomery County. Born Culpepper Co., Va., 23 Dec. 1794; emigrated to Kentucky 1810 and was studying law when war broke out. After the war he married Susan French, his cousin, and sister of Richard French, and practiced law in Mt. Sterling. He died 31 Aug. 1864 at the Mt. Sterling home of his son-in-law, Judge Peters, aged about 75. He was an able jurist and for many years on the Circuit Court Bench. C, 5 Sept. 1864. AG: Kennox Farrow, Pvt., Capt. James Sympson's Co., KMVI, 20 Sept.-20 Nov. 1814.

FENWICK, LEWIS B. Franklin County. One of the 13 survivors of Capt. Paschal Hickman's Co., battles of River Raisin. He was living in the county in 1862. Probably a son of William (1758-18 June 1833) a private, Maryland Militia, Revolutionary War, and Catherine Fenwick who died 25 June 1835. This Lewis B. Fenwick married, 1829, Monarcha Holton, sister of John A. Holton, q.v. Fenwick Family notes, Kentucky Historical Society.

FIFE, R. B. Born Fredericksburg, Va., 15 Apr. 1792; attended 1870 annual reunion from Louisville; 1874 from his home in Lexington. TK, 22 June 1870; Yeoman, 27 June 1874.

FISHEL, MICAEL. Fayette County. Lieut., Capt. George Trotter's Co. A cooper by trade. WIA during attack on the Mississinewa Towns. Fayette County Pension List.

FLEET, WILLIAM. Nicholas County. Sgt., Capt. Coleman A. Colliers' Co.; enlisted 15 Aug. 1812; placed on pension rolls 26 Jan. 1822. Nicholas County Pension List; Sen. Doc. 514.

FLOYD, CAPT. WILLIAM. Woodford County. Died 15 Jan. 1875, aged 82 years. A soldier in the War of 1812. TK, 20 Jan. 1875.

FLYNN, COL. MICHAEL. Clark County. Died 17 Aug. 1847, aged 66 years. OR, 24 Aug. 1847.

FOLEY, DANIEL. Mason County. Died in May, 1876, aged 85. TK, 21 June 1876.

FORD, REUBEN. Franklin County. "One of the gallants who so freely shed their blood in the War of 1812; died 7 Apr. 1856, aged about 65 years." C, 11 Apr. 1856. AG: Pvt., Capt. Virgil McCracken's Co., 15 Aug.-14 Oct. 1812; Pvt., Capt. James Anderson's Co., 1 Sept.-1 Oct. 1812.

FOSTER, WILLIAM T. Grant County. Attended 6th annual reunion, 1871, aged 74 years. C, 7 July 1871. AG: Pvt., Capt. James Dudley's Co., KM, 8 Feb. 7 Mar. 1815.

FOWLE, ISAAC. Nicholas County. A native of Vermont, born 24 Mar. 1791; hatter by trade; settled in Bourbon County, 1816; having served in the war of 1812; attended annual reunion of 1871, 1873. C, 7 July 1871; WC, 24 June 1873. He died 30 Dec. 1879. History of Bourbon, Scott, Harrison and Nicholas Counties, p. 772.

FOXWORTHY, SAMUEL. Fleming County. Died 9 June 1875, in his 87th year. TK, 23 June 1875. AG: Pvt., Capt. George Matthews Co., KMVM, 27 Aug.-3 Nov. 1813.

FUGATE, JOHN H. Pendleton County. Pvt., Capt. William Sebree's Co., Boswell's Regt. Pensioned 7 Aug. 1820. Sen. Doc. 514.

FUNK, ADAM. Fayette County. Pvt., Capt. Archibald Morrison's Co., 29 Mar.-31 July 1813; WIA, 5 May 1813, at "Dudley's Defeat." He married 13 Dec. 1841, Susannah Shackles. He died 24 Dec. 1849 in Barren County. Green County Pension List.

FURY, JOHN. Pvt., 1st Regt., U. S. Inf.; WIA in campaign against the Indians at Chicago, 16 Aug. 1812; a native of Ireland. Jefferson County Pension List.

GAITHER, HENRY. Cincinnati, Ohio. Attended 5th annual reunion, 1870, aged 80 years. TK, 22 June 1870.

GAYLE, WILLIAM E. Attended, 8th annual reunion, 1873, aged 98 years. WC, 24 June 1873.

GILFILLIN, JOHN. "He was a lieutenant in the U. S. Army during the late war with Great Britain, and held that office till the disbandment at the cantonment in Mississippi." He died at Frankfort, 10 Apr. 1846, aged 63. C, 14 Apr. 1846.

GOANS, JAMES. Pvt., 28th Regt., U. S. Inf.; enlisted 22 Apr. 1814, for the period of the war; died at Detroit, 24 Nov. 1814. His land allotment papers were signed by George Stockton, late Capt., 3rd Regt., U. S. Inf., Flemingsburg, Ky., 7 June 1814. "Lavicia Goans, guardian, 3 children." Bath County Pension List. Date of Stockton's statement probably 7 June 1815.

GOLDEN, WILLIAM. Madison County. Died 11 Sept. 1866, in his 106th year. He was born in Albermarle Co., Va., 1760. He was a rough carpenter and sawed timbers used in the first court house at Richmond. He served in the War of 1812 and was at Fort Meigs. C, 2 Oct. 1866. AG: Pvt., Capt. James Dyametto's Co., Dudley's Regt.

GOODNIGHT, GEORGE. Harrison County. Attended 6th annual reunion, 1871, aged 82; died between June, 1874, and June, 1875, reunions, aged 85. *C*, 7 July 1871; *Yeoman*, 26 June 1875.

GOODNIGHT, MICHAEL. Harrison County. Born Fayette County, 5 Nov. 1793; living in Connersville, Harrison County, 1874; attended annual reunions of 1870, 1873, aged 78; 1874-76. TK, 22 June 1870, 21 June 1876; Yeoman, 27 June 1874; 26 June 1875; WC, 24 June 1873.

GORIN, JOHN. Barren County. Born 15 May 1763, Fairfax Co., Va.; pvt., cpl. and sgt., Virginia Militia; Capt. and Major in Kentucky Mounted Vols., Lt. Col. Philip Barbour's Regt., War of 1812; moved to Barren County, 1782; married there 26 May 1825, Elizabeth Duvall, b. 1793; received pension; died 5 Aug. 1837. Barren County Pension List.

GRAHAM, DR. CHRISTOPHER COLUMBUS. Louisville, Kentucky. Born near Danville, 10 Oct. 1784; died at Louisville, 3 Feb. 1885. Attended 1875, 1881 and 1883 reunions of the veterans at Paris. After the 1883 meeting, when he was 99 years of age, Dr. Graham stated that he had been mustered into service 71 years before, that he was the last remaining man who had seen Daniel Boone and that he had slept with him. *Yeoman*, 26 June 1875, 20 June 1881, 21 June 1883. Maurice Langhorne's Co.; POW at Frenchtown; was drawing pension at time of his death; died 16 April 1876, near Columbia, Mo., in his 88th year. He left six children, two sons and four daughters, all married and settled in Boone County, Mo. TK, 26 Apr. 1876.

GRANT, JOHN. Boone County. Pvt., Capt. Jacob Stucker's Co.; enlisted 20 May 1813; WIA; discharged 19 Nov. 1813. He married 16 Feb. 1820, in Boone County, Polly Willis. He died 30 May 1849 in Boone. Boone County Pension List.

GRAVES, COL. JOHN. Fayette County. Served in 10th Regt., Fayette County; died 5 Aug. 1848, aged 76 years. OR 23 Aug. 1848.

GRAVES, THOMAS H. Scott County. Pvt., Capt. Lynn West's Co., enlisted 15 Aug. 1812; captured by Indians at Raisin River 22 Jan. 1813; he was born about 1793; married first Gabrilla Dollman, who died 1834; married second Elisa W. Graves, in Scott County 22 Oct. 1832; soldier moved to Hamilton County, Ohio, 1850, and five years later to Cincinnati. He died 6 Jan. 1855. His youngest child was then five years of age. Scott County Pension List; Fayette County Pension List.

GRAVITT, GEORGE S. Resident of Owen but a native of Franklin County. Served in 1812 under Col. Peter Dudley; was one who escaped at Fort Meigs

5 Mar. 1813; he died 1 Mar. 1864, aged 84. Commonwealth, 13 Apr. 1864. AG: Pvt., Capt. Peter Dudley's Co., KDM.

GRAY, ISAAC. Bath County. Capt., 10th Regt., KM; WIA 25 July 1813 at Fort Winchester. He moved from Bath to Trimble County, 1839. Bath County Pension List.

GRAY, PRESLEY. Gallatin County. Appointed by Governor Shelby to command 13th Regt., KM, destined for New Orleans; mustered in with the regiment at Louisville 10 Nov. 1815; resigned because of ill health; also served in Indian wars and in the Revolution, enlisting in latter at age of 17. Hardin County Pension List.

GRAYSON, JOHN. Fleming County. "A soldier of 1812, nearly 90 years old, is stout and active and says he is going to the Centennial with a pocket knife over 30 years old." TK, 10 May 1876. AG: Pvt., Capt. Samuel Gooden's Co., KVM.

GREENE, JESSE P. Pendleton and Clark counties. Pvt., Capt. Michael Glaves Co., 1st Regt., KM; WIA at Raisin River 22 Jan. 1813; received pension. Pendleton County Pension List; Sen. Doc. 514, p. 5.

GRIDER, HENRY. Warren County. Native of Lancaster County, Pa.;

born 9 May 1755; removed with his father and father's family about 1770 to Virginia, where he lived until 1781; came to Kentucky this year, settling in Fishers' Station, near the present Danville; removed to Warren County in 1799; married Aug., 1782, a sister of Jesse Smith, of Danville, who survived him; he was in his first engagement when 19 years old, at the mouth of Big Kanawha (Battle of Point Pleasant) and in the battle at Blue Licks, where he received an injury from which he never fully recovered; served in various campaigns under Wayne, Harrison, McIntosh, Scott and Clark; in War of 1812 served in Hopkins's campaign. He died in Warren County 5 Feb. 1843, in his 88th year, at the residence of his son, John Grider. Commonwealth, 17 Feb. 1843.

CRIDER, JOHN. Warren County. Lieutenant in Capt. Alexander Stuart's Co., 3rd Regt., KDM. Pensioned 17 July 1820. Sen. Doc. 514.

GRIFFIN, GEN. JOHN. Pulaski County. Served with the 44th Regt. for many years and was Representative and Senator from Pulaski. He died 17 Oct. 1854, aged 81, one of the oldest residents of his county. Commonwealth, 23 Oct. 1854. AG: Pvt., Capt. Thomas Dollarhide's Co., 12 Sept.-27 Oct. 1812; Pvt., Capt. John Evans's Co., KDT, Nov. 1814 for six months. Both he and his wife Mary (died 31 Aug. 1831, aged 60) are buried in James Family Graveyard, east of Somerset, Kentucky.

GRIGGS, WILLIAM P. Bath County. Attended 6th annual reunion, 1871, and 8th of 1873, aged 82 years. Commonwealth, 7 July 1871; WC, 24 June 1873.

GROVER, WILLIAM. Sardis, Kentucky. Died Mar., 1879, in his 83rd year. He had been married 56 years to his wife who survived him. A soldier of 1812. Yeoman, 18 Mar. 1879. Not in AG.

GUNTER, WILLIAM. Enlisted 11 Feb. 1815, for five years, in Capt. Richardson's Co., 1st Regt., U. S. Inf.; injured in service. Franklin County Pension List.

HADEN, BARTHOLOMEW. Volunteered in Wayne County in 1813 in Micah Taul's Co.; elected ensign; 2nd Lieut., Capt. Thomas Miller's Co., 7th Regt., KMV, 1813. Wayne County Pension List.

HALL, T. Danville, Kentucky. "A soldier of the War of 1812, and served as an orderly for General Cass." He died 23 Oct. 1869, in his 78th year. C, 12 Nov. 1869.

HALLEY (HOLLEY, HAILEY), DANIEL. Served in Capt. Richard Matson's Co.; WIA at Raisin 22 Jan. 1813. Harrison County Pension List.

HAMBLEN, WILLIAM A. Shelby County. A soldier of 1812; a Union man and hostile to the rebellion. He died 29 Aug. 1864, in his 73rd year. At the time of his death he was in Trimble County, on his annual fishing excursion. He was buried near his Shelby County residence. C, 7 Sept. 1864. AG: Pvt., Capt. Bland W. Ballard's Co.

HAMILTON, COL. WILLIAM. Carlisle, Nicholas County. Attended annual reunions 1871, 1873-1876, aged 83 or 84 at last reunion. C, 7 July 1871; WC, 24 June 1873; Yoeman, 27 June 1874, 26 June 1875; TK, 21 June 1876.

HANDLEY [HENDLEY], ELKANA. Pvt., Capt. Richard Bledsoe's Co.; WIA about 25 Sept. 1812; discharged 30 Oct. 1812. Fayette County Pension List.

HARBOUR, JEREMIAH. Born near Lexington, Kentucky, 1797; enlisted June, 1812, at Glasgow, Barren county, in Capt. William Bradford's Co., 17th U. S. Regt., for 5 years; WIA at Fort Erie in Canada, 1815; also Pvt., Capt. Edward Wadsworth's Co., 1st Rifle Regt., Regular Troops. He married 19 March 1837, at Scottsville, Tenn., Louisa F. Estes, born 1814; he had married first, Nancy Bohon (Behan). Soldier's pension began 13 June 1815. He died 28 Jan. 1860 in Hart County, Ky. Louisa F. Harbour, widow, resided in Marion Co., Kansas, after 1874. Barren and Hart County Pension Lists.

HARDESTY, FRANK. Lowe's Station, Bourbon County, Attended 1873 annual reunion, aged 83; 1874, 1876. WC, 24 June 1873; Yeoman, 27 June 1874, 24 June 1876.

HARDING, THOMAS. Robertson County. Born Fairfax Co., Virginia, Nov., 1787; Sgt., Capt. Robert Henley's Co., KVM; attended annual reunion 1870-1871, aged 84 years. TK, 22 June 1870.

HARRIS, WILLIAM. Harrison County. Attended annual reunions of 1871, aged 78; 1873-1876. C, 7 July 1871; WC, 24 June 1873; Yeoman, 27 June 1874, 26 June 1875; TK, 21 June 1876.

HARRISON, DR. BURR. Nelson County [near Bardstown]. Moved to that place 1785; served at age of 18 as Surgeon's Mate, Wayne's last campaign; in 1815 he was at battle of New Orleans as Inspector General; died 3 Aug. 1845, in his 70th year. C, 30 Sept. 1845.

HARRISON, MAJOR MICAJAH "MIKE". Mt. Sterling, Ky. A son of Joseph Harrison, of Louisa Co., Va.; married Polly G. Payne. "A soldier of the last war, he died 23 Apr. 1842, in his 66th year." C, 10 May 1842; data contributed 11 Nov. 1952 by Mr. George H. S. King, Fredericksburg, Va.

HARRISON, MICHAEL. Born 16 July 1796 in Virginia; Pvt., Capt. Nimrod Moore's Co., 28th Regt. of Regulars; enlisted at Burkville, Ky., July, 1813; discharged in July, 1814, at Detroit; War Dept. records indicate he enlisted 21 June 1813; granted military bounty land warrant, 160 acres, 27 Nov. 1852, located in Whiteside Co., Illinois. He married 27 Aug. 1822, in Fayette Co., Ky., Rachel Rupert (born in Kentucky, 1792, and died in Whiteside Co., Illinois, 31 Jan. 1879.) He died in Whiteside Co., Ill., 2 Dec. 1863. He and his wife are buried in Grove Hill Cemetery, Morrison, Illinois. Information contributed by George Harrison Sanford King, Fredericksburg, Virginia.

HAVENS, WILLIAM. Enlisted in Flemingsburg, Ky., and served as Pvt., Capt. Daniel Goodwin's Co., KM, 10 Sept. 1814-19 Mar. 1815; married 13 Apr. 1814, at Floyd Court House (Prestonsburg) Elizabeth Shriver, who died prior to 1871; he was allowed pension on application executed 7 Apr. 1871, while living in Winchester, Adams Co., Ohio, aged 77. Survivor Certificate No. 4594, Bureau of Pensions.

HAWKINS, HENRY. Jefferson County. Pvt., Capt. Frederick Geiger's Co.; WIA at battle of Tippecanoe; pensioned 2 Jan. 1816. Jefferson County Pension List; Sen. Doc. 514.

HAWKINS, COL. STROPHER JONES. Henderson County. Born 1790, Fayette County, District of Kentucky; served at battle of the Thames, receiving honorable mention in dispatches; died "recently" at his residence near Henderson, aged 77 years. C, 11 Oct. 1867.

HAZELRIGG, CHARLES. Served two campaigns in 1812; died at his residence in Montgomery County 7 Mar. 1863. C, 16 Mar. 1863.

HEARD, MAJOR MORGAN A. Russellville, Ky. He died 5 Sept. 1833. AG: One Morgan H. Heard, Ensign in Capt. Thomas L. Butler's Co., U. S. Inf., 1814. OR, 15 Sept. 1833.

HEDGES, PETER B. Clark County. Attended 8th annual reunion of veterans, 1873. Not in AG. WC, 24 June 1873.

HENDLEY, ELKANAH. See Elkana Handley.

HENDRICK, GEORGE. Harrison County. Pvt., Capt. Thomas's Co., Col. Dudley's Regt.; WIA at the Rapids of the Maumee, 15 May 1813; his pension was transferred to Corydon, Indiana. *Harrison County Pension Lists*.

HENDRICKS, THEOPHILUS. Bath County. Attended 10th annual reunion, 1875, aged 84 years. Yeoman, 26 June 1875.

HENRY, JOHN F. Born Scott County, Ky., 17 Jan. 1793; educated at Georgetown Academy; studied medicine and in 1813 was appointed Surgeon's Mate in Boswell's Regt. at Fort Meigs; afterwards graduated from New York University; settled in Hopkinsville, Ky., 1822; subsequently moved to Burlington, Iowa, where he died in November, 1873. Yeoman, 18 Nov. 1873.

HENRY, GEN. WILLIAM H. Born 1761; died at Hopkinsville, Ky., 23 Nov. 1824. AG: 4th Cpl., Capt. George Trotter's Co., 27 Aug.-31 Oct. 1812; 2nd Lt., Capt. Johnston Megowan's Co., 2 Apr. 1813; Major General at Battle of the Thames. No. 4931 Texas Society, USD of 1812.

HERAN, CAPT. JAMES L. Lexington, Ky. Ensign Capt. Nathaniel G. S. Hart's Co., Lewis's Regt., 15 Aug.- 14 Oct. 1812. He died at Lexington 21 Aug. 1821, aged 32 years. R, Aug., 1821.

HEWLETT, LEMUEL. Hopkins County. Pvt., Capt. William R. McGary's Co.; Pvt., Capt. Alney McLean's Co., KDM. Pensioned 16 Apr. 1823. Sen. Doc. 514.

HEWLIT, SAMUEL. Pvt., Capt. Alney McLean's Co.; WIA near New Orleans; married Rebecca Browder, in Muhlenberg Co., 4 Sept. 1817; served in War of 1812 from 20 Nov. 1814-20 May 1815. Hopkins County Pension List.

HICKMAN, JAMES L. Todd County. "He served his country in the tented field in the War of 1812, and for many years was a Magistrate of Todd County." He died 24 Aug. 1855, in his 67 year. Formerly a resident of Fayette County. C, 3 Sept. 1855. AG: Pvt., Capt. Nathaniel Hart's Co.

HICKS, REV. JOHN G. Fleming County. A veteran of 1812 and for a long time a local preacher of the M.E. Church, South He died 14 Sept. 1876, aged about 85. TK, 21 June 1876.

HIGHFIELD, LEONARD. Pvt., Capt. William Sebree's Co.; WIA 5 May 1813, at Fort Meigs. Pendleton County Pension List.

HIGHTOWER, JOSHUA. "Emigrated with his father, who was a Revolutionary hero, from Virginia to Jessamine County, Ky., in 1791; married there twice; first Miss Childs, second, Miss Spencer. He made thirteen trips to New Orleans on flat boats and walked back to Kentucky eleven times. Was a soldier in 1812, serving two terms, and participated in the siege of Fort Harrison and the Thames, Tippecanoe, and other bloody battles, and saw the dead chief, Tecumseh, on the battle field. He died [in Logan County?] April 27, 1876, in his 97th year." TK, 10 May 1876.

HOLEMAN, HARROD. Served through the War of 1812, with his brother William B. Holeman, q. v. He was at the battle of Tippecanoe and always claimed to have killed Tecumseh. See also William B. Holeman, below. Yeoman, 9 Nov. 1880.

HOLEMAN, WILLIAM B. Born in Shenandoah County, Va., 11 Jan. 1797; died at his home in Orange County, Florida, 21 Oct. 1880. He came to Kentucky at the age of 8 with his father, J. Harrod Holeman, and his brother, Harrod Holeman, above, and settled at Georgetown. The two sons served through the War of 1812 and after that conflict settled in Frankfort where they commenced publication of the Commonwealth. They were several times elected to the office of Public Printer. William B. Holeman married 11 Jan. 1823 Margaret P. Major, daughter of George Major. About 1875 William B. Holeman moved to Orange County, Fla., where he engaged in orange growing. He left his wife and four children: W. B. Holeman, of Evansville, Ind., Rev. F. R. Holeman, of Florida, Mrs. James M. Jones, of Whitley County, and an unmarried daughter living with her mother in Frankfort. Yeoman, 9 Nov. 1880.

HOLLIDAY, THOMAS. Fayette County. Attended 9th and 10th annual reunions, aged 80 at the last gathering, in 1875. Yeoman, 27 June 1874, 26 June 1875. AG: Pvt., Capt. Robert Hambleton's Co.

HOLTZCLAW, BENJAMIN. Lincoln County. Served in battle of New

Orleans. He died in Lincoln, in September., 1879, aged 92. (He was burried on September 8.) Yeoman, 16 Sept. 1879.

HOMES, SAMUEL. Falmouth, Ky. Attended 9th annual reunion, 1874, aged 92 years. Yeoman, 27 June 1874.

HOWELL, DAVIS. Montgomery County. Born Delaware, 12 Sept. 1797; died 16 April 1874; attended annual reunions of 1870 and 1873. TK, 22 June 1870; WC, 24 June 1873. AG: 3rd Sgt., Capt. William E. Young's Co., 27 Aug.-31 Oct. 1812; Pvt., Capt. John Crawford's Co., 26 Aug.-5 Nov. 1813.

HOWELL, MASON. Daviess County. A native of Daviess; a soldier of 1812. He died in (October), 1875 in Indiana where he was long a prominent legislator. He was 81 at the time of death. TK, 27 Oct. 1875.

HUDNUT, ELIAS P. Mason County. Attended annual reunions of 1873, aged 79; 1874-1876. WC, 24 June 1873; Yoeman, 27 June 1874, 26 June 1875; TK, 21 June 1876. AG: Pvt., Capt. John Baker's Co., KDM.

HUFFMAN, GEORGE. Served in Capt. Forrest's Co., KM; was living in Grant County when he applied for pension, 4 Feb. 1834, and was then 59 years of age. Montgomery County Pension List; Sen. Doc. 514.

HUNTER, JAMES. Franklin County. Capt., 17th Regt., U. S. Inf. He was living in Bracken County 14 Oct. 1829. He was Adjutant, Kentucky Mounted Rifles, 1811; Captain, 17th Infantry, 12 March 1812; honorably discharged 1 June 1814; received by resolution of Congress 13 Feb. 1835 the testimonial of a sword for being engaged in defense of Fort Stephenson. Heitman, v. i., p. 557.

HUTCHISON, WILLIAM. Harrison County. Attended 8th annual reunion, 1873; died before next reunion, June 18, 1874. Yeoman, 27 June 1874.

IRVINE, CAPT. CHRISTOPHER. A son of Col. William Irvine, who died at Richmond, Ky., 20 Jan. 1819. Captain Irvine was killed at Fort Meigs, 5 May 1813. Argus, 5 Feb. 1819.

ISGRIGG, DANIEL. Bourbon County. Born Baltimore, Md.; a soldier of the War of 1812; died at the residence of his son-in-law, John W. VanHook, 11 Feb. 1871, aged 84. TK, 15 Feb. 1871; C, 7 July 1871. AG: Sgt., Capt. Memorial Forrest's Co., KVM.

ISRAEL, WILLIAM. Campbell County. Mustered in at Cincinnati, April, 1812, as Pvt., Capt. John Ferris's Co., Ohio Malitia, for 6 months; attached to Regt. of Col. James Findley; injured 12 Sept. 1812. He was 89 years of age 19 Apr. 1864. Bourbon County Pension List.

JACK, HENRY. Fayette County. Pvt., Capt. Thomas Lewis's Co.; POW at the Rapids, 1813. Argus, 12 Feb. 1814.

JACKSON, GEN. JARVIS. Laurel County. He was 98 years of age in 1879. One of this name listed in AG as Lieut., Capt. James McNeil's Co., 2nd Regt., KM. Yeoman, 22 Mar. 1879.

JACKSON, JOHN. Franklin County. One of the old soldiers listed as having died, 8 Oct. 1875, aged 87; announcement made at annual reunion of veterans in June, 1876. TK, 21 June 1876.

JAMESON, JOHN. Ohio County. Attended 8th annual reunion, 1873, aged 80. WC, 24 June 1873.

JAMISON, BENONI. Harrison County. Served in Indian wars, 1791-94; enlisted in war of 1812 on 5 May 1813, as Pvt., Capt. John D. Thomas's Co.; WIA at Marietta, Ohio, May, 1813; pensioned 27 Apr. 1832. Harrison County Pension List; Sen. Doc. 514.

JANES, THOMAS. Pvt., Capt. Warfield Shirley's Co., KM, 23 Aug.-8 Oct. 1812; married Ann P. Golloher, in Adair County, 16 Nov. 1849; married first, Elizabeth Biggs. He was WIA at St. Mary's in Sept. or Oct., 1812. He died 12 June 1873 in Adair County. Henry County Pension List.

JEWELL, JOSEPH. Attended 8th annual reunion, veterans of the War of 1812, 1873, aged 80 years. WC, 24 June 1873.

JOHNSON, BENJAMIN B. Franklin County. "In early life he served his country honorably in the north-western army. He was appointed Postmaster of Frankfort, Ky., by General Jackson in 1829 and held this office until removed in 1840. He was a member of the Kentucky Legislature, 1841-44. He died at his Frankfort residence 10 Mar. 1848, aged 56 years." Yeoman, 17 Mar. 1848. AG: 1st Sgt., Capt. Robinson Graham's Co., KMVM.

JOHNSON, COL. JAMES. Scott County. Born Orange Co., Va., 1 Jan. 1774; moved to Kentucky, 1779; served as Lieut. Col., war of 1812, and commanded the right wing at the battle of the Thames. Elected to the U. S. Congress he died in office 13 Aug. 1826. R, Aug. 14, 21, 1826.

JOHNSON, MOORE. Mt. Sterling, Ky. Attended annual reunions of 1871, 1873-76, 1881 and 1883, being 88 years of age at the last meeting. C, 7 July 1871; WC, 24 June 1873; Yeoman, 27 June 1874, 26 June 1875, 20 June 1881, 21 June 1883; TK, 21 June 1876.

JOHNSON, THOMAS. Greenup County. Pvt., Capt. Coleman's Co.; POW at the Rapids, 1813. Argus, 12 Feb. 1814.

JOHNSON, GEN. WILLIAM. Scott County. Died 8 Feb. 1875, aged 77 years. Nine listings of this name in AG. Yeoman, 26 June 1875. (Probably not a soldier of the war of 1812 inasmuch as he would have been only 14 or 15 years of age at this time.)

JOHNSON, COL. WILLIAM. Scott County. He was the second son of Col. Robert Johnson. "He was one of those patriots . . . who fought in 1812; he commanded a battalion of the Kentucky militia and helped protect Fort Meigs from British and savage assaults, and was the first (with his battalion) of the troops

under General Clay who reached that place, 5 May 1813. He continued in the service six months." He died at his Scott county home Monday evening, 25 April 1814. Argus, 30 Apr. 1814.

JOLLY, JOHN. Born in Penna., 18 Apr. 1788; removed with his parents to Bourbon County, Ky., when two years of age; 1835 removed to Callaway County, Mo., where he died 14 July 1873, aged 85 years, 3 months. In the war of 1812 he served under Capt. Ellis, of Bourbon County, and fought until the close of the war. He drew a pension from 1871. TK, 6 Aug. 1873. AG: Sgt., Capt. Henry Ellis's Co., KVM, 10 Sept.-9 Oct. 1814. Other listings in AG.

JONES, LEROY. Boone County. Pvt., Capt. William Sebree's Co., Boswell's Regt.; enlisted 29 Mar. 1813; discharged I July 1813; wounded at storming of York, 1813; captured by Indians on his way home and taken to Malden; exchanged Aug., 1814; married, 23 Aug. 1813, at Burlington, Ky., Melinda Rosell. They had nine children. He died 9 June 1836 at Pleasant Run, Ky. Argus, 12 Feb. 1814; Boone County Pension List.

JONES, SAMUEL B. F. Fleming County. "A veteran of the war of 1812; died in Fleming County Tuesday evening, 6 Nov. 1883. He was at the battle of the River Basin and at Fort Meigs, and his age was 95." Yeoman, 10 Nov. 1883.

JONES, THOMAS. Paris, Kentucky. Born Fayette County, 19 Jan. 1792; his father was James Jones, a revolutionary soldier who was born about 1758 in Spottsylvania Co., Va.; his mother was Sallie Schooler, also of Virginia; Thomas Jones was a volunteer in 1812, a member of Col. Johnson's Regt. of cavalry; he was at the battle of the Thames. He married 22 Jan. 1814, in North Middletown, Patsey Ashurst, born 1787, a daughter of Josiah and Rebecca (Kennedy) Ashurst. Thomas Jones was 88 years of age in 1880. At that time he had four living sisters whose ages were: Mrs. Nancy Ashurst, of Scott County, 91; Mrs. Sallie D. Talbott, of Bourbon County, 78; Mrs. E. A. Scott, of Clark County, 76, and her sister, Miss Mary W. Jones, 85. Clark County Democrat, 20 Oct. 1880; Perrin. William H., History of Bourbon, Scott, Harrison and Nicholas Counties . . . Chicago, O. L. Baskin & Co., 1882, p. 474.

JONES, THOMAS. Fleming County. Pvt., Capt. Benedict Bacon's Co., 16th Kentucky Regiment; WIA 21 Jan. 1815. Fleming County Pension List.

JORDAN, MAJ. GEN. PETER R. Mercer County. He was a Captain in the war of 1812 and commanded a company of volunteers; after that service he held office in the Kentucky militia, and rose by regular grades from Captain to Major General; he was one of the Justices of Mercer for many years and sheriff of the county just prior to his death; elected to Kentucky Legislature in Aug., 1846. He died at his Mercer County home 10 Feb. 1848, "aged upwards of 70 years." Yeoman, 17 Mar. 1848. AG: Capt., Barbee's Regt., KM.

KARSNER, JOHN. Owen County. He was a volunteer in 1812 and was

wounded in the battle "in which the lamented Col. Dudley fell." He was living in Fayette County when he applied for increase in pension, for service as Pvt., Capt. John C. Morrison's Co., 9 Mar.-9 Sept. 1813. He died 29 Oct. 1853, in his 65th year. C, 22 Nov. 1853; Woodford County Pension List.

KEENE, GREENUP. "Doorkeeper to the lower house of the legislature. He served his country in the War of 1812." C, 15 Oct. 1850. One Greenup Keene, Scott County, was born there, 1791. His ancestors were from England and settled originally in Maryland. He was a son of S. Y. Keene and died in 1875. Perrin, op.cit., p. 600.

KELLY, SAMUEL. Clark County. Enlisted in Aug., 1812, as Musician, Capt. Wiley R. Brassfield's Co.; applied for pension 20 May 1834, aged 47. Sen. Doc. 514; Trimble County Pension List.

KENADY (KENEDY), DAVID. Enlisted at Newport, fall of 1814, in Capt. Edward Whaley's Co.; pension transferred to Clark County, Indiana. *Harrison County Pension List*.

KENDALL, REASON. Henry County. Pvt., Capt. William M. Rice's Co.; POW at the Rapids, 1813. Argus, 12 Feb. 1814.

KENEDY, DAVID. (See David Kenady above). Harrison County. Pvt., Capt. Michael Wolf's Co., Ist Regt., KMM; pensioned 10 May 1834. Sen. Doc. 514.

KENDRICK, MITCHELL. Scott County. Enlisted 29 Mar. 1813 as Pvt., Capt. John D. Thomas's Co., Boswell's Regt. In 1853 he was living in Brown County, Illinois, aged 63. Scott County Pension List.

KENNEDY, JESSE. Bourbon County. Born 11 Aug. 1787 on Kennedy's Creek, Bourbon County, on the farm settled in 1785 by his father Thomas Kennedy "who redeemed it from a wilderness and transmitted his name to the stream which ripples through it, after he had lived several years in the fort at Boonesboro—had assisted Capt. Strode in building Strode's Station and had with Michael Stoner cleared and planted 'Stoner's field' noted in the early annals of Kentucky." Jesse Kennedy in 1812 commanded a brigade of Pack horses in the service of his country. In 1813 he was appointed a constable of Bourbon, holding that office for six years; as early as 1819 and for several years thereafter he was a contributor of learned articles to *The Western Citizen*; later he was a Justice for Bourbon and in 1829, 1831-32, 1841, elected to the Kentucky Legislature. He died 3 April 1863, in his 76th year. C, 15 Apr. 1863.

KENTON, THOMAS. Robertson County. Only survivor (in 1879) of Capt. Moses Dimmet's Co., war of 1812. Yeoman, 12 Aug. 1879.

KILGORE, WILLIAM. Caldwell County. Named at annual reunion, 1875, as having died in April of that year, aged 82. Yeoman, 26 June 1875.

KING, DAVID. A sharpshooter in the war of 1812 credited by William Poe, q.v., with the killing of Tecumseh. Yeoman, 11 Feb. 1875. There was a David King in Capt. James Davidson's Co., Col. Richard M. Johnson's command. (See John King, below, also credited with slaying Tecumseh).

KING, JOHN. Credited with the slaying of Tecumseh. When the Indian's body was examined it was found to contain two rifle bullets of the same size, and matching by weight the gun used by Col. William Whitley, killed in the battle. It was said by survivors that John King picked up Whitley's rifle as the latter fell from his horse, and added a second charge, not knowing that the gun was loaded. This accounted for the two balls in the Indian's body. John King's claim was borne out by Col. James Davidson, q.v. King was buried "on the farm of Squire J. S. Murphy, three miles south of Frankfort." Yeoman, 14 June 1881.

KING, GENERAL JOHN EDWARDS. Cumberland County. Enlisted 13 Aug. 1813; served as Brigadier General at the battle of the Thames. He died at Burkesville, Kentucky, in June, 1828. R, 25 June 1828.

KING, PHILIP. Bracken County. 1st Lieut, 17 U. S. Inf. His pension application rejected 19 Jan. 1830 due to his good health. He married 4 Dec. 1841, in Bracken County, Margaret Kendall, who was living at Dover, Kentucky, in 1866, aged 65. Her husband died 28 July 1862. Bracken County Pension List.

KINGERY, JOSEPH. Monroe County. Pvt., Capt. Henry Yakey's Co., 3rd Regt., KDM. He was pensioned 27 July 1824. Sen. Doc. 514.

KNOWLES, THOMAS. Served eighteen months, from 12 July 1812 in 2nd Regt., U. S. Light Dragoons; he was then 24 years of age; also Pvt., Capt. Samuel G. Hopkins's Co.; WIA 30 July 1813; moved to Polk County, Mo., 1847, and was living there 16 Dec. 1854. Shelby County Pension List.

LACEY, MAJOR WALTER. Mason County. Ensign, 29th Regt. (Mason County) 17 May 1814; Adjutant same unit, 4 June 1814. He died Aug. (?) 1833, "an old and highly respectable citiben." C, 6 Aug. 1833; Commissioned Officers of the War of 1812-1816, MS, Kentucky Historical Society.

LAMB, JOHN. Mason County. Attended annual reunions of 1873-1876, being 85 at the time of the last meeting. WC, 24 June 1873; Yeoman, 27 June 1874, 26 June 1875; TK, 21 June 1876.

LANKHART, JOSEPH. Fayette County. Attended 6th annual reunion, 1871, aged 80 years. C, 7 July 1871.

LASHBROOK, PETER. Mason County. Attended annual reunions of 1873-1876, was 83 years of age at last meeting. WC, 24 June 1873; Yeoman, 27 June 1874, 26 June 1875; TK, 21 June 1876.

LEE, ZACHARIAH. "A soldier in the last war and served faithfully on the Canadian frontier." He died 17 July 1862, aged 76 years and 7 months. C, 1 Aug. 1862.

LEER, M. Attended 8th annual reunion, 1873, aged 84 years. WC, 24 June 1873.

LEFARGE, AYRES. Popular Plains, Ky. Listed in AG as Airs Leforgy, Pvt., Capt. George Matthews's Co., KMV ,commanded by Col. John Donaldson. Lefarge stated that a soldier by the name of Gealding killed Tecumseh. Ayers Lefarge died at Popular Plains in May or June, 1881. Yeoman, 14 June 1881.

LEWIS, MAJOR J. A. Boyle County. One Jaqualine A. Lewis listed in AG as Pvt., Capt. George Murrell's Co., KMM. He died 18 June 1874, aged 88. Yeoman, 26 June 1875.

LEWIS, JOHN, of Llangollen. Born 25 Feb. 1784, son of Col. Zachary Lewis, of Belair, Spottsylvania Co., Va. In 1812 he was in command of a troop of horses and entrusted with watching the movements of the British Fleet in the Potomac. He removed to Kentucky in 1832, settling in Georgetown, where he estabilished a female academy. He died in Frankfort, 15 Aug. 1858. Biographical account in C, 18 Aug. 1858.

LEWIS, LEROY. Harrison County. A soldier of the war of 1812; died in March (?), 1871. TK, 22 March 1871.

LINDSAY, THOMAS. Fayette County. Born Culpepper County, Va., 10 May 1789; attended annual reunions of 1870-71, and the 8th meeting, 1873; died before the reunion of 1874. TK, 22 June 1870; C, 7 July 1871; WC, 24 June 1873; Yeoman, 27 June 1874.

LUCKETT, MAJOR BENJAMIN. Frankfort, Ky. He held several offices in Franklin County and was a soldier in the war of 1812. He died at his Frankfort residence, 17 June 1866, at a very advanced age. Yeoman, 18 June 1866. AG: 2nd Sgt., Capt. Isaac Cunningham's Co., KMM.

McAFEE, COLONEL GEORGE. Mercer County. "During the late war he was with the army on the frontiers of Indiana and Illinois; in 1813 he volunteered as a private in Col. Johnson's regiment of mounted riflemen; was shortly after promoted and was in the front of the Battle of the Thames, October 5 of that year; again in the fall of 1814 he commanded a company in Col. Slaughter's regiment, descended to New Orleans and was in the ever memorable battle of 8 January 1815." He died at his residence on Salt River, in Mercer County, 28 May 1819, in his 42nd year. Argus, 11 June 1819.

McAFEE, GENERAL ROBERT B. "He was among the first born of Kentucky's citizens, and lived and died near the spot of his birth... He served a campaign in the North Western Army in the war of 1812, and afterwards wrote the history of that war. He served many years in the Legislature of this State, being repeatedly elected to both branches. He was elected Lt. Governor of the

State [1824-1828]." Yeoman, 22 Mar. 1849. His account of the war of 1812 was History of the Late War in the Western Country... Worsley & Smith, Lexington, Ky., 1816. In volume 25 (1927) of The Register of the Kentucky Historical Society was published his The Life and Times of Robert B. McAfee and his family and connections. Written by himself. Commenced April 23rd, 1845, and in volume 29 (1931) his The History of the rise and progress of the first settlement on Salt River and the establishment of the New Providence Church.

McBRAYER, ANDREW. Anderson County. An early emigrant to Kentucky; was at McAfee's Station when it was beseiged; served "his country in the field and its councils and was elected to the Legislature" [1829, 1838]. He is listed in AG as 1st Cpl., Capt. Edmond Bacon's Co., KMV. He died 16 May 1839, in his 62nd year. C, 21 May 1839.

McCARTHY, Squire JOHN. Mason County. Attended annual reunions of 1873-74, 1876, aged 85 years at his last meeting. He died at Maysville 23 May 1880. Yeoman, 1 June 1880, 24 June 1876, 27 June 1874; WC, 24 June 1873.

McCLAIN, JOHN. Butler Station, Pendleton County. Attended 9th annual reunion, 1874, aged 79 years. Yeoman, 27 June 1874.

McCONNELL, EDWARD. Bourbon County. Enlisted 15 Aug. 1812 at Georgetown, as Pvt., Capt. Maurice Langhorne's Co.; later promoted to 1st Sgt.; WIA at Raisin 18 Jan. 1813. Bourbon County Pension List.

McCONNELL, JOSEPH. Bourbon County. Farrier in Capt. William Gar-rard's Co.; WIA 18 Dec. 1812, at the Missionary Towns. Caldwell County Pension List.

McDOWELL, COLONEL JAMES. Fayette County. An officer in the Revolution and served throughout the war of 1812 with his son, Capt. John Lyle _McDowell, below. "The father of Col. James McDowell fought at Braddock's Defeat and was an officer in the Revolution; his father fell in Indian warfare [Foote, in his *Annals*, says he was the first white man killed in the valley of Virginia.]" Col. James McDowell married Mary Lyle. Yeoman, 2 Jan. 1879.

McDOWELL, CAPTAIN JOHN LYLE. Born Aug., 1794, in Fayette County; served throughout the war of 1812 with his father, Col. James McDowell, above. Captain John Lyle McDowell was an elder for many years in the First Presbyterian Church, Lexington. He died 23 Dec. 1878, at the Franklin County home of his son-in-law, Capt. Samuel Steele, in his 85th year. Yeoman, 2 Jan. 1879.

McELROY, JAMES. Lincoln County. Served in Capt. Kerr's Co.; POW at the Rapids, 1813. Argus, 12 Feb. 1814.

McFARLAND, ROBERT. Bethel, Bath County. Attended annual reunions of 1874-76, aged 82 years at his last meeting. Yeoman, 27 June 1874, 26 June 1875; TK, 21 June 1876. AG: Pvt., Capt. Samuel Gooden's Co., KVM.

McGOODWIN, MAJOR J. K. Boyle County. Attended annual reunion of

1871, aged 80 years; died 26 Jan. 1875. C, 7 July 1871; Yeoman, 26 June 1875. AG: James McGoodwin listed as Pvt., Capt. William Whitsett's Co., KMM.

McHATTON, JAMES. Owen County. Enlisted in Scott County, March, 1813, as Cpl., Capt. John Duvall's Co., KDM. He moved from Scott to Owen County in 1829. Owen County Pension List.

McHATTON, GENERAL ROBERT. Major, 77th Regt., Kentucky Militia, 1816. He was born in Fayette County 17 Nov. 1788 and died in Marion County, Indiana, 20 May 1835. C, 30 May 1835. No record of service in war of 1812.

McKEE, JOHN. Franklin County. Born Rockbridge County, Va., 21 Oct. 1787; brought to Kentucky in 1790, settling in Woodford and removing to Franklin County in 1808; married, 1812, Elizabeth Crockett, daughter of Col. Anthony Crockett; "at the beginning of the war of 1812 he was one of the volunteers who marched to the relief of Vincennes and the Wabash River country." He died 24 Feb. 1875, aged 87 years, four months and 4 days. Yeoman, March 2, 4, 1875.

McLEER (McLEAR), FRANCIS. Fayette County. Born in Ireland 16 May 1789; came to Lexington, Kentucky, from Philadelphia in 1814. Attended annual reunions of Kentucky veterans, war of 1812, in 1870, 1874 and 1875. TK, 22 June 1870; Yeoman, 27 June 1874, 26 June 1875. Service probably in Pennsylvania.

McMANAWAY, GEORGE. Enlisted 1813 in Capt. Mosby's Co., 28th Regt., U. S. Inf. to serve on board Commodore Perry's squadron on Lake Erie; WIA 20 Sept. 1813; reenlisted 1815; discharged 1815. Garrard County and Fayette County Pension Lists.

McMICKLE, ROBERT. Lincoln County. Served in Capt. Coleman Collier's Co., enlisting 15 Aug. 1812; WIA 15 Jan. 1812, "at Camp No. 3 below Fort Defiance on the Miami of the Lakes." Discharged 21 Feb. 1813. He moved to Missouri. Gallatin County Pension List; Sen. Doc. 514.

McMILLIN, JOHN. One of the last three veterans of 1812 living in Lincoln County in Sept., 1879. Yeoman, 16 Sept. 1879. AG: 1st Lt., Capt. James Coleman's Co., KMI.

McMILLIN, WILLIAM. Fayette County. Pvt., Capt. Thomas Lewis's Co.; POW at the Rapids, 1813. Argus, 12 Feb. 1814.

McROBB, WILLIAM. Mason County. "Satisfactory evidence was adduced to the Mason County Court to show that Joseph Robb is father to and legitimate heir at law of William Mac or McRobb, late a soldier in the Army of the U. S., who enlisted with Capt. Henry R. Graham in Washington, Mason County, Ky., on 13 May 1812 for five years and died whilst in the service of the U. S., which is ordered to be certified to the Secretary of War." Mason County Court Order Book I (Feb. Court, 1818) p. 175.

MADDOX, CAPT. WILSON. Shelby County. Listed in Commissioned Officers of the War of 1812-16, MS, as promoted from Ensign in 85th Regt., com-

manded by Lt. Col. George Wilcox, 18 May 1813. He died 12 June 1853, in his 73rd year. C, 21 June 1853.

MAHAN, FRANCIS. Campbell County. Pvt., Capt. William Sebree's Company; POW at the Rapids, 1813. Argus, 12 Feb. 1814.

MAHANAH, JOHN J. Enlisted 5 July 1808 in New London, Conn., 4th Regt., U. S. Inf.; after the war he lived in Vermont, Ohio and had his pension transferred to Bath County, Ky., 4 March 1818. He also lived in Scott and Owen counties. Scott County Pension List.

MAJOR, CAPTAIN THOMAS P. Came to Kentucky in early youth, residing here about 50 years. "In 1811 . . . he equipped himself and started off to the scene of action, met some others at Louisville and with these tendered his services to Governor Harrison; was present at the battle of Tippecanoe; again volunteered for twelve months service and joined Col. Johnson's regiment of mounted men and witnessed the termination of the war in the Northwest by the brilliant victory at the Thames." He died at his residence near Frankfort 18 July 1850, in his 68th year. C, 6 Aug. 1850.

MANGUM, LEWIS. Campbell County. Pvt., Capt. Posey's Co., U. S. Inf.; injured 7 Nov. 1811 at Tippecanoe. Campbell County Pension List.

MANWARING, GEORGE. Scott County. Served in the U. S. Artillery; his pension began in New York, 17 Feb. 1815; transferred to Scott County, Ky., 23 July 1817. Scott County Pension List.

MARKS, CAPTAIN HASTINGS. Clark County. "Joined the North-Western Army under General Wayne at the same time with the lamented Harrison. Their commissions were of the same date and they drew for rank; acted with bravery at Fort Recovery and in the battle of the Rapids, which terminated the war; served under Harrison in the last war." He died 27 Feb. 1843, in his 73rd year. C, 7 Mar. 1843. AG: Pvt., Capt. John Martin's Co., Lewis's Regt.

MARTIN, ARMISTEAD. Montgomery County. Attended 6th annual reunion, 1871, aged 85 years. C, 7 July 1871.

MARTIN, NIMROD. Woodford County. A soldier of 1812; attended 10th annual reunion, 1875; died at his residence near Midway, 26 Nov. 1876, aged 83; buried Versailles on Monday, 27 Nov. 1876. Yeoman, 7 Dec. 1876; 26 June 1875.

MARTIN, ROBERT E. Clark County. Born there 1 Feb. 1794; attended annual reunion of 1870. TK, 22 June 1870. AG: Pvt., Capt. James Sympson's Co., KMVM.

MASON, CAPTAIN JOHN. Montgomery County. Born Virginia, 29 Feb. 1776; Lieut. in Henry Daniel's Co., war of 1812; died in Oct., 1855. Reid, Richard, Historical sketches of Montgomery County (1926) p. 63.

MASTERSON, JOHN. Mason County. Died between annual reunion of 18 June 1875 and that of 19 June 1876. TK, 21 June 1876.

MAYFIELD, SOUTHERLAND. Pvt., Capt. Robert Edwards's Co.; transferred to Capt. Richard Hightower's Co., 17th Regt., U. S. Inf.; in battles of River Raisin; POW 22 Jan. 1813. He married Amelia Story, 30 Nov. 1824. He died 31 Aug. 1852. Shelby County Pension List.

MAYHALL, JOHN. Franklin County. Born 23 Apr. 1792; died 20 June 1862 and buried in Jackson Burying Ground, on the Louisville road near Frankfort. He was one of 13 of Capt. Paschal Hickman's Co. who survived the battle and massacre at Raisin.

MAYHALL, TIMOTHY. Franklin County. "He was a volunteer under Gen. Wayne in the early days of the West, and was again a volunteer under Gen. Harrison in the last war." He died 29 Feb. 1840 in his 66th year. C, 3 Mar 1840.

MAYHALL, WILLIAM. "One of the oldest residents of Frankfort; a native of Kentucky when our country became involved in the war of 1812, he was one of the first to march." He died 14 Nov. 1860, aged 84 years. C, 19 Nov. 1860.

MEEK, ADAM R. Decatur County, Ill. Attended 6th annual reunion, Kentucky veterans of 1812, aged 82 years. C, 7 July 1871. AG: Pvt., Capt. Thomas Metcalfe's Co., KDM.

MEENACH, ALEXANDER. Mason County. Born Cumberland County, Pa., 1781; emigrated to Mason County, 1784, with his father James Meenach. "Served in the war of 1812 with his five brothers, and is supposed to have been a member of Capt. Joshua Baker's company." He died in Aug., 1879. Yeoman, 12 Aug. 1879.

MEENACH, JAMES. Mason County. Born in Pennsylvania; came to Bourbon County, Ky., with his parents, 1794; learned the hatter's trade in Millersburg, 1800. A soldier of the war of 1812. He died in March, 1876, aged 99 years. TK, 10 May 1876.

MEFFORD, JOSEPH. Pvt., Capt. Bacon's Co., Col. Francisco's Regt., KVM. His wife, Margaret Mefford, received a land warrant of 40 acres. Franklin County Pension List.

MELVIN (MILLION), RODNEY. Madison County. Pvt., Capt. Christopher Irvine's (James Dyametto's) Co.; POW 5 May 1813. Argus, 12 Feb. 1814.

MENIFEE, R. P. Kenton County. Attended 6th annual reunion, 1871, aged 82. C, 7 July 1871. AG: Capt., Donaldson's Regt., KVM.

MILLER, COLONEL JOHN. Scott County. "A veteran of two wars." He died 3 Feb. 1853, aged 86 years, 7 months and 28 days. C, 15 Feb. 1853.

MILLION, RODNEY. See Rodney Melvin.

MITCHELL, JOHN. Woodford County. A soldier of the war of 1812. His parents emigrated to Kentucky in the fall of 1779. In his youth he was a soldier and noted huntsman. He died 5 Aug. 1841, aged 75 years, 7 months and 14 days. C, 24 Aug. 1841.

MONTZ, WILLIAM, SR. Born in Pennsylvania, June 14/July 4, 1787; an old soldier of the war of 1812; died at Louisville 1 Nov. 1869. C, 5 Nov. 1869; National Society U. S. Daughters of 1812, No. 98.

MOORE, BENJAMIN. Harrison County. Attended annual reunions of 1873-1876, aged 85 at his last meeting. He lived at Cynthiana. WC, 24 June 1873; Yeoman, 27 June 1874, 26 June 1875; TK, 21 June 1876.

MOORE, DANIEL (or DAVID?). Edmonson County. "A native of the Old Dominion; a soldier of the war of 1812; he lived in celibacy until he had considerably passed his 80th year, when he married an aged lady by the name of Roundtree; died in March, 1876, aged 94 years." TK, 10 May 1876.

MOORE, R. L. Greensburg, Ky. Attended 5th annual reunion, 1870, aged 74 years. He was born "west of Boyle County." TK, 22 June 1870.

MOORE, COLONEL THOMAS P. "Born Mercer County, 1796. As early as 1812 while yet a minor he volunteered in the service of his country, and conducted himself gallantly during the war. In 1814 he was in command of a company on the northern frontier; he was thrice married; died 21 Sept. 1853." C, 2 Aug. 1853.

MORRIS, CALEB. Harrison County. Native of Virginia; emigrated to Kentucky when a young man; died 1870, his wife in 1826. (She was Eliza Northcutt.) *Bourbon*, *Scott*, *Harrison*, *etc.*, p. 480.

MOSBY, MICAJAH. Mercer County. Born 3 Sept. 1773; an old soldier of the war of 1812. "He knew Governor Shelby well and told of 'posum hunts which they took together." He died in Oct., 1875, aged 102 years, 1 month and 6 days. TK, 20 Oct. 1875; Yeoman, 22 Feb. 1873. AG: Pvt., Capt. Robert Paxton's Co., KDM.

MOSELEY, COLONEL JOHN. Jessamine County. A native of Virginia, he emigrated to Kentucky in 1776; served with 9th Regt., of Jessamine County. He died 9 Jan. 1847, aged 81 years and a few days. OR 27 Jan. 1847.

MOTHERSHEAD, NATHANIEL. Served in the war of 1812 and enlisted at Independence, Mo., 12 June 1847, for service in the Mexican War. He was then about 68 years of age. He volunteered for service in 1812 in Dec., 1812, in Westmoreland County, Va., where he then resided. He was living in Oldham County, Ky., in 1836. Scott County Pension List.

MULDROW, COLONEL A(NDREW). Woodford County. One of this name was Lieut., Capt. William Crouch's Co., KMVM, 12 Sept.-Oct. 20, 1812. He died 24 Aug. 1829. R, 26 Aug. 1829.

MURPHY, PETER. Pvt., 17th U. S. Inf.; lost his right eye at "Dudley's Defeat." Fayette County Pension List.

MYERS, GEORGE. Served in Capt. Robert McAfee's Co., war of 1812. Yeoman, 16 Oct. 1877.

NEWELL, HUGH. Harrison County. "A soldier of 1812 and was at the

battles at Frenchtown on the River Raisin; served repeatedly in the Legislature, was four years a State Senator and was a member of the Convention which formed the present Constitution of Kentucky; he was a native of Bourbon but was for 80 years a resident of Harrison County." He died 13 Sept. 1875, in his 85th year. Yeoman, 18 Sept. 1875.

NEWLAND, BENJAMIN S. Shelby County. Attended 6th annual convention, 1871, aged 84 years. C, 7 July 1871. AG: "Benoni S. Newland" was Pvt., Capt. William E. Young's Co., 1st Regt., Ky. Light Dragoons.

NEWTON, JAMES. Adjutant, Porter's Regt., KM, war of 1812. Yeoman, 9 Nov. 1878.

NICHOLAS, MAJOR CAREY. One of this name Capt. of a company in 7th Regt., U. S. Inf., commanded by Elijah Montgomery, Jan., 1814. Major Nicholas died in Tallahassee, Fla., May 1829. R, 3 June 1829.

NICHOLS, ERASMUS. Lexington, Kentucky. Born Pennsylvania, 1790; attended 5th annual reunion of Kentucky veterans, war of 1812, in 1870, aged 86 years. TK, 22 June 1870. AG: Pvt., Capt. William Hutchinson's Co., KMVM.

NOEL, LITTLEBERRY. Boone County. "A soldier of the last war and one of the few survivors of Dudley's Defeat, and was in the campaign of Gen. Jackson." He died 23 Mar. 1846, in his 70th year. C, 28 Apr. 1846.

NORRIS, CAPTAIN JOHN. Petersburg, Boone County, Kentucky. "He was a soldier of the war of 1812, and participant in Commodore Perry's victory, Sept. 10, 1813. He was a native of Maryland, born 13 April 1791. He removed to Mason County, Ky., with his parents when eight years old. At the age of 20 (in 1813) he enlisted from Mason County in Captain Payne's Co., and was assigned to Colonel Johnson's regiment. He was one of 20 who volunteered to take part in the celebrated naval battle on Lake Erie, Sept. 10, 1813, and was ordered to duty on the ship Caledonia. He was selected for superior marksmanship and bravery to take post in the maintop of his ship as sharpshooter; but before being ordered to his post, that enviable place was shot away, and fell to the decks. He assisted in the management of the guns, and actually fired the last shot, which caused the enemy, His Majesty's ship Hunter, to strike her flag. Young Norris was one of 20 men selected as a picked crew to take charge of the captured vessel. They found her in a sinking condition, but by hard work at the pumps, brought her to port, and later received \$300. as prize money. The engagement lasted three and one-half hours, and the Hunter was literally riddled. This battle decided the contest with Great Britain on the Lakes, and Mr. Norris returned home and married. Six children were born to him, three of whom were living at the time of his death. Several years ago there was an effort made to gather together all the survivors of Perry's victory, at Put-in-Bay, and only four could be found. Since that time all have died, Mr. Norris being the last to pass away. The Legislature of Kentucky, on 17 Feb. 1860, directed the Governor to procure four gold medals—one each for James Artus, Dr. William T. Talliaferro, John Tucker, and John Norris, "as survivors of the Kentucky volunteers, who, with such ready alacrity and heroism" assisted Perry in achieving his glorious victory." He died in January (?), 1879 in his 88th year. Yeoman, 11 Jan. 1879.

NORTHCUTT, BENJAMIN. Bourbon County. Born in Frederick Co., Va., 1790 and at the age of 8 removed with his father, Jeremiah Northcutt, Revolutionary soldier, to Bourbon County, Ky. He lived here until his removal in 1852 to Missouri. He was a soldier of 1812, in Col. R. M. Johnson's regiment, and was at the battle of the Thames. He died at Columbia, Mo., residence of his daughter Mrs. Julia Jones, 21 Dec. 1874, aged 85 years. He left four children, three daughters and one son, T. M. Northcutt, of Columbia, Mo. TK, 20 Jan. 1875.

NORTON, ARNEY. Attended 6th annual reunion, 1871. C, 7 July 1871. NORTON, JAMES. Served in the Revolution and "in the war with the Indians in the Northwest." He died in Nicholas County, 21 Oct. 1857, aged 96 yeares. C, 6 Nov. 1857, AG: Sgt., Capt. William Farrow's Co., 3rd Rgt., Kentucky Mounted Riflemen.

NORVELL, JOHN. Born Garrard County; fought in 1812; was editor of the Kentucky Gazette. He died 24 Apr. 1850, aged 58. S, 1-5, 8 May 1850.

NUNLEY, ROBERT. Fayette County. Enlisted at Lexington 15 Aug. 1812, in Capt. John Edmiston's Co.; married 14 June 1814, Sarah Davis, daughter of John Davis. He was placed on pension rolls 13 Dec. 1823. He died 24 Jan. 1852. Scott County Pension List; Sen. Doc. 514.

NUNNALLY, ROBERT. See Robert Nunley.

OAKLEY, THOMAS. Bath County. Pvt., Capt. George Pugh's Co. Captain Pugh and William Manley, of the same company, heard Thomas Oakley's will 9 Feb. 1813, at Camp at the foot of the Rapids; will probated 12 Apr. 1813, in Bath County Court. Bath County Court, Will Book A, p. 33.

OVERTON, THOMAS J. 1st Lieut., 17th U. S. Inf.; KIA January 22, 1813, at Frenchtown. *Heitman*, v. 1, p. 763.

OWENS, JOHN. Pulaski County. His death announced at annual reunion of veterans, 1875; died 18 Apr. 1875, aged 84. TK, 28 Apr. 1875; Yeoman, 26 June 1875.

OWINGS, COLONEL THOMAS DEYE. Colonel, 28th Inf., 11 Mar. 1813; honorable discharge, 15 June 1815. He died at his residence in Brenham, Texas, 6 Oct. 1853, aged 77 years. C, 22 Nov. 1853; Heitman, v. 1, p. 764.

PARKER, JOHN E. Athens, Fayette County. Attended annual reunions of 1871, 1873-1875, aged 80 at his last meeting. C, 7 July 1871; WC, 24 June 1873; Yeoman, 27 June 1874, 26 June 1875.

PATTEN, WILLIAM. Harrison County. Attended 6th annual reunion, 1871, aged 76 years, C, 7 July 1871.

PARKER, MAJOR THOMAS. Lewis County. Died 9 Feb. 1853, in his 83rd year. Two listings in AG but 1812 service not proved. C, 22 Feb. 1853.

PARKS, MOSES. Mercer County. He was born and reared within a few miles of where he died. "Parksville" was named in his honor. He died in Oct., 1866, aged 77 years. Yeoman, 23 Oct. 1866. Two lisings of this name in AG.

PATTERSON, JOHN. Jessamine County. "An old citizen soldier of 1812."

He died 10 Apr. 1870. TK, 20 Apr. 1870.

PAUL, HOSEA. Attended annual reunion of Kentucky veterans of 1812, from Aberdeen, Ohio, in 1876. He was then 85. TK, 21 June 1876.

PAXTON, JOSEPH. Pvt., Capt. Leslie Comb's Co.; WIA at Fort Meigs 1 May 1813; served until 28 Sept. 1813; married Minty Paxton, in Greene County, Mo., 16 June 1844. He died in Dade Co., Mo., 15 May 1850. Campbell County Pension List.

PAYNE, ASA. Payne's Depot, Scott County. Born there 1788; was aide to his father, Gen. John Payne, war of 1812; attended annual reunions of 1870-1871, 1874, aged 86 at his last meeting. TK, 22 June 1870; C, 7 July 1871; Yeoman, 27 June 1874.

PAYNE, INNIS B. Campbell County. Attended annual reunions of 1871, 1874-1876, aged 83 at his last meeting. C, 7 July 1871; Yeoman, 26 June 1875,

27 June 1874; TK, 21 June 1876.

PAYNE, JUNIUS. Newport, Kentucky. Born Mason County, 21 Oct. 1793; attended annual reunions of 1870, 1881. (Also listed as Enos Payne.) TK, 22 June 1870; Yeoman, 20 June 1881.

PAYNE, CAPTAIN WILLIAM. Franklin County. Served in war of 1812;

died in Jan., 1871, aged 84. TK, 25 Jan. 1871.

PENDLETON, GENERAL EDMUND. Clintonville, Bourbon County. Attended annual reunions of 1873-1876, aged 87 at the last meeting. WC, 24 June 1873; Yeoman, 8 Aug. 1874, 26 June 1875; TK, 21 June 1876.

PENN, JOHN. His death announced at annual reunion of veterans, 1875;

died 18 Mar. 1875, aged 79. Yeoman, 26 June 1875.

PENNY, CAPTAIN JOHN, JR. Anderson County. "During the progress of the late war with Great Britain, he gave ample proofs of his devotion to his county by entering personally into her most active service." He died in Rockcastle County, 20 Feb. 1827, in his 29 year. He was a son of the Reverend John Penny. He left a widow and several small children. Argus, 7 Mar. 1827.

PERKINS, JOHN. Garrard County. Pvt., Capt. John Yantis's Co.,; POW

at the Rapids, 1813. Argus, 12 Feb. 1814.

PERRIN, DR. GEORGE H. Cynthiana, Kentucky. Served in 1814 in 16th Regt., commanded by General McArthur; attended annual reunions of Kentucky veterans, 1871, 1873-76, 1881, 1883, aged 89 at his last meeting. C, 7 July

1871; WC, 24 June 1873; Yeoman, 27 June 1874, 20 June 1881, 21 June 1883; TK, 21 June 1876.

PIATT, JOHN H. Furnished commissary stores to the Northwestern Army; a long standing claim for moneys involved during his services to the army was decided in favor of the heirs in 1875. The sum recovered was \$131,508. TK, 26 May 1875.

PIATT, SALEM. Lexington, Ky. Died in January, 1813, from a wound received at Mississinewa, 17 Dec. 1812. A public demonstration was held for him, and Henry Riddle, in Lexington on 22 Feb. 1813. Kentucky Gazette, 26 Feb. 1813.

POE, WILLIAM. "An octogenarian of Holt Co., Mo., who stated that a sharpshooter named David King killed Tecumseh. Poe was in the fight when the 'big Injun' was killed, in the battalion commanded by Col. Richard M. Johnson." Yeoman, 11 Feb. 1875

POINDEXTER, MAJOR JOHN. Christian County. A soldier of 1812; died 21 Jan. 1877, aged 85 years. His wife died four days later, aged 79. Yeoman, 30 Jan. 1877.

PORTER, COLONEL JOHN. Butler County. "A soldier of the Revolution; member elect of the Legislature; served with the 66th Regt., war of 1812; died 24 Sept. 1833, aged 74 years." OR, 17 Oct. 1833.

PORTWOOD, JOHN. Nicholasville, Kentucky. Born Madison County in Nov., 1787; attended annual reunions of 1870-71, 1874-76, aged 88 years at the time of the last meeting. TK, 22 June 1870, 21 June 1876; C, 7 July 1871; Yeoman, 27 June 1874, 26 June 1875.

POWELL, CHARLES. Washington County. A soldier of 1812; died in June (?), 1876, aged 84 years. TK, 5 June 1876. AG: Pvt., Capt. Robert Burnet's Co., Barbee's Regt.

POWERS, ANDERSON. Bridgeport, Franklin County. "A soldier of the war of 1812, and fought at New Orleans; died 1 Jan. 1878, one day shy of 84 years." (Frankfort, Ky.) Weekly Roundabout, 5 Jan. 1878: see also Yeoman, 15 Jan. 1878 for obituary of Powers and sketch of the battle of New Orleans. AG: 1st. Cpl., Capt. George McAfee's Co., KDM.

PRESTON, WILLIAM. Campbell County. "A soldier of the war of 1812 and his wife who have lived together for 60 years do all their work and are as sprightly as new beginners." TK, 3 Mar. 1875.

PREWITT, ROBERT HURT. Enlisted Jessamine County, as Pvt., Capt. Richard Hightower's Co., 17th Regt., U. S. Inf. He was born in 1791 and died in 1845. National Society Daughters of 1812, Kansas, No. 12739.

PREWITT, CAPTAIN VANALLEN. Scott County. Ensign, Capt. John

Edmiston's Co., 1st Rifle Regt., 15 Aug.-14 Oct. 1812. He died in Feb., 1826. R, 20 Feb. 1826.

PREWITT, GENERAL WILLIAM C. Fayette County. Appointed Lieut., 8th Regt., Lt. Col. Dudley commanding, 2 Sept. 1812; he died 21 Sept. 1854. C, 25 Sept. 1854.

PRICE, CAPTAIN RICHARD. 2nd Lt., 28th Inf. U. S., 30 June 1813; Adjutant, Aug. to Nov., 1813. He died 11 Nov. 1813, in service, a few days after returning to Cincinnati from the Northwest Army. He married in 1801 Hannah Upshaw, daughter of Col. John Upshaw, of Essex Co., Va., in whose house she was married. She died in March, 1853, in her 79th year. C, 29 Mar. 1853; Argus, 20 Nov. 1813; Heitman, v. 1, p. 806.

PRIEST, DANIEL. Sideview, Montgomery County. Attended annual reunions of 1873-1876, aged 81 years at his last meeting. WC, 24 June 1873; Yeoman, 27 June 1874, 26 June 1875; TK, 21 June 1876. AG: Pvt., Capt. Benjamin Warfield's Co., 20 May-19 Nov. 1813.

PRICHARD, BENJAMIN B. Montgomery County. Pvt., Capt. Samuel Williams's Co., Lewis's Regt.; died at the home of Horace Benton, 30 June 1835, aged 45 years. He weighed 525 or 550 pounds. OR, 5 Aug. 1835.

PUCKETT, JOHN. Woodbury, Butler County. He served in 4th Virginia guarding Washington, D. C. He was 88 years of age in 1876. TK, 21 June 1876.

PUGH, JOSEPH. A soldier of 1812; died in the vicinity of Covington, 28 Mar. 1842. C, 5 Apr. 1842.

QUARLES, TUNSTALL. "He filled various public stations, and served his country in the capacity of captain in the war of 1812." Later he was elected to Congress. He died near Somerset, 7 Jan. 1855, aged about 75 years. C, 15 Jan. 1855. AG: Capt., 2nd Regt., KM.

QUISENBERRY, ROGER. Clark County. Born there 23 Sept. 1792; attended annual reunion, Kentucky veterans of the war of 1812, in 1870. TK, 22 June 1870.

RANDALLS, NATHANIEL. Fleming County. Died August, 1876, aged 86 years. TK, 30 Aug. 1876. AG: Pvt., Capt. Johnston Megowans's Co., U.S. Inf.

RAYBURN, HENRY. Harrison County. Attended 6th annual reunion, veterans of the war of 1812, 1871, aged 76 years. C, 7 July 1871. AG: Pvt., Simon Galaspie's (Gillespie's) Company, Francisco's Regt.

REAM, JOHN. Fleming County. A member of Capt. George Stockton's

company of 100 volunteer marines who served on Perry's ships on Lake Erie; WIA in battle there 10 Sept. 1813. He was Pvt., Capt. Joseph C. Belt's Co., 28th Regt., U.S. Inf. Fayette County Pension List.

REDMAN, JOSEPH. Mason County. Pvt., 1st U.S. Rifle Regt.; enlisted 25 May 1813; WIA in battle of Lake Erie, 10 Sept. 1813; served in Capt. H. R. Graham's Mason County company. Campbell County Pension List.

REES (REESE), JONATHAN. Mason County. 2nd Lieut., 19th U.S. Inf.; enlisted 15 May 1813 from Brown County, Ohio; living in Maysville, Kentucky, when he applied for pension 12 Jan. 1831. *Madison County Pension List*.

REEVES, JOSEPH. Owen County. Pvt., Capt. Joseph Funk's Co., 38th Regt., Jan. 1813-3 May 1813; injured 28 Apr. 1813 near Hackett's Tavern in Kentucky; living in Henry County when he enlisted. Shelby County Pension List.

REGAN, SAMUEL. Pvt., 24th Regt., U.S. Inf.; WIA at Mackinaw, Michigan; discharged 4 Aug. 1814. Floyd County Pension List.

RENICK, JAMES. Winchester, Kentucky. Attended 5th annual reunion, 1870, aged 76 years; attended reunions of 1871, 1873-76; voted in Clintonville precinct, Bourbon County, 1874, then 80 years of age. TK, 22 June 1870; C, 7 July 1871; WC, 24 June 1873; Yeoman, 27 June 1874, 26 June 1875, 24 June 1876, 8 Aug. 1874. AG: Pvt., Capt. Isaac Cunningham's Co., KMVM.

RENNICK, COL. A. H. Frankfort, Kentucky. Son of John and Mary (Huston) Rennick, of Pennsylvania; emigrated to Kentucky about 1790, settling near Lexington; Colonel Rennick was born 25 Aug. 1791; volunteered in Capt. Paschal

ROBINSON, MICHAEL (MITCHELL). Pvt., Capt. Patrick Gray's Co. who escaped the battles and massacre at River Raisin; was deputy clerk or clerk of several of the courts at Frankfort "for most of the time since 1807"; died 18 Dec. 1871. Biography in C, 26 May 1871, 22 Dec. 1871.

RHODES, SAMUEL. Harrison County. Attended 8th annual reunion, 1873, aged 80; died Fleming County, March, 1876. WC, 24 June 1873; TK, 21 June 1876. AG: Pvt., Capt. George Matthews's Co., KMVM.

RICHARDSON, DAVID. Mercer County. Entered the Revolutionary army from Baltimore, Md.; was with General Wayne against the Indians; "marched with Shelby to Canada." He was 77 years of age 2 Sept. 1833 when he made these statements. Mercer County Pension List.

RICHARDSON, JOHN. Franklin County. Born 9 June 1792; died 18 Dec. 1875. Served in Capt. Paschal Hickman's Co., 1st Rifle Regiment, and was one

of 13 of this company to escape the battles and massacre at River Raisin. N.S.D. 1812, Ky., No. 111.

RICHARDSON, JOHN. Estill County. A soldier of 1812; died Feb., 1876, aged 84. TK, 9 Feb, 21 June 1876.

RIDDLE, HENRY. Lexington, Kentucky. Died Jan., 1813, from wounds received at the battle of Mississinewa, 17 Dec. 1812. KG 26 Jan. 1813. AG: 2nd Cpl., Cpt., Capt. George Trotter's Co., Ky. Light Dragoons.

RITCHEY (RICHEY), ESAU. Nicholas County. Enlisted 29 Mar. 1812 as Pvt., Capt. Thomas Metcalfe's Co., Boswell's Regt., KDM; married in Bourbon County, Sept., 1805, "Nancey Webster, alias Combs or Coombs," daughter of Joseph Combs. Soldier died in Harrison County, 4 Dec. 1870. Nicholas County Pension List.

RITCHEY, JOHN. Harrison County. Pvt., Capt. John Duvall's Co.; pensioned 14 July 1830. Sen. Doc. 514.

ROBERTS, DR. JOSEPH G. Frankfort, Kentucky. Born 19 Feb. 1789; "during the War of 1812 he was assistant Surgeon on board the vessel commanded by Commodore Porter." Also served under Gen. Taylor in the Mexican War, and again in the Civil War as Surgeon of the 40th Ky. Mounted Inf., and as Brigade Surgeon, 1st Brigade, 5th Div., 23rd Corps. He died 3 July 1868, aged 79 years. *C*, July 10, 17, 1868; *Yeoman*, 4 July 1868.

ROBERTS, RICHARD. Simpson County. Attended 10th annual reunion, Kentucky veterans of the War of 1812, in 1875, aged 87 years. Yeoman, 26 June 1875.

ROBERTSON, THOMAS. Pvt., Capt. Hoskins's Co., 2nd U.S. Dragoons; WIA at the battle of Mississinewa, Dec., 1812. Henry County Pension List.

ROBINSON, MICHAEL (MITCHELL). Pvt., Capt. Patrick Gray's Co. Soldier was born 1796, died after 1850 in Cass County, Michigan. U.S.D. 1812, Michigan, No. 3589.

ROBSON, CAPTAIN JOHN SPRY. Franklin County. Born in Maryland, 27 Sept. 1789; resided in Franklin County, Kentucky, since 4 July 1814; "oldest Mason in the county, having been made a Mason in 1818"; served in war of 1812 in Capt. Meyer's Co., Maryland Militia, stationed at Fort McHenry; died in Franklin County, 27 June 1880. More in Yeoman, 3 Aug. 1880.

ROGERS, SAMUEL. Nicholas County. Attended 10th annual reunion, 1875 and 1876, aged 87 at last meeting. Yeoman, 26 June 1875; TK, 21 June 1876.

RONYAN, FRANCIS. Fayette County. Pvt., Capt. Thomas Lewis's Co.; POW at the Rapids, 1813. Argus, 12 Feb. 1814.

ROSSON, JOHN. Franklin County. "Served two campaigns in the War of

1812. He was a member of the Company of which Gen. Peter Dudley was then First Lieutenant, when he first volunteered [Capt. Paschal Hickman's Company]. In his second tour, Gen. Dudley was then his captain. Col. A. H. Rennick and Capt. John A. Holton were two of his mess-mates." He died at Madison, Indiana, 7 March 1868, aged 90 or 91 years. C, 27 Mar. 1868.

RUDD, JOHN H. Bracken County. Served in 28th Regt.; died in Yazoo County, Miss., 12 May 1835. C, 4 July 1835; OR 1 July 1835.

RUNYAN. See RONYAN.

RUSSELL, MAJOR HENRY. Nelson County. A soldier of the war of 1812; died at Warrensburg, Missouri, in Oct., 1876, aged about 88 years. TK, 21 June 1876.

RUSSELL, CAPTAIN JOHN W. Franklin County. Born 11 Oct. 1794 on the farm where he died; "in 1813 he joined Peter Dudley's company and bore part in the siege of Fort Meigs and other engagements on our northern frontier." He died 1 Aug. 1869. C, 6 Aug. 1869.

RUSSELL, COLONEL WILLIAM. Lexington, Kentucky. Colonel, 7th Regiment, war of 1812; died 3 July 1825, aged 66 years. R, July 4, 11, 1825.

RUTLEDGE, ISAAC. Grant County. Attended 6th annual reunion, 1871, aged 83 years. C, 7 July 1871.

SALISBURY, ANDREW. Enlisted 16 Nov. 1812, as Pvt., Capt. Samuel G. Hopkins's Co.; WIA 18 Dec. 1813; born Rowan County, N.C., removed to Ohio. Shelby County Pension List.

SANDERS, ISAAC D. Boone County. Entered service in 1813 as Sgt., Capt. Henry R. Graham's Co.; WIA in 1814 at Fort Erie. Boone County Pension List.

SCOBEE, ROBERT. Clark County. Served in Colonel Francisco's Regt., war of 1812; died 31 Oct. 1835. OR, 11 Nov. 1835.

SCONCE, ROBERT. Scott County. Lieut., Capt. Robert E. Yates's Co., war of 1812; died at the residence of his son, William Sconce, 26 Sept. 1875, aged 83 years. Taken to Bourbon County for burial. *Yeoman*, 2 Oct. 1875.

SCOTT, JOEL. Woodford County. Born 15 Nov. 1781 near Abingdon, Va.; came with father, John Scott, to Woodford County, 1785; member conventions to form the Constitution of Kentucky; represented Bourbon County many years in General Assembly; took charge of Kentucky Penitentiary, 1824-1834; was on the first Board of Trustees, Georgetown College; removed to Franklin County, 1834; died at his residence in Woodford County, 28 June 1860, in his 79th year. C, 2 July 1860. AG: One Joel Scott was Lieut., 12th Regt., war of 1812.

SCOTT, MATTHEW T. Lexington, Kentucky. A native of Pennsylvania; emigrated to Kentucky in 1810; died Aug., 1858, in his 74th year. He was Presi-

dent, Northern Bank of Kentucky. C, Aug. 25, 27, 1858. AG: One Matthew T. Scott listed in Capt. Thomas Lewis's Co., KM, commanded by Col. William Dudley "absent."

SCOTT, CAPTAIN WILLIAM. Paris, Kentucky. "A soldier in the late war." He died 13 Aug. 1847, aged 74 years. OR, 21 Aug. 1847.

SCOTT, WILLIAM. Bourbon County. Volunteered at Paris about 20 Aug. 1812, in Capt. William Garrard's Light Dragoons; discharged at Franklinton, Ohio, about 20 Aug. 1813; WIA 18 Dec. 1812 at Mississinewa. He removed to Illinois to live. Bourbon County Pension List.

SCRUGHAM, COLONEL JOSEPH. Lexington, Kentucky. Served in 8th Regt., war of 1812; died in Lexington 17 Jan. 1856, aged 76 years. C, 22 Jan. 1856.

SEWELL, JOSEPH. Henry County. Attended 10th annual reunion, 1875, aged 82 years. Yeoman, 26 June 1875. AG: Pvt., Capt. Archibald Morrison's Co., KDM.

SHACKELFORD. JAMES. Casey County. "This veteran of the War of 1812 died recently at his Casey county home, at the advanced age of 99 years. He was the maker of the celebrated Shackelford rifle, a rifle that for years has been the pride of this portion of the country. The last rifle that he made was when he was 96 years old, and it is said to be a marvel both of beauty and excellency." KG, 13 Dec. 1879. (Contributed by C. Frank Dunn.) SHANNON, JAMES. Franklin County. "He was a companion of John A. Holton and Peter Dudley in the war of 1812." He died 2 July 1869, aged 80. C, 9 July 1869. AG: Pvt., Capt. Peter Dudley's Co., 1812; Pvt., Capt. Peter Dudley's Co., KDM, 9 Mar.-9 Sept. 1813.

SHARON, SAMUEL. Fayette and Scott counties. Pvt., Capt. Lynn West's Co.; living in Scott County when his pension commenced in 1814; wounded in action. Scott County Pension List.

SHARP, JOHN. Fayette County. Served in the U.S. Inf.; was living in Fayette County in 1830, aged 55 years; died 28 Apr. 1839. Jessamine County Pension List.

SHAWHAN, JOSEPH. Harrison County. Attended 6th annual reunion, 1871, aged 90 years. C, 7 July 1871.

SHEPHERD, PRESLEY. Fayette County. Pvt., Capt. Butler's Co., 44th Regt., U.S. Inf.; enlisted 1814; WIA 23 Dec. 1814; discharged 1815. He moved from Tennessee to about 14 miles from Lexington, Kentucky. Clark County Pension List.

SHIVERY, G. W. Fayette County. Served in Capt. Stewart W. Megowan's Co., Lewis's Regt. (name spelled Shirevry); attended 1870, 1871 annual reunions; died 25 July 1875, aged 83 years. He had been married 50 years in Dec., 1870. TK, 22 June 1870, 21 June 1876; C, 7 July 1871.

SHOEMAKER, SPENCER. Pvt., Capt. William Ellis's (later Capt. Richard Matson's) Co.; WIA 18 Jan. 1813; placed on pension rolls 5 Jan. 1818; died 11 Nov. 1819. Harrison County Pension List; Sen. Doc. 514.

SIMRALL, JOSEPH. Shelbyville, Kentucky. Col., 1st Regt., Kentucky Light Dragoons, 22 Aug.-31 Oct. 1812; Lt. Col., Kentucky Volunteers, 25 Aug.-9 Nov. 1813; died 7 Sept. 1837. KG, 28 Sept. 1837.

SKINNER, PETER. Bourbon County. Attended 6th annual reunion, 1871, aged 73 years. C, 7 July 1871.

SMITH, BIRD. Woodford County. Born Prince Edward County, Va., 1787; enlisted at Lexington, Kentucky, at age of 21; Pvt., Capt. George Trotter's Co.; 2nd Sgt., Capt. Tunstall Quarles's Co.; married Elvira Price, 1 Feb. 1825; died in Woodford County, 9 Apr. 1860. C, 23 Apr. 1860; Woodford County Pension List.

SMITH, JOHN SPEED. Madison County. Born Jessamine County, 1 July 1792; studied law but gave up his practice to march with General Harrison's army on the Wabash; fought in battle of Tippecanoe; admitted to the bar in Kentucky in 1812; 1813 again fought against the British, this time as Brig.-Major. He authored the inscription on the marble block contributed by Kentucky to the Washington Monument. He died in Madison County, 6 June 1854, aged 62. S, June 6, 13, 20, 1854.

SMITH, JOSEPH. "He was a volunteer from Nelson County, Kentucky, and served a six month's campaign in 1812 under Bob Wilcox." He died at his residence (the Salt Lick Farm) in Ohio County, Ky., 11 Oct. 1853, aged 68 years, 6 months and 20 days. C, 8 Nov. 1853.

SMITH, THOMAS S. Jessamine County. Served in the 9th Regt., war of 1812; died 17 Sept. 1837, aged 58 years. KG, 21 Sept. 1837.

SMITH, WILLIAM. Rockcastle County. "Born Russell County, Va., 1773; after the close of the Revolution he served as an Indian spy on the Clinch and Kentucky waters; emigrated to Kentucky, 1795, settling in the present Rockcastle County; shortly after married the daughter of Col. Richard Singleton (a Major at King's Mountain) and had two children, Col. E. Smith and the wife of Col. James Terrill; his wife dying he subsequently married the daughter of Thomas Fish; in the war of 1812 he commanded a company; he served in the Legislature some twenty-odd years, in both branches." Yeoman, 1 Mar. 1849.

SOUTHERLAND, WILLIAM. Casey County. Born Scotland; emigrated to America at the age of 14, before the Declaration of Independence; entered

Revolutionary service very early in that struggle; served from Virginia on seven tours in succession; after the war he rejoined his family and moved to Kentucky; at the age of 55 he volunteered for service in the war of 1812 and was with Governor Shelby at the battle of the Thames; died 19 July 1843, in his 88th year. Kentucky Tribune (Danville) 8 Sept. 1843.

SPEGAL, ————. Born North Carolina, 1788; attended annual reunion, 1870. TK, 22 June 1870. AG: Martin Spiegle was Pvt., Capt. James Ellis's Co., KVM, 10 Sept.-9 Oct. 1814.

SPOON, HENRY. Scott County. Served in U.S. Inf., enlisting in July, 1812; living in Jefferson County 6 Oct. 1851, aged 63 years. Scott County Pension List.

SPROUL, ALEXANDER. Cumberland County. Served in Capt. William Wood's Company of volunteers from Cumberland; was thought to have served in the Revolution. He died in service in 1814. Clinton County Pension List.

SPURR, RICHARD, SR. "He was a soldier in the war of 1812 and was in action at the battle of the Thames." He died 21 April 1853, in his 76th year. C, 3 May 1853.

STANFORD, JOHN. Shelby County. Attended 10th annual reunion, 1875, aged 80 years. Yeoman, 26 June 1875.

STANFORD, LUCAS. Simpson County. A soldier of 1812; died 27 Jan. 1876, aged 81 years. TK, 9 Feb. 1876; 21 June 1876.

STAPLES, MRS. ELIZABETH. Montgomery County. "The widow of a soldier in the war of 1812, she prepared papers for pension in April, 1878, at the age of 83. Mrs. Staples can walk one half mile without resting, milks two cows night and morning, can churn, knit, sew, in fact is never idle. During the war she made clothing for the soldiers preparing to leave for the service." Yeoman, 25 Apr. 1878. Only one of this name, Joshua Staples, listed in AG roster of Kentucky volunteers. He was Pvt., Capt. John V. Bush's Co., Lt. Col. John Francisco's Regt.

STEPHENSON, THOMAS. Mercer County. Attended 8th annual reunion, 1873, aged 79 years. WC, 24 June 1873. AG: Pvt., Capt. Armstrong Kerr's Co.

STEVENS, THOMAS. Campbell County. Served in KM in Col. William E. Boswell's Regt.; WIA 5 May 1813; honorably discharged in Sept., 1813; also served in the Revolution. Campbell County Pension List.

STEWART, JAMES. Served in Capt. Joyce's Co., KM; WIA at New Orleans; married 3 Mar. 1816, Polly Phillips. He died 22 Sept. 1842 at Cincinnati, Ohio. Jefferson County Pension List.

STEWART, JAMES. Clark County. "Attended 6th annual reunion, 1871, aged 80 years. C, 7 July 1871. He died in Feb., 1876, aged 84 years." TK, 21 June 1876.

STEWART, ROBERT. Born Nicholas County, 1792; attended annual reunions of 1870-71. TK, 22 June 1870; C, 7 July 1871.

STIVERS, EDWARD. Montgomery County. Musician, 3rd U.S. Inf.; born in present Montgomery County, 1770; enlisted 15 June 1814. Children: Eleanor Stivers Harrington, aged 40 years in 1833; Catherine Stivers Brown, 38; William Stivers, 37; Susan Stivers Ogden, 27; Martin Stivers, 25. Montgomery County Pension List.

STOCKTON, GEORGE. Fleming County. Commanded a company of Marines who went on board Perry's ship on Lake Erie; had 100 men who volunteered for this duty. He returned to Fort Seneca for clothes for his men and did not return to the ship until the action was over. Fayette County Pension List.

STONE, JOSEPH. Berry's Station, Harrison County. Attended annual reunions of 1874-1876, aged 85 at the last meeting. Yeoman, 27 June 1874, 26 June 1875; TK, 21 June 1876.

STREET, JOHN PARKE. Newport, Kentucky. Attended 9th annual reunion, 1874, aged 79 years. Yeoman, 27 June 1874.

STUCKER, JACOB. Scott County. "One of the most celebrated Indian fighters who protected Kentucky through her infancy. He was also a captain in Johnson's mounted regiment and fought on the Thames in the late war." He died in Scott County "lately." Argus, 29 June 1820.

STURGEON, ELISHA (ELIJAH). Grant County. Attended annual reunions of 1870-1871, aged 84 at the last meeting. "He was in Crittenden 1 Mar. 1876, pension day, with several other old veterans of 1812. He was then 97 years old." TK, 22 June 1870, 15 Mar. 1876; C, 7 July 1871.

SUBLETT, JOHN S. Green County. Served in Capt. Armstrong Kerr's Co. from March, 1813; fought at Meigs, was wounded and captured. *Green County Pension List*.

SUDDUTH, COLONEL WILLIAM. Owingsville, Kentucky. One William M. Sudduth served in 65th Regt. (Bath County) in the war of 1812. Col. Sudduth died 28 Aug. 1845, aged 80 years. OR 3 Sept. 1845.

SUMMERFIELD, EPHRAIM. Cpl., 17th Regt., U.S. Inf. under Captains Holder and Whistler; born 1795; died about 1876 in Michigan. U.S.D. 1812, Michigan, No. 9929.

SUTHERLAND, FRED. Clark County. His death, on 18 Nov. 1874, at the age of 85, was announced at the annual reunion of veterans, June, 1875. Yeoman, 26 June 1875.

SUTHERLAND, WILLIAM. Enlisted in Capt. James Hunter's Co., 17th U.S. Inf.; disabled and discharged 19 Nov. 1814. Wayne County Pension List.

SWEARINGEN, HENRY THOMAS. Shepherdstown, Va. "A Captain in the line and fought in several battles on the St. Lawrence; WIA and captured; after the war he was sent as Colonel of the line to effect exchange of prisoners of war for the U.S.; died at Glasgow, Kentucky, 18 Jan. 1820. He had come here to attend to a valuable estate inherited from his father. He was married not long before his death. A young man." Argus, 26 Jan. 1820.

SYLVA, SAMUEL. Anderson County. Pvt., Capt. Robert B. McAfee's Co., KMI; placed on pension roll 14 Jan. 1832. Sen. Doc. 514.

TALLIAFERRO, DR. WILLIAM T. Born 1795; practiced medicine in Mason County, later lived in Cincinnati; volunteered in Bracken County and was one of the volunteers who served on Perry's ships on Lake Erie; attended annual reunion of veterans, 1870; died between June, 1870, and June, 1871, reunions. TK, 22 June 1870; C, 7 July 1871; Yeoman, 11 Jan. 1879.

TANDY, WILLIS. Fayette County. Pvt., Capt. John Hamilton's Co.; received a bomb fragment in his left eye during the action at Frenchtown, Jan. 22, 1813; captured and paroled 26 Feb. 1813 at Newark, Upper Canada; married, 31 Oct. 1823, Martha Reed (his first wife was Mary or Polly Cloud who died in Fayette County); he died in Morgan County, Illinois, 5 Sept. 1849, aged 60 years, 9 months and 17 days; buried East Cemetery, Jacksonville, Ill. Fayette County Pension List; Honor Roll . . . Soldiers of 1812 Buried in Illinois, v. 1 (MS); Sen. Doc. 514.

TAPP, NELSON. Born in Virginia, 1790; removed to Kentucky, 1794; attended annual reunions of 1870-71, 1873; died 19 July 1874, aged 84 years. TK, 22 June 1870; C, 7 July 1871; WC, 24 June 1873; Yeoman, 26 June 1875.

TATE, THOMAS L. Franklin County. "Was distinguished as a participant in the war of 1812 and for many years a citizen of Franklin County; married the oldest daughter of Rev. John Taylor." Thomas L. Tate, according to his tombstone record, was born 14 Aug. 1787 and died 7 Nov. 1852. He was buried in the Taylor burying ground on the Macklin farm at Forks of Elkhorn. (One Thomas L. Tate married in Franklin County, 15 June 1829, Mrs. Nancy T. Gray.) Thomas Tate's name is on the original roster of Capt. Paschal Hickman's Co. He was one of twelve or thirteen of this unit to escape the battles and massacre at Frenchtown, Jan., 1813. Yeoman, 15 July 1873.

TAYLOR, COLBY H., Colbyville, Clark County. Served in 36th Regt., War of 1812; died 10 Sept. 1853, aged 73 years. S, 1 Oct. 1853.

TAYLOR, CAPTAIN HUBBARD. Clark County. "Served in the war of 1812 under Dick Johnson (Pvt., Capt. James Johnson's Co., 3rd Regt.) and also under Gen. James Taylor; he was educated for a lawyer and followed this profession for about 20 years; was twice sent to the Legislature of Kentucky, once

from Clark and once from Bourbon County; at the time of his marriage, in 1814, at the age of 26, he had a law office in Winchester; he moved to Paris in 1823, living there until 1832 when he moved back to Clark and became a farmer; he married 13 Oct. 1814, Mary, daughter of Thomas Arnold, for many years Clerk of the Bourbon Circuit Court; (her father, Thomas Arnold, was an apprentice for five years in the office of Levi Todd, Circuit Court Clerk of Fayette and grandfather of Mrs. Abraham Lincoln); on 14 Oct. 1874 Capt. Taylor and his wife celebrated their 60th wedding anniversary; she was then 76 years of age and he was 86." Captain Hubbard Taylor died 9 June 1876, aged 88. He had been a member of the Masonic fraternity for 61 years and was buried by them. Yeoman, 24 Oct. 1874; TK, 21 June 1876.

TAYLOR, ISAAC. Campbell County. Pvt., Capt. William Sebree's Co.; POW at the Rapids, 1813. Argus, 12 Feb. 1814.

TEVIS, SAMUEL. Shelby County. "During the last war he served two campaigns, one as First Lieut. of a company and the other as Adjutant of a Regiment." He died 7 Apr. 1841 near Shelbyville, aged 53 years. C, 27 Apr. 1841.

THEOBALD, THOMAS S. Frankfort, Kentucky. Born Bourbon County, 1791; came to Frankfort in 1806, at the age of 15; at the outbreak of the war he assisted in raising a company of which he was elected lieutenant (1st Lieut., Morrill's Co., Kentucky Mounted Rifles); at the conclusion of this tour his company had assembled at Vincennes for mustering out when it was found there was no money to pay the men—the nearest source being Louisville. Rather than allow his men to disperse without pay, he led a squad to Louisville and back without losing a dollar of the pay roll. After the war he held many public offices including that of Keeper of the Penitentiary, 1834-44. He married 22 July 1813 Sarah Watkins Keene, born Scott County 3 May 1793, died in Frankfort 10 Jan. 1876. Thomas S. Theobald died there 30 Dec. 1873. Five years before, on 21 June 1871, he had received the first pension certificate as a veteran of the war of 1812 issued to a Kentuckian. It entitled him to eight dollars per month. Collins, v. 1, p. 215; Yeoman, 3 Jan. 1874, 11 Jan. 1876; C, 15 Mar. 1872.

THOMAS, ISAAC. Mason County. "Born Mefford's Station, 8 Nov. 1789 or 1788 and was consequently in his 86th year when he died in July, 1875. He was a noncommissioned officer in the war of 1812 and served with distinction at the battle of the Thames." Yeoman, 29 July 1875.

THOMASSON, RICHARD. Scott County. Served in 12th Regt.; died 10 Mar. 1855, one of the oldest citizens of the county. C, 26 Mar. 1855. AG: One of this name was Pvt., Capt. Jacob Stucker's Co., KMI.

THORNTON, GENERAL W. F. A former citizen of Bourbon County, Kentucky, and resident of Shelbyville, Illinois. "He was a native of Virginia, where he figured as editor of the *Alexandria Gazette* and General in the War of

1812. His wife, Miss McClannahan, was an aunt of Mrs. Brutus J. Clay. He was a cousin of ex-State Senator John Roots Thornton, Paris, Ky. He died 21 Oct. 1873, aged 84 years." Yeoman, 1 Nov. 1873.

TILFORD, ALEXANDER. Scott County. Pvt., Capt. Lynn West's Co.; died Sept., 1831, aged about 50 years. C, 27 Sept. 1831.

TILFORD, ROBERT. Boyle County. Attended 6th annual reunion, 1871, aged 83 years. C, 7 July 1871. AG: 5th Cpl., Capt. Archibald Bilbo's Co.

TODD, SAMUEL B. Fayette County. Enlisted in Fayette Co., 14 Aug. 1812, in Capt. Nathaniel G.S. Hart's Co.; married 27 Nov. 1827 Caroline Barr; applied for pension while living in Boone Co., Mo., 6 June 1871, aged 78 years; was living in Howard County, Mo., in Nov., 1850. Jessamine County Pension List.

TONGATE [TUNGATE], MEREDITH. Garrard County. Pvt., Capt. Whistler's Co., 3rd U.S. Inf. He was born in Amherst Co., Va.; married in May, 1824, Elizabeth Baker, in Garrard Co., Ky. He died in Orange Co., Ind., 7 Aug. 1842. Garrard County Pension List.

TOWLES, HENRY. Bourbon County. Pvt., Capt. William Garrard's Troop of Light Dragoons; WIA at siege of Fort Meigs, May, 1813; discharged at Franklinton, Ohio, 13 Aug. 1813. Bourbon County Pension List.

TRIMBLE, DAVID. Greenup County. Born Frederick Co., Va., June, 1792; served as brigade quarter master, First Brigade, KMM, later as Pvt., Major Peter Dudley's Bn., KMVI; elected to Fifteenth and four succeeding Congresses, 1817-1827; died at Trimble's Furnace, Greenup County, 20 Oct. 1842. C, 25 Oct. 1842; Biographical Directory of the American Congress, 1774-1927.

TRIMBLE, JAMES. Fayette County. Attended 5th annual reunion, 1870, aged 74 years, and the meeting of 1871. TK, 22 June 1870; C, 7 July 1871. AG: Pvt., Capt. James Coleman's Co., KMI.

TUCKER, JOHN. One of the Kentucky volunteers with Perry on Lake Erie. Yeoman. 11 Jan. 1879.

TURNER, EDWARD. Mason County. Pensioned 18 Mar. 1813. This name listed in AG as Pvt., Capt. Joseph C. Belt's Co., Pvt., Capt. William R. Payne's Co., and Pvt., Capt. Zechonias Singleton's Co. Sen. Doc. 514.

TURNER, JOHN. Madison County. Served in Capt. Christopher Irvine's Co.; POW at the Rapids, 1813. Argus, 12 Feb. 1814.

TURNER, JULIUS. Pvt., Capt. Joseph Redding's Co.; in action at River Raisin Jan. 22, 1813. Fayette County Pension List.

UNDERWOOD, JOSEPH R. Warren County. Born Goochland Co., Va., 24 Oct. 1791; removed to Kentucky at the age of 12 and was adopted by a maternal uncle; graduated from Kentucky University, 1811, after which he read

law with Robert Wickliffe; in 1812 he served as Lieut., Capt. John C. Morrison's Co., Dudley's Regt., and was wounded and captured at Dudley's Defeat; after the war he practiced law, held many public offices in Kentucky, including that of Judge of the Court of Appeals, 1828-35, and was elected to the Twenty-fourth and three succeeding Congresses, 1835-43; elected to U.S. Senate and served 1847-53. He died near Bowling Green, Kentucky, 23 Aug. 1876. Yeoman, 26 Aug. 1876; Biographical Directory of the American Congress, 1774-1927. His son, John Cox Underwood (Sept. 12, 1840-Oct. 26, 1913) was Lieutenant-Governor of Kentucky, 1875-79.

VAN PELT, WILLIAM, SR. Fayette County. Born 18 Oct. 1784, died 5 Oct. 1872. "From the time of his eligibility he never lost a presidential vote from James Madison in 1808 to Gen. Grant in 1868." He served with the 42nd Regt. in the war of 1812. Yeoman, 21 Dec. 1872.

VOORHIES, MAJOR PETER GORDON. A soldier of the war of 1812. He was born in Trenton, N.J., and in 1790 emigrated to Frankfort, Ky.; he moved to Red River where he died in July or August, 1851, aged 79 years. S, 8 Aug. 1851. AG: Ensign, Capt. Paschal Hickman's Co.

WALKER, COLEMAN. Madison County. Pvt., Christopher Irvine's (James Dyametto's) Co.; POW 5 May 1813 at the Rapids. Argus, 12 Feb. 1814.

WALKER, WILLIAM. Franklin County. Attended 8th annual reunion, 1873, aged 85 years. WC, 24 June 1873. AG: twelve listings this name.

WALL, LEWIS H. Carlisle, Kentuckv. Attended 9th annual reunion, 1874, aged 80 years. Yeoman, 27 June 1874.

WALLACE, JOSEPH (or JOHN). Bourbon County. Attended 6th annual reunion, 1871, aged 78 years; 1873 reunion. C, 7 July 1871; WC, 24 June 1873.

WARD, ANDREW. Harrison County. Enlisted 20 May 1812 as Pvt., Capt. Bradford's Co., 17th U.S. Inf.; also served in Capt. Larrabee's Co., 3rd U.S. Inf.; WIA at Fort Meigs, 5 May 1813. Harrison County Pension List.

WARD, JOHN. Garrard County. Pvt., Capt. John Yantis's Co.; captured 5 May 1813 at the Rapids. Argus, 12 Feb. 1814.

WARD, THOMAS. Pvt., Capt. Redding's Co.; placed on pension rolls 2 Dec. 1814. Sen. Doc. 514.

WARD, COLONEL WILLIAM. Served with the 12th Regt., war of 1812; lived in Scott County, Ky.; died in Mississippi, 15 July 1836. KG, 4 Aug. 1836.

WARDEN, WILLIAM B. Served in Capt. Alexander Kerr's Co., Mar. 26-Sept. 28, 1813; Capt. Armstrong's Co., 10 Nov. 1814-10 May 1815; WIA at Dudley's Defeat; married Catherine Jordan. He died 5 Apr. 1865. He was also in the Battle of New Orleans. His first wife was Elizabeth Meirlin. Hickman County Pension List.

WARE, COLONEL THOMPSON. Bourbon County. Served with 71st Regt.; died 9 Sept. 1852, in his 84th year. C, 21 Sept. 1852.

WARFIELD, BENJAMIN. Fayette County. Lieut., Capt. Samuel L. Williams's Co.; Captain of his own company, Col. Richard M. Johnson's Regt.; died at his home in Fayette 20 Oct. 1856, in his 67th year. He was twice married, his second wife surviving him. He left a family of three sons and one daughter, children of his first wife. He was educated at the University of Kentucky and trained for the bar. C, 19 Nov. 1856.

WARREN, CHARLES. Attended annual reunion, 1876, aged 83 years, coming from Kearney, Mo., for the meeting. TK, 21 June 1876. AG: Cpl., Capt. William Davis's Co., KM.

WARRING, EDWARD. Scott County. Attended 6th annual reunion, 1871, aged 77 years. C, 7 July 1871.

WATSON, AARON. Mason County. "A soldier of 1812 [in Capt. Moses Demmitt's Co.]; married 10 Aug. 1794, in Mason, Leah Furr [the marriage record lists him as Moses Watson]." Mason County Genealogical Notes, Kentucky Historical Society.

WEBB, JAMES G. Winchester, Kentucky. Born 3 Feb. 1792; captured during action on River Raisin, Jan., 1813; died 12 Mar. 1844, Loami Township, Sangamon Co., Ill. Honor Roll Soldiers of 1812 buried in Illinois, v. 1. (MS).

WEBB, JOHN. Madison County. Attended annual reunions of 1873, 1876, aged 84 years at last meeting. WC, 24 June 1873; Yeoman, 24 June 1876.

WEBB, COLONEL JOHN V. Scott County. Served in 77th Regt.; died 7 May 1839. C, 18 June 1839.

WEBB, JOSHUA. Madison and Fayette counties. Attended annual reunions of 1873, 1876, 1881, aged 89 years at last meeting. WC, 24 June 1873; TK, 21 June 1876; Yeoman, 20 June 1881.

WEBSTER, LARKIN. Grant County. Attended annual reunions of 1870-71, 1873, 1875, aged 83 years at the last meeting. TK, 22 June 1870; C, 7 July 1871; WC, 24 June 1873; Yeoman, 26 June 1875. He appeared in Crittenden, Grant County, 1 Mar. 1876, with several old veterans of 1812 to get his pension check. He was then 84. TK, 15 Mar. 1876.

WELLS, LEVI. Ensign, 7th Inf., U.S., 13 Nov. 1812. He was killed Jan. 22, 1813, during the action at River Raisin—on detached service with the 17th U.S. Inf., commanded by his father, Col. Samuel Wells. *Heitman*, v. 1.

WELSH, DAVID. Pvt., 1st U.S. Inf., Capt. Packland's Co., 20 June 1814-29 Feb. 1816; wounded in action 23 Dec. 1814 during fighting below New Orleans. (Mississippi pension). Henry County Pension List.

WEST, BENJAMIN (or BENONI). Boyle County. Attended annual reunions of 1871 and 1875, aged 86 at the last meeting. C, 7 July 1871; Yeoman, 26 June 1875. AG: Cpl., Capt. James Anderson's Co.

WHITE, COLONEL ANDREW S. Shelby County. Member Constitutional Convention of 1849-50; senior partner of A. S. White & Co., pork packers, Louisville; died 12 June 1855. C, 18 June 1855. AG: One of this name was Pvt., Capt. John Hall's Co., KMVM.

WHITE, COLONEL PHILIP. Franklin County. One of this name was Major in Col. John Calloway's Regt., KV; died 22 Aug. 1822, aged 58 years. R, 26 Aug. 1822.

WHITE, SAMUEL W. Shelby County. Pvt., Capt. Frederick Geiger's Co., 23 Oct.-18 Nov. 1811; WIA at battle of Tippecanoe; pensioned; died in Shelby County, 17 Nov. 1862, lacking four days of 86 years. Shelby County Pension List, C, 21 Nov. 1862; Sen. Doc. 514.

WHITE, THOMAS. Bourbon County. Attended 10th annual reunion, 1875, aged 81 years. Yeoman, 26 June 1875.

WHITEHEAD, ARMISTEAD. Served as 3rd Lieut., 5th U.S. Inf.; WIA at Lyon's Creek, Upper Canada. Harrison County Pension List.

WILKS, MILLS. Boone County. Enlisted 15 Aug. 1812, for six months, in Capt. Uriel Sebree's Co.; WIA 18 Jan. 1813 at Frenchtown; POW 22 Jan. 1813; received his discharge from Major Richard Gano, acting colonel of the Regt., 4 Mar. 1813; placed on pension rolls 21 Feb. 1834. He was Cpl., Capt. Sebree's Co. Boone County Pension List; Sen. Doc. 514.

WILLIAMS, ELISHA. Mercer County. Attended 8th annual reunion, 1873, aged 87. WC, 24 June 1873. AG: Cpl., Capt. James C. Price's Co., Lewis's Regt.

WILLIAMS, GEORGE. Lincoln County. A veteran of the war of 1812, receiving a pension in 1878. Yeoman, 21 May 1878.

WILLIAMS, JAMES. Cumberland County. Born Sullivan Co., Va., 1763; enlisted for Revolutionary service from Sullivan in 1778; removed to Cumberland Co., Ky., about 1802; enlisted for 1812 service in Capt. William Wood's company of Cumberland volunteers; 8 Aug. 1838, had his pension transferred to Hempstead Co., Arkansas. Clinton County Pension List.

WILLIAMS, MAJOR JOHN. Simpson County. Enlisted in Revolutionary service at the age of 16 and was in the battles of Brandywine, Germantown, Monmouth and other battles and skirmishes. "He was one of the earliest settlers of the west and an Indian fighter in the neighborhoods of Nashville and Gallatin. When the fort at Greenville was attacked by 300 Indians, there being only a few men, women and children in the fort, he was one of a little band that went to the

rescue. In the war of 1812 he again volunteered his services and was chosen to command a company of horse under General Hopkins. He was ten years in the Senate of Kentucky, from Warren County. He died in September (?), 1833, in his 74th year. C, 24 Sept. 1833.

WILLIAMS, COLONEL WILLIAM. Madison County. Commanded a Regt., mustered 31 Aug. 1812; died in Aug., 1824, aged 45 years. R, 23 Aug. 1824.

WILLIAMS, ZEPHENIAH. Fayette and Franklin counties. Pvt., Capt. N.G.S. Hart's Co.; POW at Frenchtown, 22 Jan. 1813. For many years he was a Ruling Elder of the McChord church, Lexington, and on his removal to Frankfort, an Elder in the Presbyterian church there. About 1857 he removed to Dubuque, Iowa, where he died 21 July 1858. C, 9 Aug. 1858.

WILLSON, PETER G. Boyle County. Attended 10th annual reunion, 1875, aged 82 years. Yeoman, 26 June 1875.

WILSON, HAMILTON. Bourbon County. Attended 11th annual reunion, 1876, aged 84 years. TK, 21 June 1876; Yeoman, 24 June 1876.

WILSON, JAMES L. Fleming County. Attended 8th annual reunion, 1873, aged 78. WC, 24 June 1873. A Colonel J. Wilson, Oldham County, died 10 Jan. 1875, aged 79 years. The same? Yeoman, 26 June 1875.

WILSON, WILLIAM. Fayette County. Pvt., Capt. William Sebree's Co., KM; WIA at Fort Meigs, 5 May 1813. Fayette County Pension List; Argus, 12 Feb. 1814.

WILSON, WILLIAM. Scott County. Pvt., Lewis's Co.; captured at the Rapids, 1813. Argus, 12 Feb. 1814. Same as above?

WINLOCK, FIELDING. Born Jefferson County, 4 May 1789; served in Simrall's Regt.; died in Shelbyville, 24 Feb. 1874. He was a son of Gen. Winlock, of Shelby. Yeoman, 28 Feb. 1874.

WINLOCK, GENERAL JOSEPH. Shelby County. Officer, 1st Regt., KMM; died March, 1831, aged 73 years. R, 6 Apr. 1831.

WINLOCK, DR. JOSEPH. Shelby County. One of this name was Surgeon's Mate, 1 Sept. 1812-25 Dec. 1813; died 11 Feb. 1814, aged 22 years. He was a son of Gen. Winlock, of Shelby. Argus, 5 Mar. 1814.

WITHINGTON, THOMAS. Fayette County. Pvt., Capt. Archibald Morrison's Co.; POW at the Rapids, 1813. Argus, 12 Feb. 1814.

WITT, ELISHA. Estill County. A soldier of 1812; died 2 Sept. 1858, in his 65th year. C, 13 Sept. 1858.

WOLF, JESSE. Enlisted in Scott County, in Capt. Jacob Stucker's Co.; married in Scott County, Mary Polk; applied for pension from Union County, Ind., 30 Oct. 1873 when he was 78. Harrison County Pension List; Sen. Doc. 514.

WOOD, BENJAMIN. Harrison County. Attended 6th annual reunion,

1871, aged 77 years. C, 7 July 1871. AG: Pvt., Capt. John W. Redding's Co., KMI.

WOOD, JOHN. Enlisted at Lexington, Kentucky; WIA Jan. 18 or 22, 1813, during action on River Raisin (sworn to by George Morris and James Munday who knew him there). He married Rebecca Ballard, in Charleston, Indiana, 21 Oct. 1821. Children: Sidney S., aged 39 in 1879 and Frances Crawley, aged 56 in 1879. Madison County Pension List.

WOOD, THOMAS. Pvt., Capt. Wiley R. Brasfield's Co.; mustered in at Georgetown, 15 Aug. 1812; in 1855 he was living in Fayette County; on 6 Jan. 1872, when he applied for pension, he was living in Owen County. He was then 84. Owen County Pension List.

WOOD, WILLIAM. Cumberland County. Raised a company of volunteers there in the spring of 1813. Clinton County Pension List.

WORNALL, THOMAS. Clark County. One of this name captain of a company, KMVM, commanded by Samuel South. Thomas Wornall died in Nov., 1838, at an advanced age. OR 17 Nov. 1838.

WRIGHT, COLONEL WILLIAM. Paris, Kentucky. Attended annual reunions of 1871, 1873-76, 1878, aged 94 years at the last meeting. *C*, 7 July 1871; *WC*, 24 June 1873; *Yeoman*, 27 June 1874, 26 June 1875, 29 June 1878; *TK*, 21 June 1876.

YOUNGLOVE, EZRA. Christian County. One of the 150 picked volunteers who fought on Lake Erie with Perry; assigned to the *Niagara*; listed as Pvt., Capt. Thomas L. Butler's Co., 28th U.S. Inf.; living in 1859. *Quisenberry*, p. 78.

ZINN, JOSEPH. Grant County. Attended annual reunion, veterans of the war of 1812, in 1871, 1873 and died between the meeting of June, 1874, and that of June, 1875. He was 78 at the time of his death. C, 7 July 1871; WC, 24 June 1873; Yeoman, 26 June 1875. AG: Pvt., Capt. James Ellis's Co., Ky. Vol. Militia.

ARTHUR, CAPTAIN AMBROSE. Knox County. Born Bedford Co., Va., 5 June 1776; raised a company in Knox and led it at the battle at Fort Meigs; married 22 Jan. 1811, in the same county, Jane Gilbert Fletcher (5 Oct. 1787-4 Dec. 1880). Captain Arthur died 20 July 1859. Contributed by Mrs. George C. Lewis, Bryn Mawr, Pa.

BOND, WILLIAM. Franklin County. Pvt., Capt. Peter Dudley's Co., raised to avenge the loss of Capt. Paschal Hickman and most of his company at River Raisin, Jan., 1813. There are three other listings of this name in the AG. William Bond later lived in Anderson County. He married, 5 Nov. 1813, Mrs. Rebecca Johnson Marshall. Contributed by Mrs. George C. Lewis, Bryn Mawr, Pa.

BRANDENBURGH, ABSALOM. Settled in Virginia on coming to America; later removed to Paducah, Kentucky, where he was a plantation inspector and meat inspector; founded and lived in Brandenburgh, Ky.; served in 1812 with the 3rd Regt., KDM, and fought at New Orleans; removed to Mauchport, Ind., where he engaged in making brandy and distillery products and where he died and was buried. He was married four times. Wayne Guthrie in *Indianapolis* (Ind.) News, 7 Oct. 1952. Contributed by Miss Thelma Murphy, Indianapolis, Ind.

BUTLER, MAJOR THOMAS L. Louisville, Kentucky. "The oldest member of the Butler family in Kentucky. He served as an army officer for a number of years and was aid to General Jackson at New Orleans; filled various offices under several administrations, and was member of the Kentucky Legislature for many terms. He was a brother of Gen. William O. Butler. He died at the Louisville home of his son-in-law, P. O. Turpin, 'last week,' aged 99 years." Clark County (Ky.) Democrat, 10 Nov. 1880.

CAYSE, THOMAS. Garrard County. Served in the 17th U.S. Inf., under Philip King. He died in Jan., 1813. Forrest Calico, "Veterans of the War of 1812 from Garrard County," *Register*, v. 48 (1950).

EDWARDS, JAMES H. Born Moutgomery County, Va., and reared in Jefferson County, Ky.; Pvt., Capt. Peter Funk's Co.; WIA at battle of Tippecanoe, 7 Nov. 1811. Moved to Denton County, Texas, 1858. Henderson County Pension List.

FERIS, DR. M. A. Georgetown, Kentucky. Surgeon, 17th U.S. Inf., under Col. Samuel Wells was living in 1830. Bracken County Pension List.

FISHER, JOHN BÖLEYN. Born Pennsylvania, 1 Mar. 1768; moved to Virginia and served as Indian fighter, 1791-94 from Boutetourt County; served later under General Anthony Wayne and was wounded and tomahawked; married in Virginia, 14 Oct. 1801, Mary L. Brown; removed to Kentucky between 1801-05, settling in Mt. Sterling where he lived until 1843; enlisted in the war of 1812, in Capt. Warner Elmore's Co., KMM; later was Cpl., Capt. Simon Gillespie's Co., Francisco's Regt.; removed to Hodgenville, Larue County, where he died 27 Aug. 1870, aged 102. Contributed by Mrs. Leonard T. Harris, Chicago, Ill.

MERCER, DAVID. Born Greene County, N.C., Dec., 1791; enlisted a Pvt., Capt. Silvanus Massie's Co., KM., 1 Sept. 1812; died Marion Co., Ill., 14 June 1834. He married 21 Dec. 1814, Elizabeth Searcy (1797-17 Oct. 1843). Soldier listed incorrectly in AG as David Messer. Contributed by Kenneth Mercer, Webster Groves, Mo.

MORGAN, JOHN. Born Shelby County, 1790, son of William and Rachel (Pheamister) Morgan; enlisted in 1812 struggle on 31 Aug. 1813, from Franklin County, serving under Matthew Flournoy; removed, 1840, from Fayette County

to Hannibal, Marion County, Mo., where he died 6 Aug. 1872. He was married three times: 26 Oct. 1813, to Mary Orr; 14 May 1822, to Jane Wason (d. 1825) and 13 Feb. 1827, to Rebecca Orr. John Morgan Government Registry No. WO 44 494, Kentucky Historical Society.
